TECHNICAL SPECIFICATION – REMOTE DATA LOGGER

INTELLIGENT GSM TELEMETRY DATA LOGGER SYSTEM

1. Overview

As part of Johannesburg Water's (JW) strategic initiative to implement advanced digital infrastructure within a broader Smart City programme, JW requires the supply, configuration, installation, and commissioning of intelligent, battery-operated remote data loggers.

These devices shall interface with existing field instrumentation using Modbus RTU communication protocols and transmit operational data via GSM / 4G telemetry to JW's central monitoring systems. The raw data from the field must be hosted directly on JW's servers to ensure that upon termination of the contract for any reason, full access to and ownership of the data remains solely with the client, namely Johannesburg Water.

The solution must integrate seamlessly with JW's existing SCADA platform, which is currently Adroit version 10, and support reliable, secure and continuous data acquisition from geographically distributed sites.

2. Application Environment

The proposed data loggers will be deployed across a range of water infrastructure assets, including but not limited to

- 2.1 Pressure Reducing Valve (PRV) stations
- 2.2 Reservoir facilities
- 2.3 Bulk and zone flow metering installations
- 2.4 Pressure monitoring points within the distribution network
- 2.5 Other remote or unmanned water infrastructure sites as required

Installations may be located in harsh outdoor environments, including underground chambers, in reservoirs, roadside kiosks and exposed utility enclosures.

3 Technical Specification of the Logger

The logger units will be used in different applications. This requires the units to be intelligent and to be configured and programmable for the different application requirements. The Data Logger must comply with at least the following specifications:

3.1 Environmental

The logger must be designed for extreme and harsh outdoor environments; on a lamp pole, on a wall, inside a reservoir, or attached to a vehicle.

- a. The unit must comply with at least IP-67.
- b. Ambient Temperature Range: -20 to +80°C

3.2 External IO Requirements

Five (5) configurable multi-purpose inputs/outputs are required.
The IOs will be individually programmable to the following IO Types:

- a. Analog Inputs
- b. Digital Inputs
- c. Counter Inputs
- d. 4-20 mA sink or source
- e. Switch to ground 250 mA
- f. Boost output configurable 5-25 V, 100 mA.

3.3 Internal Sensors

The unit must be equipped with at least the following Internal Sensors:

- a. GPS with accuracy within 5 meters
- b. Accelerometer: 3-Axis. Alarm enabled when unit is moved around.
- c. Tamper detection.

3.4 Modbus Interfacing

The unit must be equipped with a Modbus-RTU Master port operating through RS-485. The Modbus-RTU must be able to read multiple Modbus registers from multiple Modbus slave devices. A unit capable of interfacing with only one Modbus slave device shall not be acceptable.

3.5 Wireless Out Bound Communication

The unit must be equipped with the following minimum wireless communication ports:

- a. Wi-Fi is to be used for local programming and configuration.
- b. GSM-4G-LTE for backhaul communication to the SCADA System.

3.6 On-Board WEB Server for unit configuration

The logger unit must be equipped with an on-board Web Server. The user must be able to log on to the unit web server through Wi-Fi connection and complete configuration and programming of the unit. The user must be able to configuration using a Smart Phone, Tablet or Laptop Web Browser.

3.7 Remote Programming

The user must be able to remotely (off-site) to do the following tasks:

- a. Change the logger configuration.
- b. Download and update Firmware.

3.8 Edge Processing

JW requires the data logger to support embedded application functionality for on-device data processing and control. The unit shall enable the development and deployment of custom scripts, using a native supported scripting language, to manipulate incoming data, generate combinational alarms, execute local control actions and construct customized data payloads for transmission to JW servers. This capability should operate autonomously and support remote updating where possible.

3.9 Battery Life

The data logger unit shall operate exclusively on battery power. The logging interval shall be configurable from 1 second up to 60 minutes. Data transmission to the server shall be configurable (e.g. hourly, three times per day, or daily).

The battery system shall provide a minimum continuous operational life of eight (8) months under the following conditions: data logging at 5-minute intervals and data transmission via 4G GSM on an hourly basis.

The batteries shall be readily available from local suppliers and must be easily replaceable by JW personnel without specialised tools. Battery replacement shall not void any manufacturer warranties or compromise the ingress protection (IP) rating of the data logger.

3.10 Communication Protocols

The logger units must report its data to the JW server utilizing MQTT or HTTP(S)

4 SCADA Programming and SCADA Interfacing

The Logger data must be sent to the JW SCADA control room server. The service provider must make provision for the required hardware and protocol interfaces to ensure that the data received from the remote devices be converted to OPC-UA Standard.

The data must be provided and interfaced to Adroit SCADA, current JW installed SCADA product, via the OPC-UA interface.

The Adroit SCADA must be programmed to fully comply with the strict JW Telemetry Standard.

As minimum the following minimum will be required:

- a. Scanning of the OPC-UA server data on the SCADA OPC-UA client.
- b. Configuration of the HMI / UI screens.
- c. Configure Historical Data trending.
- d. Configuration of alarming.
- e. Programming and implementation of the data reports.

Once this functionality has been demonstrated by the Contractor's appointed SCADA system integrator and a detailed Standard Operating Procedure (SOP) and Functional Design Specification (FDS) been developed and approved, Johannesburg Water (JW) reserves the right to undertake this portion of the work using its own certified SCADA engineer personnel.

5 **WEB-Hosting and GSM-SIM Cost**

JW also requires the service provider to provide a hosting service whereby the services will be to host the logger data on a WEB-SCADA system. JW water personnel must be able to access and view the WEB-SCADA through an Internet connection utilizing a Web browser.

With the necessary security protection, authorized JW employees will be able to access the WEB-SCADA using a Smart Phone, Tablet or Laptop web browser.

The HMI screens, trending and other features on the Adroit SCADA must be replicated on the WEB-SCADA system.

The service provider should include in its 24-month hosting service and the SIM costs.

The supplier must provide the brand name, model number, and a comprehensive technical data sheet for the offered equipment/product for Technical Evaluation purposes. Failure to submit these documents will result in the supplier being disqualified from further Technical Evaluation consideration.
