The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Formal Tenders TD-02/05/2022 will be evaluated and adjudicated in terms of the **80/20** Preference Point System prescribed by the Oudtshoorn Municipality’s Supply Chain Management Policy.
