1.1 Scope of Requirement

1.1.1 Supply, delivery and maintenance of water coolers on a rental basis (12 months).

SCOPE OF WORK

The department requires the following listed below for the supply, delivery and maintenance of water cooler / dispensers on a rental basis for a period of 12 months:

- Service provider is required to provide floor standing water coolers and dispensers with 18 – 20 litre capacity.
- Maintenance and changing of filters of water coolers, which includes cleaning of machines every quarter.
- Refill of water on the basis of need
- Replacement of water filter must be factored in the price
- Service provider is responsible for fixing of any faulty water coolers for the duration of the contract. Any damage to the water coolers/bottles will be the responsibility of the service provider.
- All water coolers must accommodate bottle water and filter bottles with filters
- Water coolers must be energy efficient
- All water coolers, spares/consumable used for this contract must be from the original suppliers.
- Service provider will be responsible for to refill the water onsite.
- The water coolers should have environmentally friendly cooling systems;
- The Service Provider must indicate the validity period of warranty / guarantee applicable;
- The Service Provider will be required to sign a Service Level Agreement (SLA) with the Department for the service requested
- **Service Provider should consider SANS 241 Standard for drinking water quality**
