## PART T1: TENDER PROCEDURES

---

### T1.1 Tender Notice and Invitation to Tender

The Eastern Cape Department Public Works and Infrastructure invites Professional Service Providers for the **PROVISION OF PROFESSIONAL ELECTRICAL ENGINEERING SERVICES FOR THE CONSTRUCTION OF EMAXESIBENI OFFICE PRECINCT BLOCK A IN ALFRED NZO DISTRICT**. Eastern Cape Department of Public Works and Infrastructure will enter into a contract with the successful tenderer.

The contract will be based on the CIDB Professional services contract (Third edition) 2009.

Only tenderers who have suitable experience and suitably qualified personnel in providing similar services to those that are required are eligible to submit tenders.

Bid documents will be emailed to nominated bidders on the **19 April 2024**

**NB: The preferred tenderer will be required to submit an approved insurer undertaking to provide the Professional Indemnity specific to the project within 21 days of appointment.**

### B. TENDER SUBMISSION:

The closing time for receipt of tenders by the ECDPWI is 11:00am on **21 May 2024**. Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted. Bids will be open in public. Bids must be submitted in sealed envelopes clearly marked **SCMU5-24/25-0039 PROVISION OF PROFESSIONAL ELECTRICAL ENGINEERING SERVICES FOR THE CONSTRUCTION OF EMAXESIBENI OFFICE PRECINCT BLOCK A IN ALFRED NZO DISTRICT** and must be deposited in the bid box, **DEPARTMENT OF PUBLIC WORKS AND INFRASTRUCTURE, FRONT CORNER OF QHASANA BUILDING ON THE WAY TO CIDB OFFICES LABELLED "TENDERS", BISHO**.

It is the responsibility of the bidder/s to ensure that bid documents /proposals are submitted on or before closing time and at the correct location as the department will not take responsibility of wrong delivery. Bidders using courier services for delivery of their bid documents must ensure the delivery is at the correct place / location and time as the department will not be held responsible for wrong delivery. Bid documents must only be deposited in the bid box and not be handed over to any departmental official. The department will not accept responsibility if bids are handed to department officials and are not timeously deposited in the bid box.

Tenders may only be submitted on the tender documentation that is issued. Tenderers must be registered on the National Treasury Central Supplier Data Base and proof of registration must be submitted with the proposal (<https://secure.csd.gov.za>).

Requirements for sealing, addressing, delivery, opening and assessment of tenders are stated in the Tender Data.

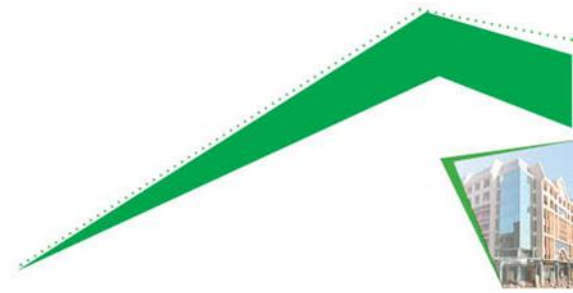
## T1.2 Tender Data
