Technical Specification: Heavy-Duty Dual-Shaft Industrial Shredder / E-Waste Crusher

1. Background

Electrical prepaid meters reaching end-of-life require secure, auditable physical destruction to prevent reuse, tampering, data exposure, and unauthorized recovery of components. These meters typically comprise flame-retardant polycarbonate/ABS plastic housings, internal printed circuit boards, copper coils, wiring, screws, terminals, and small steel parts. The selected equipment must therefore be capable of processing mixed electronic waste with a combination of rigid plastics, non-ferrous metals, circuit boards, and light ferrous material.

The equipment required is a heavy-duty dual-shaft industrial shredder or e-waste crusher designed for low-speed, high-torque primary size reduction. Dual-shaft shredders are commonly used for e-scrap and product destruction because counter-rotating shafts provide high torque, reduce heat generation, and assist with jam-resistant processing of mixed materials.

2. Scope of Work

The supplier shall design, supply, deliver, install, commission, and support a complete industrial shredding solution suitable for the secure destruction of electrical prepaid meters. The solution shall include the shredder/crusher unit, infeed hopper, drive system, control panel, guarding, discharge arrangement, emergency stop system, spare parts, manuals, operator training, and commissioning documentation.

- Assess the material characteristics and propose a machine configuration suitable for prepaid meter destruction.
- Supply a heavy-duty dual-shaft shredder or e-waste crusher with appropriate cutting chamber, cutters, drive power, torque, controls, and safety systems.
- Provide installation, testing, commissioning, training, and after-sales technical support.
- Provide documentation required for operation, maintenance, safety, warranty, and compliance.
- Demonstrate that the output material is sufficiently damaged to prevent meter reuse or component recovery without further processing.

3. Objective

The objective is to procure a robust, safe, and reliable shredding system that can securely destroy electrical prepaid meters at an industrial scale while minimizing downtime, heat generation, dust release, and operational risk. The machine must reduce complete meters into irregular, non-reusable fragments suitable for downstream recycling, sorting, or compliant disposal.

4. Technical Specification

Item	Description
Equipment type	Heavy-duty dual-shaft industrial shredder, twin-shaft e-waste crusher, or equivalent low-speed high-torque machine.
Application	Secure destruction and primary size reduction of electrical prepaid meters with plastic housings, PCBs, copper coils, wiring, screws, terminals, and small steel parts.
Drive system	Electric or hydraulic drive with high-torque gearbox/reducer suitable for continuous industrial operation.
Motor power	Minimum 22 kW total installed power; preferred range 22 kW to 75 kW depending on proposed throughput and cutter configuration.
Electrical supply	Three-phase industrial supply compatible with local site power, typically 380/400 V, 50 Hz, with overload and phase protection.
Cutting chamber	Minimum opening approximately 600 mm x 450 mm, or supplier-proposed equivalent sized to accept multiple prepaid meters per feed cycle.
Shaft arrangement	Two counter-rotating shafts with intermeshing cutters, spacers, scrapers, and cleaning fingers to reduce wrapping and material build-up.
Operating speed	Low-speed high-torque operation, typically 10–35 rpm, to reduce heat, dust, noise, jamming, and blade wear.

Cutter material	Heat-treated alloy steel, hardened tool steel, AR-grade steel, or equivalent wear-resistant cutter material suitable for mixed e-waste.
Cutter thickness	Supplier to propose cutter thickness and tooth profile based on required output size and security destruction objective.
Throughput	Minimum 300 kg/hour preferred; final guaranteed throughput to be confirmed by supplier based on meter dimensions, feed method, and output size.
Output size	Coarse destruction output acceptable unless otherwise specified; recommended target fragment size 20–80 mm or supplier-proposed size preventing reuse.
Controls	PLC or intelligent control panel with start/stop, forward/reverse, current monitoring, overload protection, auto-reverse, fault indication, and lockable isolator.
Overload protection	Automatic shaft reversal on torque/current overload to prevent jamming, motor stall, and cutter damage.
Construction	Heavy-duty welded steel frame, reinforced hopper, guarded rotating components, service access panels, and anti-vibration mounting where required.
Bearings and seals	Protected bearings and seals designed to prevent ingress of shredded contaminants, dust, copper fragments, and PCB debris.
Discharge	Discharge chute, bin interface, conveyor interface, or collection container arrangement suitable for site handling requirements.
Dust and housekeeping	Provision for dust extraction connection, enclosed discharge, or other dust-control arrangement where required by the site risk assessment.

5. Safety Requirements

- The machine shall be supplied with fixed and/or interlocked guarding around all moving parts, drive components, belts, chains, shafts, cutters, and discharge hazards.
- Emergency stop buttons shall be provided at the operator station and other practical access points.
- The hopper shall be designed to prevent operator access to cutters during operation.
- The control system shall include lockout/tagout provisions, isolator switch, overload protection, fault indication, and safe restart logic after power interruption.
- Noise and dust risks shall be addressed through design, guarding, enclosure options, extraction points, and operating procedures.

- The supplier shall provide safe operating procedures, maintenance procedures, risk information, and operator training.

6. Installation and Commissioning

- The supplier shall confirm site requirements prior to delivery, including floor loading, access, lifting, electrical supply, ventilation, dust extraction, and discharge handling.
- The supplier shall install and commission the machine or supervise installation by the purchaser's appointed contractor.
- Commissioning shall include mechanical checks, electrical checks, no-load testing, loaded testing with prepaid meters or representative material, emergency stop testing, overload/reverse testing, and operator handover.
- The supplier shall record commissioning settings, operating parameters, test observations, throughput achieved, and any corrective actions required.

7. Warranty and Guarantee

The supplier shall provide a minimum warranty and guarantee period of two (2) years from the date of successful commissioning and acceptance of the equipment. ***The warranty and guarantee shall include all required maintenance and any repairs during the two-year period, at no additional cost to the purchaser.***

8. Training

The supplier shall provide comprehensive training to designated operators on the safe operation, routine inspection, and basic maintenance of the crusher. The training shall be conducted by an accredited facilitator. Upon successful completion of the training, each operator shall be issued with a certificate confirming that the operator is trained and authorised to use the crusher.

- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
