DESCRIPTION OF THE NEED

BACKGROUND

The Broad-Based Black Economic Empowerment Amendment Act 2013, (Act 46 of 2013,

paragraph 13G. (1) states, all spheres of government, public entities and organs of state must report on their compliance with broad-based black economic empowerment in their audited annual financial statements and annual reports required under the Public Finance Management Act, 1999 (Act no.1 of 1999). The assessment of the NRWDI B-BBEE status, the issuance of a compliance report and the B-BBEE status will assist NRWDI to comply with the above Act.

DESCRIPTION OF THE NEED / SCOPE OF WORK

The service provider must provide a clear delivery plan.

Gathering of the information required to assess NRWDI on the B-BBEE.

Prepare the NRWDI specialised scorecard to determine the Institute's B-BBEE measurement.

Prepare a B-BBEE compliance report for NRWDI to comply with Broad Based Black Economic Empowerment Amendment Act 2013, Act 46 of 2013.

Issue NRWDI with the B-BBEE compliance certificate.

Submit the relevant documents to the BEE Commission.

Perform any other task necessary for the NRWDI to obtain a B-BBEE compliance report.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claimpoints for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by theorgan of state.

2. DEFINITIONS

- (a) **“black people”** is a generic term which means Africans, Coloureds and Indians—
- who are citizens of the Republic of South Africa by birth or descent; or
 - who became citizens of the Republic of South Africa by naturalisation—
 - before 27 April 1994; or
 - on or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalisationprior to that date;
- (b) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation toprovide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (c) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (d) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (e) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (f) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and
- (g) **“women”** means a person of female gender who is a citizen of the Republic of South Africa.

4. OINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
