2. **BACKGROUND**

The merSETA is the Manufacturing, Engineering and Related Services Education and Training Authority established to promote the Skills Development Act, (Act No. 97 of 1998). It facilitates skills development in the following sub-sectors: metal and engineering, automotive manufacturing, motor retail and component manufacturing, new tyre manufacturing and plastics industries.

3. **OBJECTIVE**

The merSETA hosts its Annual General Meeting (AGM) every year during the organisation's third quarter (October–December). The purpose of the AGM is to present the merSETA's Annual Report containing information about the organisation's performance and strategy for the previous financial year.

The merSETA will be hosting its Hybrid AGM in October 2026 (TBC) and requires a service provider who specialises in hosting Hybrid events to expand the reach of the event to a larger audience that would not be able to attend the physical event.

The service provider will be expected to run the registration and RSVP process so that stakeholders use one platform to register and login to the Hybrid AGM. Attendees who will be physically attending (Approx. 250) should, once registered, receive venue details. The RSVP/registration details will be directed to the Hybrid AGM mailbox. This should be included in the software/platform the service provider will use for the event.

The physical registration process should be paperless using a digital system for attendees. The printed tag should have a QR code to scan the digital programme for the day.

The service provider will be required to also include the service of a Presidential Autocue (include all line items such as operator, crew, meals and other necessary features for two days including the dry run).



4. PROJECT/ CONTRACT

This is a once-off contract valid from the date of signature to the conclusion of the project.

5. SCOPE OF PROJECT

The service provider will be required to liaise with stakeholders throughout the country. The merSETA therefore requires a high-tech service provider with competencies to run the AGM feed, incoming and outgoing, across the country.

The service provider must ensure that the merSETA AGM is one (1) event, but two (2) experiences. The provider must include all elements that will ensure physical attendees are able to see virtual attendees' interactions and virtual attendees must be able to see physical attendees from time to time, although the focus will be on the speakers. A stable connection, seamless streaming, videography and two-way communication is paramount.

The main objective of the project therefore is:

5.1. To ensure that the merSETA AGM is one (1) event, but two (2) experiences:

5.2. The preferred bidder will be required to provide and manage a registration/Rsvp platform in terms of which:

5.2.1 Registrations must be processed through the hybrid Annual General Meeting mailbox;

5.2.2 Attendees who registered to physically attend will, once registered, receive venue details. The physical registration should be a digital process (printouts will be the stakeholder tag with a QR code to scan and view the programme);

5.2.3 To enable participants not included in the initial invitation to register on the platform to be able to participate in the hybrid Annual General Meeting; and

5.2.4 The physical registration process should be paperless using a digital system for attendees. The printed tag should have a QR code to scan the digital programme for the day.

6. OUTCOMES AND DELIVERABLES

6.1 Produce a conceptual framework document to be approved by the merSETA.

6.2 Provide a detailed project plan for approval by merSETA.

6.3 Provide enhanced content engagement by producing an effective and interactive platform to ensure live streaming of sessions and seamless two-way communication (e.g., polls, comments, Q&A, online feedback, etc.).

6.4 Use relevant interactive software to enhance the experience for virtual attendees.

6.5 Provide technical expertise and equipment for hybrid events, including:

- Bidder must provide a list of equipment to be used during the event;
- Bidder must provide a contingency plan in case of technical/power/network failure or any other issue for event continuity.



- 6.6 Ensure a stable connection for virtual attendees at all times; and
- 6.7 Enhance the physical event to create a seamless virtual experience.
- 6.8 All setup to be completed by 15h00 and dry runs to be completed until 21h00 a day before the event.

6.9 Deliverables Specification but not limited to:

6.9.1. Sound system

- PA requirements
