1. PURPOSE

The purpose of this RFQ is to appoint a suitable service provider to conduct skill audit on 341 SANParks employees that are on Paterson D Band and Upper.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

The service provider will be responsible to provide the following:

3.1 Company Experience in conducting Skills Audit by providing:

- Comprehensive Company Profile indicating a minimum of five years' experience in Skills Audits.
- Three contactable referees with documentary evidence (Testimonials, Reference Letters or Certificate of Completion) indicating the successful completion of a Skills Audit project.

3.2 Team Members Experience in conducting Skills Audits by providing:

- Team Leader: Documentary proof indicating the track record of at least five years' experience in skills audits depicted in a Curriculum Vitae. Bidder must provide certified copies of relevant academic qualifications clearly indicating the minimum achievement at NQF Level 7 Degree.
- Team Members: Documentary proof indicating the track record of at least one years' experience in skills audit depicted in a Curriculum Vitae. Bidder must provide certified copies of relevant academic qualifications clearly indication achievement at NQF Level 6 Diploma.
- The Bidder must provide proof of South African Qualification Authority (SAQA) evaluation and verification for qualifications achieved in a foreign country.

3.3. Skills Audit Project Approach and Methodology

- Bidder must submit a proposed Approach and Methodology as well as a project plan with timelines on delivering the Skills Audit.

3.4 Skills Transfer

- The Bidder must provide a documented Skills Transfer Plan for the SANParks employees.

3.5 Pricing Schedule

- The bidder must provide pricing on a Bid Pricing Structure provided.

4. Skills Audit Objectives

- 4.1. Develop a skills and competency framework for all workforce segments identified (Ranger Corp, Conservation Services, Tourism and Marketing, Hospitality, Socio-Economic Transformation, Finance, Supply Chain Management, Risk Enterprise Management, and Human Resources Management)
- 4.2. Determine skills and competency gaps between future skill requirements and current employee skill sets
- 4.3. Determine scarce and critical skills for the identified segments of SANParks
- 4.4. Determine personal development plans (IDP's)
- 4.5. Develop an organizational training plan based on the outcomes of the skills and competency assessment process to address the skills gaps identified and the current needs
- 4.6. Determine skills and competencies of the current employees of the organization
- 4.7. Determine skills, competencies and qualifications required to effectively deliver on the operational requirement of the organization
- 4.8. Determine the skills and competence gaps between the skills requirements and current employee skills sets
- 4.9. Determine critical and scarce skills for the SANParks

5. Skills Audit Deliverables

5.1. **Approach and Methodology**

- 5.1.1. A comprehensive methodology, framework and approach to be followed for the skills audit
- 5.1.2. On-line assessment tool (if applicable) should be aligned to the SANParks infrastructure

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
