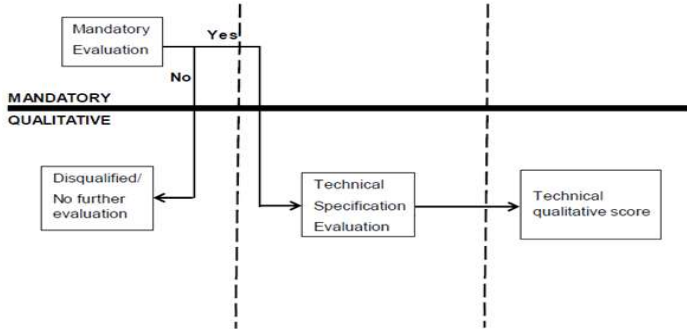

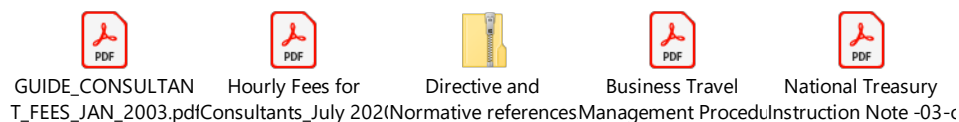

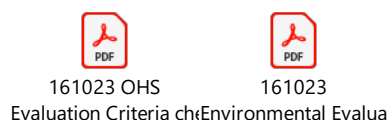


Appendix E– Supplier Development, Localisation &Industrialization
