1. BACKGROUND OF COUNCIL FOR MEDICAL SCHEMES

The Council for Medical Schemes is a statutory body established by the Medical Schemes Act (131 of 1998) to provide regulatory supervision of private health financing through medical schemes; and functions as a Schedule 3A Public Entity.

To be an agile and transformative Regulator in order to **promote affordable** and **accessible** healthcare cover towards **universal health coverage**

MISSION

The CMS regulates the medical schemes industry in a fair and transparent manner and achieves this by:

- **Protecting the public** and informing them about their rights, obligations and other matters in respect of medical schemes.
- Ensuring that **complaints raised by members** of the public are handled appropriately and speedily.
- Ensuring that all entities conducting the business of medical schemes, and other regulated entities, **comply with the Medical Schemes Act**.

General

The Senior Software Developer needs to be a self-disciplined team player with a passion for web applications development. The person will also need to function in a high paced work environment with tight deadlines, attend daily progress meetings and co-present demo meetings with the business users.

Purpose/Deliverable

The Senior Software Developer will be responsible for designing, developing and testing a web application used by the CMS to capture, analyse and report on large amounts of financial data collected from regulated entities in line with business requirements and system specifications. The web application should have an easy to use and secure User web portal which is linked to a backend database and should easily integrate with internal CMS systems (i.e. document management system, electronic signature system, etc.).

The Senior Software Developer will be expected to meet the business users and other Software Development team members at the CMS premises (Covid Protocols followed at all times) for general and system discussions from time to time.

The Senior Software Developer and appointed Service Provider will enter into a Service Level Agreement (SLA) and NDA (Non-disclosure agreement) with the CMS.

3. EVALUATION CRITERIA

CERTIFICATE OF INDEPENDENT BID DETERMINATION – SBD 8

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
