TERMS OF REFERENCE : REQUEST FOR THE APPOINTMENT OF ATTORNEYS TO AMEND LETTERS OF AUTHORITY

1. PURPOSE

To request the appointment of attorneys to attend to the amendment of the Letters of Authority of the Gauteng Partnership Trust trading as Gauteng Partnership Fund ("GPF").

2. BACKGROUND

- 2.1. The GPF was established in 2002 by the MEC of Gauteng Department of Human Settlement's predecessor in title, the Gauteng Department of Housing and Local Government ("the Founder" or the Department") in terms of the Trust Property Control Act 57 of 1988.
- 2.2. As such the GPF is a trust operated under the Trust Property Control Act with the Trust Deed as its founding document.
- 2.3. In terms of the Trust Deed the trust is operated and managed by the trustees.
- 2.4. The trustees are empowered, inter alia, to appoint a Chief Executive Officer who will be responsible for the day-to-day operation and administration of the trust activities, provided that immediately upon his/her appointment the Chief Executive Officer shall be appointed as a trustee of the trust.
- 2.5. Therefore, the Chief Executive Officer becomes a trustee authorised to act as such by the Master of the High Court through the letters of authority.
- 2.5.1. The Chief Executive Officer of the GPF resigned as such on 26 March 2020. He however remains a trustee of the GPF until removed by the Master of the High Court.

3. DETAILS OF REQUEST

- 3.1. It is common cause that a trustee only has authority to act as such once issued with the Letters of Authority by the Master of the High court.
- 3.2. Similarly, a trustee will lose the authority to act as a trustee once the Master revokes that authority through removal from the Letters of Authority.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
