1. BACKGROUND

There is an annual provision in the departmental budget Quotation to supply, deliver, service and repair medical oxygen equipment. The supply and delivery of the equipment is to ensure that emergency medical care is rendered to the community of the City of Tshwane in accordance with legislation.

2. PROJECT SCOPE

It is the intent of the City of Tshwane Emergency Services that these specifications cover to supply, deliver, service and repair medical equipment on an as and when required basis for a period not exceeding twelve (12) months.

With a view of obtaining the best results and service in the Emergency Services Department, these specifications cover only the general requirements. Minor details of materials where not otherwise specified are left to the discretion of the bidder.

All service parts shall be new and of the highest quality. It shall be protected from damage; any damaged, flawed, or defaced materials shall be rejected and replaced at a cost to the service provider. The Supplier shall warrant that the materials shall be of the highest grade, in accordance with the best practices, ready and complete for full operation. The quotation will be awarded to one bidder.

3. DELIVERABLES

3.1 The supplier shall supply, deliver, service and repair medical equipment as and when required.

- Service, repair and maintenance of medical oxygen compressor
- Supply and delivery of medical oxygen cylinder and parts

3.2 Standard maintenance contract

3.3.1 Service requirement

The service to be carried out at 12-month intervals with the following checks being carried out:

- a) Service of the Eco Med Ultra 200I Oxygen Booster Pump
- b) Service of the Comp Air L 15 FS – 10 A & F36C+ Low pressure compressor & Drier
- c) Testing of the equipment
- d) Supply and delivery of Size D medical oxygen cylinder (diameter 11cm, height 61cm, weight (empty) 3.54kg, oxygen litres 450l, water litres 3.2L, flow @2L/min 3 hours-45min)
- e) Supply and delivery of click-style stop dial, hand dial marked 0-25l/min, Oxygen cylinder pressure gauge, pressure dial protected by a rubber ring, outer body manufactured from aluminium, inner body manufactured from brass, minimum input operating pressure 250 bars pin-index regulator.
- f) Supply and replace specialized washer with a metal frame and rubber ring or a small standard rubber O-ring. Specifically, these seals often measure around 14.5mm in length, 9.3mm inner diameter, and 2.6mm width, or standard AS568-011 or -015 sizes for similar applications O-ring

4. STAGES OF EVALUATION

Bidders must provide two contactable reference letters not older than 5 years in relation to supply, deliver, service and repair of medical oxygen equipment for other clients, indicating the description of the goods or services provided on the letterhead containing contact details of the client.

Stage 3: Preference Points System

The preferential point system used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- 80 points for price
- 20 points for Specific goals

- Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.

6. VALIDITY PERIOD

The validity period for the tender after closure is 90 days. CoT shall have right and power to extend any tender validity period beyond any initial validity period set and subsequent extensions. SCM shall ensure that an extension of validity is requested in writing from all bidders before the validity expiry date. Extension of validity shall be finalized while the quotations/bids are still valid.

7. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a bidder offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder to seek confirmation of whether the bidder will be disqualified based on being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the service provider to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the City reserves the right to cancel the quotation.
