2 INTRODUCTION

- 2.1 African Exploration Mining and Finance Corporation (SOC) Ltd ("AEMFC") is a state-owned Mining Company established to secure South Africa's energy supply primarily through the mining and supply of coal for the generation of electricity, as well as securing other resources that will provide energy for the future, including key minerals for beneficiation in the energy and steel value chain. As a growing company, AEMFC is currently operating an opencast coal mine (Vlakfontein Mine- Coordinates: **Latitude 26° 0'42.15"S, Longitude 28°57'47.72"E**) established in 2011 which is located near Ogies in Mpumalanga Province with its Head Office at Waterfall City in Johannesburg.
- 2.2 AEMFC is holder of Mining Right for Vlakfontein Mine which covers various portions of the farm Vlakfontein 569 JR.
- 2.3 AEMFC Vlakfontein Mine has a contract with Eskom to Supply 2.5 million sales tons of coal per annum to Eskom Power Stations.

Thus, the Service Provider is requested to provide a proposal based on the scope of work (**Section 5 - SOW**).

AEMFC intends to appoint a Service Provider for an Insurance broker for a period of two (2) years.

6 SCOPE OF WORK (SOW) (REQUIREMENTS)

AEMFC is looking to appoint a Service Provider for Insurance Brokerage (Insurance Broker) between the company and the different insurers/underwriters for a period of two (2) years.

(The insurers/underwriters for the different insurance covers will be reviewed periodically (usually annually) for the cost competitive premiums).

6.1 The Services to be provided by the insurance broker shall be the following:

- 6.1.1 Obtaining relevant renewal information from AEMFC as necessary for the various insurance policies being renewed;
- 6.1.2 Review of exposures and risks/legislations;
- 6.1.3 Review of policy limits and sums insured;
- 6.1.4 Review of uninsured risks;
- 6.1.5 Review of business interruptions limits;

- 6.1.6 Facilitate on asset valuations/replacement values annually (to mitigate against the risk of under/over insurance);
- 6.1.7 Assist underwriting/insurance reports;
- 6.1.8 Review of claims history-ensuring claims statistics and outstanding estimates are accurate;
- 6.1.9 Annual review of risk bearing;
- 6.1.10 Review insurance clauses on all contracts;
- 6.1.11 Continuously monitor the financial health of all insurers participating on our risk and inform AEMFC of any changes;

- e) B-BBEE status will be scored out of 20 points in accordance with PPPFA. If a tenderer fails to submit proof of B-BBEE status level, the tenderer will not be disqualified (except if B-BBEE level is a pre-qualification criterion). The tenderer will, however, be awarded 80 points for price and will score 0 points for B-BBEE level /status (out of 20).

12.5 NATIONAL TREASURY'S SUPPLIER DATABASE (CSD) REGISTRATION

- a) Bidders must submit proof of registration on the National Treasury's Central Supplier Database (CSD).

14 EVALUATION CRITERIA

The following evaluation method will be used:

- 14.1 After the closing date of the bid invitation, an appointed evaluation committee of AEMFC officials and / or external parties/ consultants (where necessary) will evaluate the proposal of the service providers.
- 14.2 The committee will evaluate each of the bid proposals received against the approved criteria as stated below:
 - a) Compliance Check of required documents
 - b) Functionality (Technical)
 - c) Price and B-BBEE status level of contribution in accordance with PPPFA and its Regulations.

14.3 PHASE1: Compliance Check of Required documents

All proposals submitted will be evaluated to establish compliance to the commercial requirements such as for completion and signing of Standard Bidding Documents (SBD) forms, and submission of Central Supplier Database (CSD) registration number.

14.4 PHASE 2: Functionality

Minimum threshold value of **80** should be obtained by the service providers to qualify for the fourth phase.
