1. INTRODUCTION

1.1 INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve OHS conditions in South African Mining Industry.

2. PART A: THE CONTRACT

2.1 CONTEXT OF THIS PROCUREMENT

The MHSC seeks to appoint a service provider to conduct a review of the potential causes, early detection, consequences and suppression of conveyor fires in inclined excavations in underground mines.



Following several incidents in South African mines (e.g. Northam Platinum Mine and Impala Platinum) where rubberised conveyor belting (including fire retarded belting) caught fire with resultant fatalities, it has become apparent that the fire dynamics of flammable materials, which formed part of such conflagrations are not always fully understood. Investigations into these incidents have resulted in a number of aspects being highlighted which have a marked impact on the rate of propagation, the fire intensity levels and the general dynamics of fire products arising from such scenarios. A further example of the impact of such dynamics is the King's Cross underground train station disaster in London, United Kingdom, which resulted in the death of several firefighters who had responded to that fire.

Furthermore, according to the outcomes of the investigations into the King's Cross disaster as well as the abovementioned local incidents, factors that have become apparent as being of particular importance are:

- The type of belting and flammable materials within the installation.
- The fire loading within the excavation.
- The inclination of the installation/excavation (including potential "troughing" effects).
- The shape and size of the excavation.
- The synergistic effects of connected excavations such as lateral cross cuts, box holes, air passes and cross belts and their potential contribution to the spread of the fire and combustion products.
- The direction and velocity of the airflow within the excavation.
- The positioning of early detection and warning installations.
- The positioning and capacity (density) of fire suppression systems.

A number of International and South African standards are currently based on significant work that has been conducted over many years on the flammability and rate of flame spread of rubberised conveyor belting in use in underground mines. The assessment of these characteristic parameters effectively relies on the use of small scale and large scale testing protocols alike (utilising either full-sized or smaller samples of various types and grades of rubberised belting).

With the exclusion of one (partly completed test), no significant testing of belts located in inclined planes within tunnel enclosures could be sourced in the available literature and, as such, the effect of excavation



inclination together with down-casting or up-casting air currents through the excavation has not been effectively quantified or sufficiently studied to provide definitive design and protective parameters for such installations. Currently, there is a lack of guidance on the application of parameters such as, for example, optimal air velocity and location of fire detection sensors within such geometries and on how these should be considered to reduce risk levels both in new and existing installations alike.

In addition, the abovementioned research indicates that the fire dynamics that could possibly be set up and the way in which active fire propagates both up and down decline systems can result in totally unpredictable situations which have the potential of rapidly affecting the safety of any person within or in proximity of these sites. The effective detection and timely warning in respect of these occurrences as well as the means of determining the location of an active fire site accurately, have also been demonstrated to be challenging under these conditions. Thus, it is envisaged that a design and assessment tool can aid to improve underground conveyor belt fire emergency preparedness and response plans and scenario planning.

It also anticipated that this research will lead to improved, specific guidance for mine ventilation, engineering and fire specialists regarding the risk treatment philosophies and measures that should be taken into account when designing or modifying this type of installation.

2.2 CONTRACT PERIOD

The contract will be valid for a period of 18 months.

2.3 TERMS OF REFERENCE

a) DETAILED SPECIFICATIONS/SCOPE OF WORK

- 2.3.1.1** Conduct a comprehensive literature review, both nationally and internationally, of the potential causes, early detection, consequences and suppression of conveyor fires in inclined excavations in underground mines. Additionally, the review should also



consider previous empirical studies (including modelling using computerised fluid dynamics simulations) to gain a better understanding of the following aspects for inclined excavations:

- a) Specific fire dynamics and the impact of physical factors.
 - b) Volumes and types of contaminants generated by such fires
 - c) Effects of heat on critical installations, such as fire data acquisition/detection systems, and the interpretation of information received from these systems.
 - d) Anticipated effectiveness of fire suppression systems under different scenarios.
- 2.3.1.2** Develop improved designs that will serve as a baseline and provide alternative designs in consultation with relevant stakeholders. These designs should offer enhanced, specific guidance to mine ventilation, engineering, and fire specialists regarding the layout of rubberised conveyor belt installations situated in inclined excavations.
- 2.3.1.3** Develop an assessment tool which can be used to assess the effectiveness of the designs developed in 2.3.1.2 (of the ToR).
- 2.3.1.4** Test the designs developed in 2.3.1.2 (of the ToR) in a physical simulated environment.
- 2.3.1.5** Identify the shortcomings of the designs using the assessment tool and address those shortcomings.
- 2.3.1.6** Conduct a stakeholder workshop arranged and hosted by the service provider in Gauteng to solicit further inputs.

b) EXPECTED RESEARCH OUTCOMES

- 2.3.2.1** Provide a report on the comprehensive literature review conducted on the potential causes, early detection, consequences and suppression of conveyor fires in inclined excavations in underground mines as per 2.3.1.1 (of the ToR).
- 2.3.2.2** Provide a report of the improved designs as per 2.3.1.2 (of the ToR).
- 2.3.2.3** Provide a report together with the developed assessment tool as per 2.3.1.3 (of the ToR).
- 2.3.2.4** Provide a report of the test results as per 2.3.1.4 (of the ToR).

- 2.3.2.5** Provide a report on the identification and addressing of the shortcomings of the designs using the assessment tool as per 2.3.1.5 (of the ToR).
- 2.3.2.6** Provide a report on the stakeholder workshop arranged and hosted by the service provider in Gauteng.
- 2.3.2.7** Provide a draft final report on the potential causes, early detection, consequences and suppression of conveyor fires in inclined excavations in underground mines.
- 2.3.2.8** Provide a final report on the potential causes, early detection, consequences and suppression of conveyor fires in inclined excavations in underground mines.

c) REQUIRED TEAM COMPOSITION

- 2.3.3.1** The service provider must have at least 5 years' experience in conducting applied research and the project team must have members with expertise in the following areas:
 - a) Minimum of 5 years' experience in mining engineering in the mining sector.
 - b) Minimum of 5 years' experience in mine ventilation engineering in the mining sector.
 - c) Minimum of 5 years' experience in preventing and managing fires in the mining environment.
 - d) Minimum of 5 years' experience in mechanical engineering in the mining sector.

2. PART B: THE PRICING

- 4.1.3 Bid documents must contain both technical proposal and pricing proposal **(two envelope system).**

A digital version on USB/Memory stick containing the bid document and all other supporting documents (fully submitted bid proposal with its attachments) must be provided of all tender documentation within the bid envelope. These serve as the original sets of bid documents and form part of the contract.

4.2 BID CLOSING

- 4.2.1 There shall be no public opening by the MHSC of the bids received.
- 4.2.2 There shall be no discussions with any enterprise until evaluation and adjudication of the proposal has been complete.
- 4.2.3 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, bids submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.
- 4.2.4 All bids shall close on the specified date and time as stipulated in the bid document.
- 4.2.5 Bids received after closing time and date will be classified as LATE and will not be considered.
- 4.2.6 Bids submitted in any other manner other than the specified address (tender box) shall not be accepted.

4.3 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the Bid documents.

4.4 MANDATORY COMPLIANCE – CENTRAL SUPPLIER DATABASE

4.2 PRICE AND PREFERENCE (SPECIFIC GOALS) EVALUATION – STAGE 2

- Bid price proposals are compared on an equal and fair basis, considering all aspects of the bid pricing requirements. Qualifying bids are ranked on price and specific goals points claimed in the following manner:

- c) Collusion, Fraud and corruption: Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.
- d) Cancellation prior to awarding: MHSC reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range or any process impropriety.
- e) Fronting: MHSC, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should MHSC establish any of the fronting indicators as contained in the Department of Trade and Industry's "Guidelines on Complex Structures and Transactions and Fronting" during such inquiry/investigation, the onus is on the bidder to prove that fronting does not exist. Failure to do so within a period of 7 days from date of notification will invalidate the bid/contract and may also result in the restriction of the bidder to conduct business with the public sector for a period not exceeding 10 years, in addition to any other remedies MHSC may have against the bidder concerned.

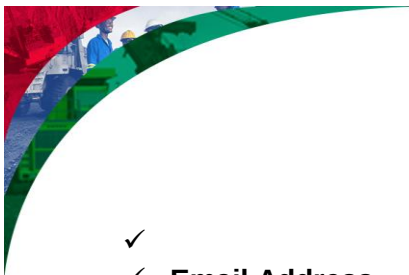

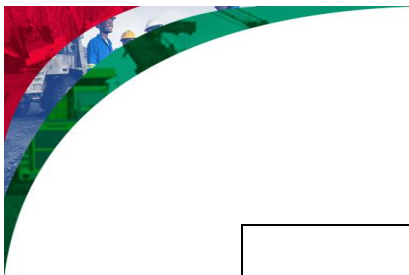

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

The Mine Health and Safety Council (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). The Mine Health and Safety Council (MHSC) appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
