1. PURPOSE

The purpose of this exercise is to appoint a service provider to provide first aid training for six (06) people.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

South African National Parks (SANParks) invites accredited Training Providers to offer in-house training to Six (06) employees in First Aid Level 1, 2 and 3 Skills Programmes. The Skills Programme is based on Unit Standard ID: 119567, 120496 and 376480 and forms part of the Qualification ID: 74269 National Certificate: Occupational Health, Safety and Environment qualification, The target group for the training is members of the Health and Safety Committee and other employees. The employees are based in Groenkloof National Park.

At the end of the training for First Aid Level 1, participants must be able to:

- Demonstrate an understanding of emergency scene management
- Demonstrate an understanding of elementary anatomy and physiology
- Assess an emergency situation
- Apply First Aid procedures to the life-threatening situation
- Treat common injuries

At the end of the training for First Aid Level 2, participants must be able to:

- Demonstrate the principles of primary emergency care.
- Assess and control a single injury emergency scene in the workplace.
- Demonstrate primary emergency life support for adults, children and infants.
- Explain and manage shock.
- Carry out secondary assessment of the sick or injured person and provide appropriate primary emergency care at the scene.
- Keep records of the incident/accident.

At the end of the training for First Aid Level 3, participants must be able to:

- Explaining the principles of advanced primary emergency care in all health emergencies.
- Demonstrating an advanced level of preparedness to deal with potential emergencies.
- Assessing and managing a complex emergency scene/disaster.
- Explaining the applied anatomy and physiology of the human body systems and describing the emergency care management of disorders and diseases relating to each physical system.
- Applying primary emergency life support for all age groups according to international and/or national protocols.
- Explaining and managing shock.

RESPONSIBILITIES OF THE TRAINING PROVIDER

- Deliver against the RFQ and Purchase Order.
- Ensure that the attendance register is signed by each learner on a daily basis for the duration of the training.
- Learner SETA enrolment forms must be completed and copies provided to SANParks.
- Ensure that the Portfolio of Evidence is submitted on a specified date.
- Ensure that all learners sign the Portfolio of Evidence submission register.
- Upload the Learners onto the SETA ETQA database. Proof of upload submitted to SANParks
- Learning Programme is facilitated, assessed, moderated and verified
- Learner guidance and support is provided
- Learners are certified – Provide Certificate of Attendance, Certificate of Competence and ETQA Statement of Results

5.2 MANDATORY REQUIREMENTS

Bidders may be disqualified if they do not fully comply with all mandatory requirements. No “unanswered” questions will be allowed. If a response to a question has been indicated as comply but not elaborated upon or substantiated it shall be regarded as mandatory non-compliance and the bidder shall be disqualified.

5.3 FUNCTIONALITY REQUIREMENTS

SANParks promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team. The minimum functional threshold will be **70%**.

Any bidder who does not meet the minimum threshold will not proceed to the Price and Preference Stage of evaluation.

12. FINAL AWARD

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

SANParks reserves the right not to award to the highest points scorer in accordance with S 2(1) (f) of the Act (PPPFA).

10.3 Points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contributor.

10.4 The maximum points for this bid are allocated as follows:
