1. INTRODUCTION

1.1 INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve OHS conditions in South African Mining Industry.

The industry criteria for regional pillar design state that the Average Pillar Stress (APS) should not exceed 2.5 x the Uniaxial Compressive Strength (UCS) of the weakest host rock, whether it is the hanging wall or footwall, in cases where lithologies differ. Handley et al. (1997) found that significant seismicity in the back area pillars starts at axial stress (f_a) values as low as 1.2. This criterion originated from back analysis conducted for strike stabilising regional pillars for deep-level Ventersdorp Contact Reef (VCR) and Carbon Leader Reef (CLR) gold mining, using longwall mining methods. Furthermore, this criterion considers only one failure mechanism, i.e. pillar foundation failure. The current APS criterion does not account for system stiffness effects. York (1998) noted that the ultimate strength of a pillar



system is largely influenced by the stiffness and level of horizontal confinement provided by the loading environment. Additionally, through extensive numerical analysis, York (1998) further noted that severe damage to regional pillars can occur at approximately 300 MPa and calculated f_a values as low as 1.25 x UCS.

Recent rock burst incidents associated with regional and ad hoc pillars in the platinum mining industry suggest that the criterion is inadequate, as rock bursts have occurred at much lower APS values than recommended by industry standards. Back analysis of platinum failures also indicates that pillar behaviour may vary from one pillar to another due to the presence of multiple lithological units with differing strength and stiffness characteristics.

2. PART A: THE CONTRACT

2.1 CONTEXT OF THIS PROCUREMENT

The MHSC intends to appoint a service provider to conduct research aimed at developing a suitable APS criterion for designing regional pillars in platinum reefs, gold reefs and other tabular ore/mineral deposits. The research should focus on tabular ore/mineral deposits.

2.2 CONTRACT PERIOD

The expected duration of the project is 18 months.

Note: The 15 months will be allocated towards the project work.

The 3 months will be allocated to the MHSC administrative duties, such as project initiation, contracts, and project closeout.

2.3 TERMS OF REFERENCE

2.3.1. DETAILED SPECIFICATIONS/SCOPE OF WORK

The service provider will be required to undertake the following as part of the scope of work:

- 2.3.1.1.** Conduct a comprehensive literature review on a national and international scale and provide a report on the appropriate APS criterion for the design of regional pillars in platinum reefs, gold reefs, and other tabular orebodies.
- 2.3.1.2.** Assess suitable seismic catalogues to create or dispel associations between regional pillar design parameters and propensity for damaging seismic events.
- 2.3.1.3.** Determine applicable industry criteria for dip pillar layouts and compare any discrepancies with those obtained for strike pillar layouts.
- 2.3.1.4.** Identify additional criteria to augment the Support and Maintenance Index for regional pillars.
- 2.3.1.5.** Develop a suitable numerical modelling methodology which includes the use of FLAC3D/UDEC/3DEC or equivalent software to effectively evaluate the stability of the regional pillars.
- 2.3.1.6.** Develop additional mine design criteria either independently or to be used in combination with APS.
- 2.3.1.7.** Utilise numerical modelling techniques to simulate regional pillars composed of multiple lithological units and compare the results with lithological homogeneous pillars.
- 2.3.1.8.** Conduct site investigations to update mine design criteria for regional pillars across the following categories:
 - 2.3.1.8.1.** Gold (two sites).
 - 2.3.1.8.2.** Platinum (UG2) (two sites).
 - 2.3.1.8.3.** Platinum (Merensky reef) (two sites).
 - 2.3.1.8.4.** Other tabular orebodies (two sites).
- 2.3.1.9.** Organise and conduct a hybrid workshop, to be hosted by the service provider in Gauteng, aimed at presenting research findings to relevant stakeholders and soliciting additional inputs.

2.3.2. EXPECTED RESEACH OUTCOMES

- 2.3.2.1.** Provide a comprehensive report summarizing the results of the literature review conducted in section **2.3.1.1.**
- 2.3.2.2.** Present the identified correlations between regional pillar characteristics and seismic events, as outlined in section **2.3.1.2.**

- 2.3.2.3. Provide industry-approved criteria for dip and strike pillar layouts, as determined in section 2.3.1.3.
- 2.3.2.4. Provide additional criteria to enhance the Support and Maintenance Index for regional pillars, as specified in section 2.3.1.4.
- 2.3.2.5. Provide suitable numerical modelling techniques for assessing the stability of regional pillars, in accordance with section 2.3.1.5.
- 2.3.2.6. Propose supplementary mine design elements, either independently or in conjunction with APS, as described in section 2.3.1.6.
- 2.3.2.7. Provide the developed numerical model for simulating regional pillars composed of multiple lithological units, as detailed in section 2.3.1.7.
- 2.3.2.8. Detailed report outlining the findings of on-site investigations conducted to update mine design criteria for regional pillars, as required in section 2.3.1.8.
- 2.3.2.9. Comprehensive report documenting the proceedings and outcomes of the hybrid workshop conducted as per section 2.3.1.9.
- 2.3.2.10. Submit a final report.

4.1.3 Bid documents must contain both technical proposal and pricing proposal **(two envelope system).**

A digital version on USB/Memory stick containing the bid document and all other supporting documents (fully submitted bid proposal with its attachments) must be provided of all tender documentation within the bid envelope. These serve as the original sets of bid documents and form part of the contract.

4.2 BID CLOSING

4.2.1 There shall be no public opening by the MHSC of the bids received.

4.2.2 There shall be no discussions with any enterprise until evaluation and adjudication of the proposal has been complete.

4.2.3 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, bids submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.

4.2.4 All bids shall close on the specified date and time as stipulated in the bid document.

4.2.5 Bids received after closing time and date will be classified as LATE and will not be considered.

4.2.6 Bids submitted in any other manner other than the specified address (tender box) shall not be accepted.

4.3 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the Bid documents.

5.1.4 Minimum of **10** years of experience in seismology in the mining sector.

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

The Mine Health and Safety Council (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). The Mine Health and Safety Council (MHSC) appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the

The parties agree that all right, title, and interest in the contract intellectual property rightly invests in The Mine Health and Safety Council (MHSC) and to give effect to the foregoing:
