- 1.3. Price(s) quoted must be exclusive of VAT.
- 1.4. This request for a formal proposal is subject to the Preferential Procurement Policy Framework Act and The Preferential Procurement Regulations, 2022, The General Conditions of Contract (GCC) and, if applicable, any other special Conditions of Contract.

2.3. **Price and Preference Points**

2.3.1. **Price Proposal**

Bidders must submit a detailed cost excluding VAT.

2.3.2. **Preference points system**

The 80/20 preference point system will be applied in line with the Preferential Procurement Regulations.

3. **ABOUT THE PANEL**

The Takeover Regulation Panel (the Panel) is established as a juristic person in terms of section 196 of the Companies Act No 71 of 2008 (the Act). The Panel reports to the Minister of the Department of Trade, Industry and Competition (the dtic). It functions as an organ of state within the public administration but as an institution outside the public service.

The Panel is listed as a Schedule 3A public entity in the Public Finance Management Act, 1999 (Act 1 of 1999).

4. **PURPOSE OF THE BID**

The purpose of this Request for Proposal (RFP) is to solicit proposals from potential service providers for the provision of B-BBEE Consulting Services who has experience in QSC verification for schedule 3A public entities.

5. **SCOPE OF WORK**

The appointed service provider will be required to provide comprehensive B-BBEE Consulting and implementation support, including the following key areas:

- 5.1. Gap Analysis: Evaluating the Panel's current B-BBEE status against sector codes.
- 5.2. Strategy and planning: Develop a B-BBEE strategy and a two-year rolling B-BBEE implementation plan for the Panel. The plan must include cost implications for each

applicable element, specific targets, and projected B-BBEE level outcomes over the two-year period.

- 5.3. Implementation and monitoring: Support the Panel with the implementation of the approved B-BBEE strategy and plan, including ongoing tracking of progress against agreed targets.
- 5.4. Progress reporting: Provide monthly progress reports to management on progress made against the B-BBEE plan and on relevant B-BBEE developments.
- 5.5. Skills transfer: Develop a skills transfer plan that sets out how Panel staff will be trained and empowered to continue implementing B-BBEE initiatives without ongoing reliance on external parties.
- 5.6. Verification readiness: Collate verification documentation, support verification readiness throughout the financial year, and assist with points validation before finalisation of the verification process.
- 5.7. Verification support: Assist the Panel during the B-BBEE verification process.
- 5.8. Regulatory advisory services: Provide advisory services on B-BBEE-related developments, including changes to applicable B-BBEE laws, codes, regulations, and related requirements.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2022

1. GENERAL CONDITIONS

- 1.1. The following preference point systems apply to invitations to tender:
 - 1.1.1. The 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - 1.1.2. The 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2. To be completed by the organ of state

The applicable preference point system for this tender is the **80/20** preference point system.

- 1.3. Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:
 - 1.3.1. Price; and
 - 1.3.2. Specific Goals.

1.4. To be completed by the organ of state:

The maximum points for this tender are allocated as follows:

- 1.5. Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6. The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any manner required by the organ of state.

2. DEFINITIONS

- 2.1. **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- 2.2. **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts
- 2.3. **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- 2.4. **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- 2.5. **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULA FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1. THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

$P_{\min}$ = Price of lowest acceptable bid
