1.2. Sepam Relay replacement / Installation

The installation scope of work entails the following:

- a) Supply and installation of control cabling
Procure and install red control cables with specifications of 1.5 mm² cross-sectional area and a total length of 75 meters for all three protection relays. Installation shall include all necessary consumables, such as cable lugs, cable ties and associated accessories to ensure a complete installation and complies with SANS standards.
- b) Supply, installation and commissioning of protection relays
Supply, install and fully commission three protection relays. This includes all associated consumables required for proper mounting, wiring and functional readiness in accordance with the OEM specifications and SANS standards.
- c) System Integration
Integrate and configure the newly installed protection relays into the existing motor protection network to ensure continuous communication, coordination and protection functionality within the existing electrical protection system.
