1. PURPOSE

The purpose of these terms of reference (ToR) is to invite or request bidders to submit a quotation for **GAS INSTALLATIONS UPGRADE** at Mountain Zebra National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

South African National Parks invites quotations for **the upgrade of gas installations** in Mountain Zebra National Park. It is a requirement of this quotation that only contractors registered with the CIDB are eligible to tender. It is estimated that tenderers should have a CIDB contractor grading designation of **1 ME** and higher.

LOCATION OF THE WORKS

The Site of Works is situated within the Mountain Zebra National Park , Off R61 / GraaffReinet Road, 24km Cradock , Eastern Cape.

3. SPECIAL CONDITIONS

- General and Special Conditions of Contract The General Conditions of Contract (GCC) available on the National Treasury website www.treasury.gov.za will be applicable to this closed quotation.
- The scope of work shall form part of a contract
- The service provider may not assign or subcontract any part of the order without the written consent of the SANParks.
- In the event that the service provider fails to deliver the required goods, SANParks retains the right to take which ever steps are necessary to alleviate the situation. This may include the involvement of other service providers and the service provider will not have any claim because of the actions taken by SANParks.
- An official order will be issued before any service is rendered to Mountain Zebra National Park.
