1. Scope

The generator must be a new, portable, petrol-powered generator rated at 8.75 kVA (7 kW) standby output or approved equivalent, suitable for providing reliable electrical power for maintenance operations, construction sites, workshops, and emergency backup applications.

2. Technical Requirements

1. PRODUCT DESCRIPTION AND TECHNICAL DOCUMENTATION

Suppliers must submit with the bid submission Model Guides of at least one page (w/pictures). Further to the above, the supplier must provide specifications of at least one page detailing the features and options available.

2. INSPECTION AND TESTING

Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the supplier's cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.

3. PROOF OF AUTHENTICITY AND QUALITY ASSURANCE

The Supplier must provide proof that the equipment supplied is genuine, brand new, and manufactured to meet the specified technical standards, in the form of, but not limited to a Manufacturer's Certificate

The certificate must include:

- Manufacturer's name and contact details

- Model and serial number
- Date of manufacture
- Statement of compliance with ISO/CE or relevant quality standards
- The certificate must be signed, dated, and stamped by an authorized representative of the manufacturer.
- A Pre-Delivery Inspection Report or Factory Acceptance Test (FAT) certificate must also be submitted, if applicable.

These documents will form part of the Quality Control Plan (QCP) and must be submitted upon delivery and before final acceptance.

4. GUARANTEES & WARRANTIES

The tools/ equipment must be covered by a minimum 12-month warranty from the date of delivery.

Warranty must cover manufacturing defects, engine, hydraulic system, and vibration mechanism.

5. OCCUPATIONAL HEALTH & SAFETY REQUIREMENTS

Equipment shall comply with all safety requirements as prescribed in the Occupational Health and Safety Act No 85 of 1993 (Latest revision). The Tenderer furthermore must accept full responsibilities as per Clause 10 of the Occupational Health and Safety Act No 85 of 1993, "General duties of manufacturers and others regarding articles and substances for use at work".

6. Delivery Period

Products listed on the purchase order shall be delivered to the specified location within **7 calendar days of the date of the purchase order**. The period for delivery of the products listed on the purchase order shall be agreed with the municipal responsible official prior to delivery. Should the lowest priced Contractor be unable to deliver the specified product within the stipulated time, the outstanding order may be cancelled and a new order placed with a contractor who can meet these requirements.

7. Delivery Delays

Should the Service Provider fail to deliver the complete order or only part of the order within 14 days, without written proof justifying such delay, the Municipality may cancel the outstanding order and place a new order with a Service Provider who can meet these requirements.

Should the Service Provider fail to respond within the times as set out above, a penalty equal to 1% of the total cost of the work will be deducted from any monies due, for each day in breach thereof.

8. ESTIMATED QUANTITIES

Bidders must take note that quantities are not guaranteed and merely an estimate. Kouga Local Municipality reserves the right to select the number of tools/ equipment procured. Items will be awarded per line item to the successful bidder. All items will be procured on an ad-hoc basis.

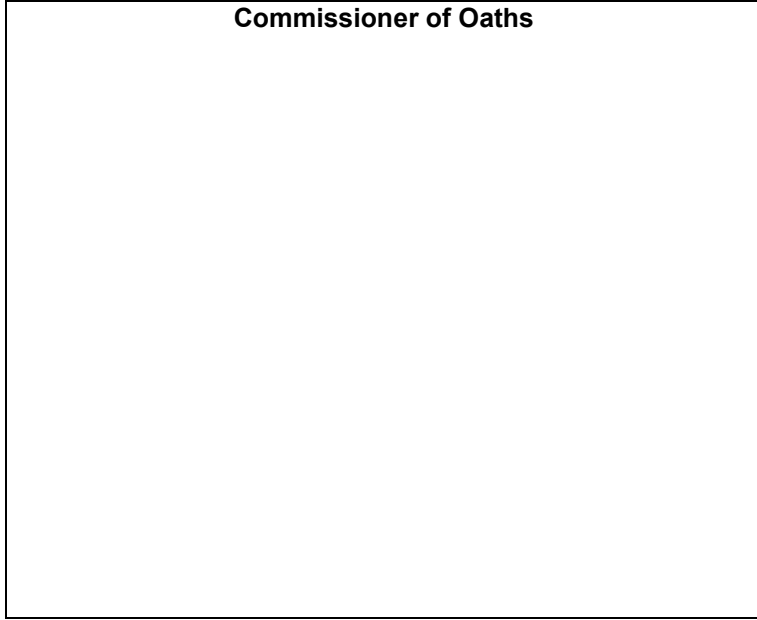
