1. BACKGROUND

The Tshwane Automotive Special Economic Zone (TASEZ) is co-owned by the Department of Trade, Industry and Competition (the DTIC), the Gauteng Provincial Government (GPG) and the City of Tshwane Municipality (CoT).

TASEZ is registered in terms of the Companies Act No 71 of 2008 and it is the Operator of the Tshwane Automotive Special Economic Zone in terms of the Special Economic Zones Act 16 of 2014. TASEZ is situated in the east of Pretoria City in Silverton. It aims to offer a diversity of appropriate land uses and other economic activities.

TASEZ seeks to appoint a qualified and experience internet service provider to supply and install as detailed in the scope of work. The CSIR building currently lacks adequate internet connectivity and a modern telephone system, which hinders productivity and seamless communication among staff members. With the increasing demands for data transfer, online meetings, and cloud-based applications, it is imperative to upgrade TASEZ infrastructure to meet these needs.

2. INVITATION TO SUBMIT A QUOTATION

Appointment of a service provider for the Supply, Installation and configuration of the internet network connectivity and telephone system.

3. SCOPE OF WORK

The service provider will be required to supply, install and configure the internet network connectivity and telephone system for TASEZ offices (CSIR Building).

The appointed the of internet service provider will be required to provide the solution based on a WIFI-Management platform via the onsite Unifi controller, WIFI access point to address the RF requirements and provide the required network within each coverage arears as indicated in the assessment report (Annexure A) and will so be required to supply and configure a voice over internet protocol (VOIP) telephone system.

3.1. Wireless Lan (WLAN) Solution:

A Ubiquity Wireless Access Point Solution must be provider with the below hardware:

- Ubiquity U6 WI-FI Long Range access Points
- Ubiquity 24 port Edge-Core switch with management capabilities

- Cat6 Copper Cables to all Access Point for PoE and speed.

Coverage/ Locations:

Coverage will be provided in the following areas as per the service requirements:

- Ground Floor (East and West Wing)
- Lower Level

Functionality:

The Unifi WI-FI controller which will reside at TASEZ (CSIR Building 21) will control all aspects of the WI-FI network, all management and configurations will be done from this device. This includes updates of configurations, software updates, management functions security updates. From this device all configurations will be pushed down to the WI-FI access points. All access points will be pointed to the Unifi Controller for configurations and will rely on this controller for updates configurations, such as SSID and security control.

SSID (Service Set Identifier)

To configure two SSID's as per the tender's requirements." The service provider is required to configure the Access Points to have two SSID (WI-FI network name) where on SSID will provide/connectivity for both internet and the Municipality LAN (Data)/POP, the second SSID must provide connectivity only to internet and provide low bandwidth compared to the first SSID.

3.2. Security:

Configure the two SSID's with a password that the customer will provide for secure authentication.

3.2.1. Dateline Connectivity

The service provider will be able to provision a network Dateline on 200Mbps NeoBroadband Fibre.

3.3. Telephone System

3.3.1. Solution Type

The service provider will supply and configure on operator Connect telephone platform system that enables cloud services to work closely with Microsoft Teams cloud, offering Voiceover internet protocol (VoIP) access to all Microsoft Teams users.

The Microsoft Operator Connect Solution that will provides a comprehensive telephony solution on the MS Teams interface to enables the user to have access to all the rich Microsoft Teams features and functions in one place. Calls that can be made to landline or mobile number of internal and external contacts, giving the basic functionality of traditional business phone system (PBX)

3.4. Maintenance and Support

The service provider will maintain the VoIP telephone system and proactively monitor all equipment and last mile access, ensuring optimal response times. The Operator Connect Gateway should also be managed and maintained by the service provider and keep up to date with all relevant software, patches and in accordance with the Microsoft Teams requirements to ensure optimal performance.

4. CONTACT AND COMMUNICATION

- 4.1. All communication and enquiries shall be **in writing** (via email), to the following email address, rfqs-rfps@tasez.co.za. TASEZ will communicate with all Bidders where clarity regarding this RFQ is sought.
- 4.2. **Clarification questions from bidders will be closed two (2) days before date of closure on the RFQ.**
- 4.3. Any communication to an official in respect of the RFQ between the closing date and the award of the contract by the Bidders is prohibited.
- 4.4. If a Bidders finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this RFQ or any other information provided by TASEZ (other than minor clerical matters), the Bidders must promptly notify TASEZ in writing of such discrepancy, ambiguity, error or inconsistency in order to afford TASEZ an opportunity to consider what corrective action is necessary (if any).
- 4.5. Any actual discrepancy, ambiguity, error, or inconsistency in the RFQ or any other information provided by TASEZ will, if possible, be corrected and provided to all Bidders without attribution to the Bidders who provided the written notice.
- 4.6. All persons (including Bidders) obtaining or receiving the RFQ and any other information in connection with the RFQ must keep the contents of the RFQ and other such information confidential, and not disclose or use the information except as required for the purpose of developing a response to the RFQ.

5. LATE SUBMISSION

- 5.1. Late responses to the RFQ will not be accepted.
- 5.2. All dates and times in this RFQs are in accordance to the South African standard calendar and time.**
- 5.3. Any time or date in this RFQ is subject to change at TASEZ's discretion. The establishment of a time or date in this RFQ does not create an obligation on the part of TASEZ to take any action or create any right in any way for any Bidders to demand that any action be taken on the date established.
- 5.4. The Bidders accepts that, if TASEZ extends the deadline for the RFQ submission (the closing date) for any reason, the requirements of this RFQ otherwise apply equally to the extended deadline

7. VALIDITY PERIOD OF THE RFQ

The validity period of this RFQ shall be **90 days** from the closing date.

8. DURATION OF THE CONTRACT

The duration of the contract will be for a period of twelve Months.

1.6. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. Definitions

2.1. "B-BBEE" means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;

2.2. "B-BBEE status level of contributor" means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;

2.3. "Bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;

- 2.4. "Broad-Based Black Economic Empowerment Act" means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);

This Standard Bidding Document (SBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

Before completing this declaration, Bidder must study the General Conditions, Definitions, Directives applicable in respect of Local Content as prescribed in the Preferential Procurement Regulations, 2011, the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 (Edition 1) and the Guidance on the Calculation of Local Content together with the Local Content Declaration Templates [Annex C (Local Content Declaration: Summary Schedule), D (Imported Content Declaration: Supporting Schedule to Annex C) and E (Local Content Declaration: Supporting Schedule to Annex C)].
