Introduction to the NRF

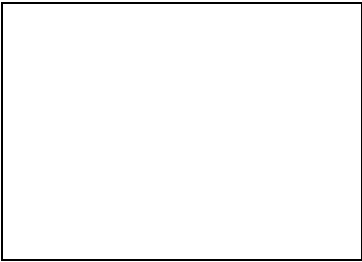
