- Preference points system:

The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. If all bids received are more than R 1 million, the proposal will be cancelled and re-issued. **A Bidder, whose price is above R 1 million will automatically be disqualified from the evaluation process.**
