1. PURPOSE OF THE REPORT:

The Kouga Local Municipality needs to procure the services of an independent auditing firm for the review of the 2025/26 Annual Financial Statements. The purpose of this report is to request the Bid Specification Committee to consider this report and grant authority to advertise for quotations from prospective service providers.

2. BACKGROUND:

Section 165 of the Municipal Finance Management Act (MFMA) states that each municipality must have an internal audit unit.

The MFMA further states that the internal audit unit of a municipality must:

- a) Prepare a risk-based audit plan and an internal audit program for each financial year;
- b) Advise the accounting officer and report to the audit committee on the implementation of the internal audit plan and matters relating to -
 - I. internal audit;
 - II. internal controls;
 - III. accounting procedures and practices;
 - IV. risk and risk management;
 - V. performance management;
 - VI. loss control; and
 - VII. Compliance with the MFMA, the annual Division of Revenue Act and any other applicable legislation; and
- c) Perform such other duties as may be assigned to it by the accounting officer.

In accordance with the annual Internal Audit plan, Internal Audit is required to review the Annual Financial Statements of the Municipality and present such report to the Audit Committee.

As the Kouga Local Municipality does not have sufficient capacity, its mandate as stipulated in the MFMA cannot be fulfilled, hence the requirement to advertise for the review of the Annual Financial Statements.

3. SCOPE OF WORK

The Kouga Local Municipality hereby invites written quotations from suitably qualified institutions to review the Annual Financial Statements for 2025/26 and present a report to the Audit Committee for consideration.

The prospective service providers are required to submit a total cost quotation in respect of the scope of work set out below:

- Inspecting whether disclosures in the draft Annual Financial Statements for the year ended 30 June 2026 comply with the statements of GRAP using the National Treasury GRAP Disclosure Checklist.
- Agreeing the prior year comparatives of the draft Annual Financial Statements to the prior year approved financial statements.
- Checking the referencing of all the notes included in the draft Annual Financial Statements.
- Reading all addendums included in the draft Annual Financial Statements for any misleading information.
