## 1 GENERAL

Submissions to this Request for Proposal (RFP) [hereinafter referred to as a Tender or a Proposal] are requested from persons, companies, close corporations or enterprises [hereinafter referred to as an entity, or Tenderer].

### 1.1 DESCRIPTION

### 3 **BROAD-BASED BLACK ECONOMIC EMPOWERMENT AND SOCIO-ECONOMIC OBLIGATIONS**

SFF Association fully endorses and supports the Government's objective of Broad-Based Black Economic Empowerment and it is strongly of the opinion that all South African business enterprises have an equal obligation to redress the imbalances of the past.

#### 3.1 B-BBEE Joint Ventures or Consortiums

Tenderers who would wish to respond to this RFP as a Joint Venture [JV] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Tenderers must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If such a JV or consortium agreement is unavailable, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by SFF association through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to SFF Association.

### 3.2 Preference Points and Specific Goals

As prescribed in terms of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and Preferential Procurement Regulations 2022, Tenderers are to note that the following preference point systems:

- **the 80/20 system for requirements with a Rand value of up to R50,000,000 (all applicable taxes included) OR**
- **the 90/10 system for requirements with a Rand value above R50,000,000 (all applicable taxes included)**

When SFF association invites prospective Service Providers to submit Proposals for its Specific Goals, it requires Tenderers to complete Annexure A [the B-BBEE Preference Point Claim Form] and submit it together with proof of their documents as stipulated in the Claim Form in order to obtain Specific Goal Points.

**Note:** Failure to submit a valid and certified copy B-BBEE certificate or Sworn Affidavit or any other documents specified (as evidence for Specific Goals) at the Closing Date of this RFP will result in a score of zero being allocated for Specific Goals.

### 3.3 Subcontracting

SFF association fully endorses Government's transformation and empowerment objectives when contemplating subcontracting. Tenderers are requested to give preference to companies which are, Entities with a specified BEE level, EMEs and QSEs, and South African Owned Companies in order to promote Supplier Development.

In terms of Annexure A of this RFP [the B-BBEE Preference Point Claim Form], Tenderers are required to indicate the percentage of the contract that will be sub-contracted as well as the B-BBEE status of the sub-contractor/s.

In addition, tenderers are required to attach a letter from the intended sub-contractor in the event of the Tenderer's appointment.

- 7.2. reject any Proposal which does not conform to instructions and scope of work which are detailed herein;
- 7.3. disqualify Proposals submitted after the stated submission deadline [Closing Date];
- 7.4. not necessarily accept the lowest priced Proposal or an alternative Tender;
- 7.5. validate any information submitted by Tenderers in response to this tender. This would include but not limited to, requesting the Tenderer to provide supporting evidence. By submitting a tender, the Tenderer hereby irrevocable grant the necessary consent to SFF to do so;

## 9 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Tenderers are required to self-register on National Treasury's Central Supplier Database ("CSD") which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Tenderers must register on the CSD prior to submitting their bids. Business may not be awarded to a Tenderer who has failed to register on the CSD. **Only foreign suppliers with no local registered entity need not register on the CSD.**

## 10 TAX COMPLIANCE

Tenderers must be compliant when submitting a proposal to SFF and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this tender that the tax matters of the successful Tenderer be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Tenderer's tax obligations.

The Tenderer shall–

## PART 2. BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

### 12 BACKGROUND AND SCOPE OF WORK

#### 12.1 Introduction

RFP number SFF/2024/NOE/SP7 is for a service provider, referred to as the Tenderer in this tender document, to carry out a tectonostratigraphic evolution study of the Jonglei sub-basin based on 2D kinematic restoration modelling and fault seal analysis referred to as Sub-Project7 in the license Block B2 in South Sudan.

South Africa's state-owned Strategic Fuel Fund ("SFF") signed an Exploration and Production Sharing Agreement (EPSA) with the Ministry of Petroleum, South Sudan government, in May 2019. Under this agreement, SFF will carry out E&P activities in Block B2 in partnership with South Sudan's national oil company, Nile Petroleum Corporation.

As part of the exploration program, SFF carries out geological and geophysical studies in Block B2 to increase the chance of hydrocarbon discovery. To fulfil this obligation, SFF seeks a technically competent service provider to conduct a detailed Tectonostratigraphic evolution study of the **Jonglei subbasin**.

Upon completing the study on the Jonglei subbasin, SFF intends to carry out similar studies on other basins. Consequently, this contract is subject to potential extension as per the sole and unfettered discretion of SFF.

#### 12.2 Background Information

Understanding the underlying geology of sedimentary basins is often hindered by complex structures and/or a lack of data, leading to highly uncertain models and, thus, exploration uncertainties. Subsurface structural models are critical for understanding a basin's structural evolution. Tectonic controls such as faults and subsidence/uplift significantly alter the subsurface geology, impacting petroleum system elements such as reservoir distribution and source rock burial depth.

Kinematic restoration models can aid the understanding of petroleum systems processes, including hydrocarbon maturation, expulsion, migration, and accumulation, and the potential present-day location of hydrocarbon fields.

Structural balancing and restoration combined make a good tool that can be used to validate structural models and predict untapped locations with more confidence in a geologically plausible manner. Structural balanced models represent a powerful tool for predicting unseen subsurface geometries based on input data (e.g., outcrop geometries, seismic sections/volumes, gravity models, etc.) The validity of structural restoration is determined by achieving a restoration model that is both **balanced and geologically plausible**. Several restoration models may be generated; therefore, it is recommended that multiple restoration scenarios be tested. Several results that are useful for a range of geological assessments can emerge from structural restoration. These include validation of interpretation, prediction of unseen structures and horizons geometries, estimation of extension and shortening, quantification of uplift and erosion.

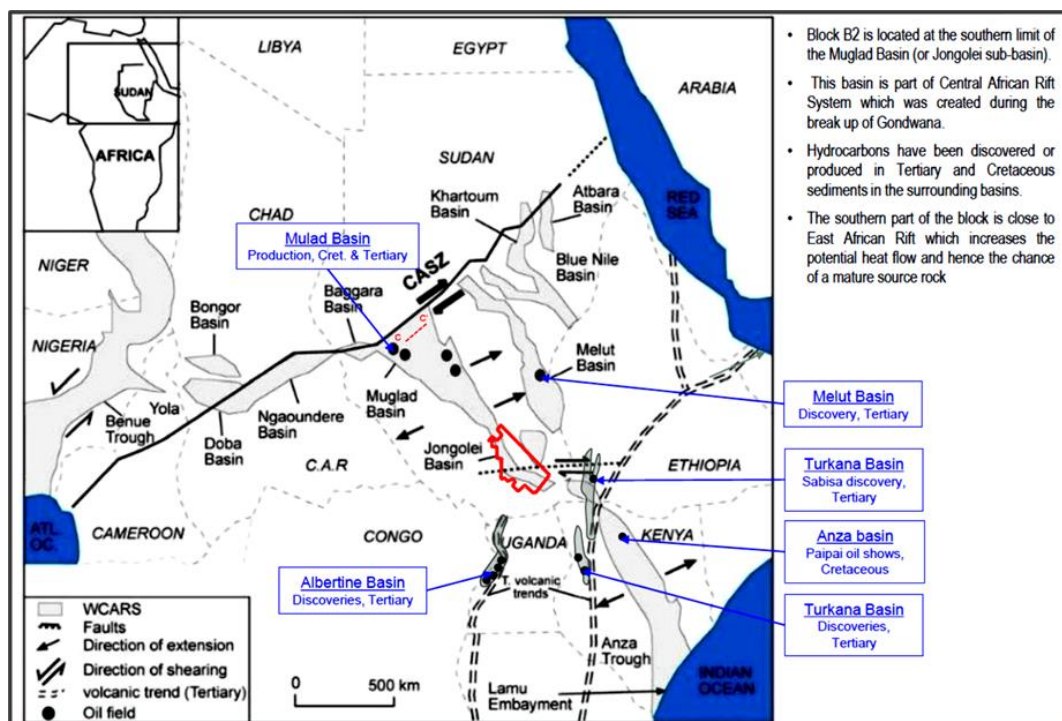


Figure 1: Map showing the location of the Muglad Basin and Sub-basins of Sudan as a part of the Central African Rift System. The red polygon represents the boundary of Block B2 in the Jonglei Sub-Basin. (Modified after Makeen Y.M 2021)

Geologically, the study area (Jonglei Sub-basin) is located in the southern part of the Muglad Basin, a large rift basin related to the Central African Rift Zone. Muglad basin's total area is approximately 120,000 km<sup>2</sup>, extending 800 km in an NW-SE direction with a maximum width of 200km. It comprises several sub-basins oriented in an NW-SE to NNW-SSE direction, with extensional and strike-slip structural histories (fig 1). The basin has undergone a polyphase development, resulting in three major phases of extension with intervening periods of uplift, erosion, or non-deposition. Three major episodes of extensional tectonism are recognized: - Early Cretaceous (140 - 95 Ma), Late Cretaceous (95 - 65 Ma), and Paleogene (65 -30 Ma). Each episode started as a rifting phase and ended with a sag phase (Fig. 2).

The stratigraphic succession of each rift-related depositional cycle begins near the rift margins with basal sand, followed upwards by a shale-dominated interval, reflecting the deepening of the basin. Shale-dominated sediments accumulated during periods of active rifting when subsidence was maximum. Sand-dominated sediments accumulated when subsidence rates were relatively low, especially during the thermal sag phases. Extensive lacustrine shales dominate syn-rift deposits of the first cycle (Abu Gabra Formation). Schull (1988) concluded that the lake water depth was sufficient for accumulating and preserving organic-rich kerogenous shales, the primary source of rocks for the oils found in this basin. Giedt (1990) supported the notion that the syn-rift deposits of the second episode (Aradeiba, Zarqa, and Ghazal Formations) and the third episode (Nayil and Tendi Formations) consist mainly of lacustrine as well as fluvial overbank shales.

The rift basin has commercial petroleum reserves, with both Cretaceous and Tertiary petroleum systems active. The principal exploration risks are the lateral seal and, locally, the effect of tectonic rejuvenation and tectonic inversion. The depo-centres of Muglad Basin contain Cretaceous to Paleogene lacustrine source rocks that have generated hydrocarbons since the Late Cretaceous. The generated hydrocarbons migrated into Cretaceous and Paleogene reservoirs and structural traps.

## **13 PROJECT OBJECTIVES**

This study aims to undertake a thorough Tectonostratigraphic evolution study based on 2D kinematic restoration, including structural geological analysis of the Jonglei Subbasin. The primary objectives are to validate interpretations, establish the timing of trap formation and hydrocarbon charge, assess source rock preservation, evaluate seal capacity, predict unseen structures and horizons geometries, estimate of extension and shortening, and quantify uplift and erosion.

## **14 PROJECT EXECUTION PLAN (PEP)**

The tenderer must submit a PEP outlining their approach to conducting the tectonostratigraphic evolution study of the Jonglei sub-basin based on 2D kinematic restoration modelling and fault seal analysis. The significant elements of a project execution plan are:

- Scope Definition
- Project scheduling
- Timelines as per deliverables
- Resource allocation

## **15 PROJECT DESCRIPTION AND SCOPE OF WORK**

### **15.1 Background**

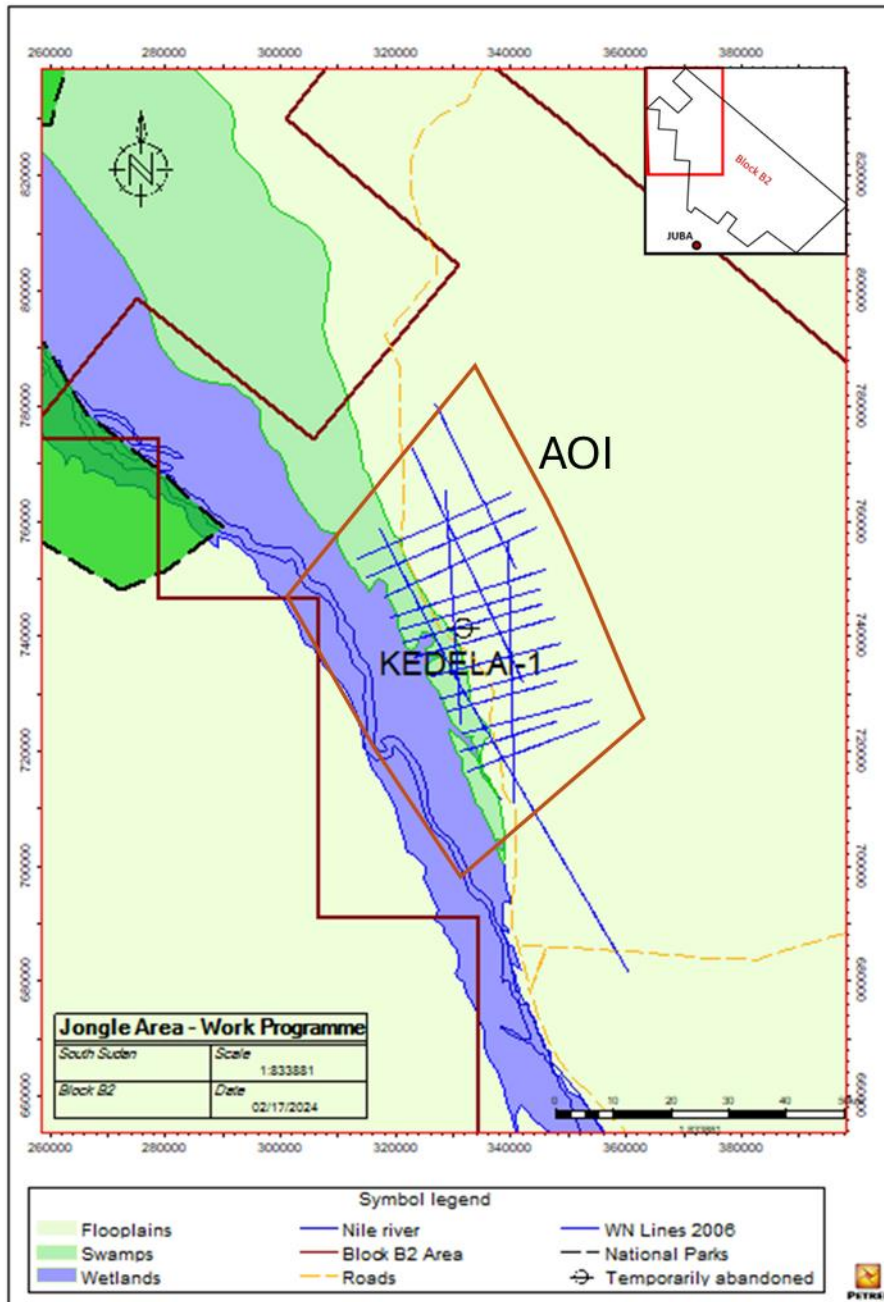


Figure 3 Physiographic map showing the location of Kedelai-1 well and legacy seismic lines in Block B2, South Sudan, highlighting the area of interest.

License Block B2 is located in the southeastern portion of South Sudan and extends over approximately 48,000 sq km. The Area of interest (AOI) terrain is mainly flat and subjected to seasonal flooding of the White Nile River. It consists of swamps (20%) and floodplains (80%), as shown in Figure 3.

The Jonglei subbasin is a southern extension of the great Muglad basin. Despite its unexplored nature, its geology and oil potential are anticipated to reflect those of the Muglad Basin. Currently, multiple rigorous geotechnical studies are underway to meticulously evaluate and fully ascertain the subbasin's geological attributes and promising oil potential.

Recently acquired gravity and magnetic data fully cover the area of interest. Basement interpretation and major fault lineaments were interpreted from the GM models.

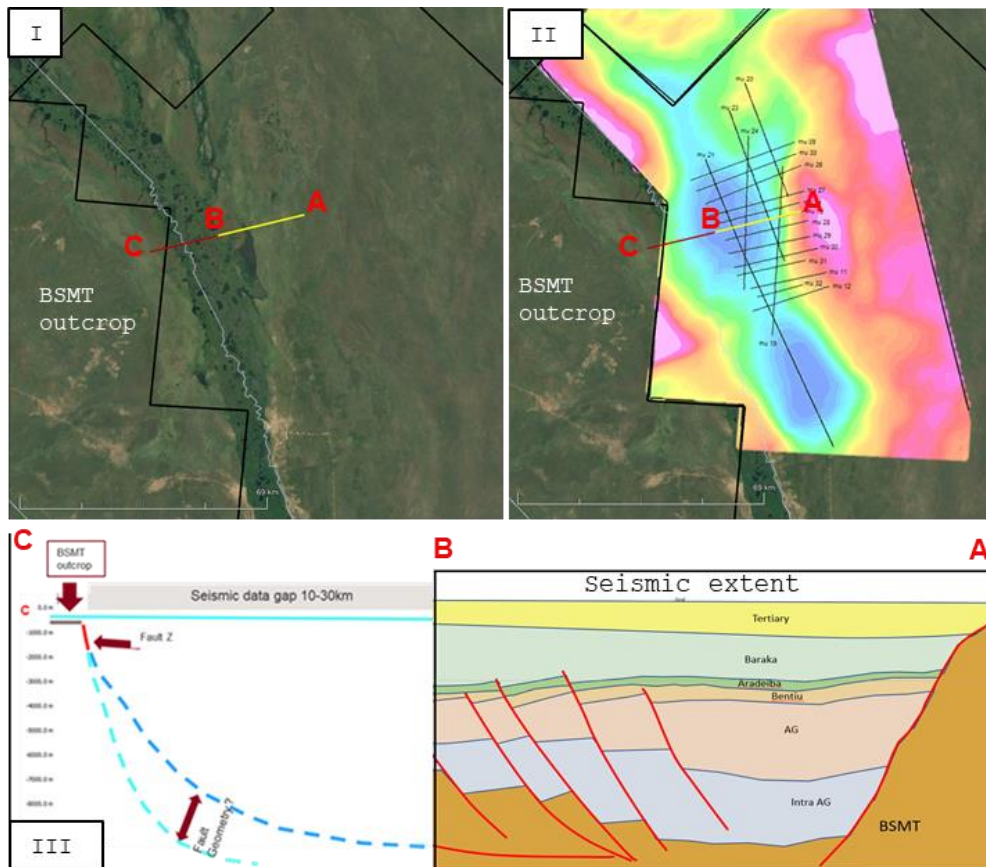


Figure 4 (I). Aerial Google Maps of the Study Area Showcasing the Outcropping Basement on the flanks of the Graben, (II). Basement depth map derived from gravity data. (III). cross section across the graben showing the extent of the seismic data.

In addition, 18 2D seismic lines are available in the AOI. Seismic data is limited to the eastern side of the mapped graben. Based on Gravity magnetic and geological conceptual models, the basin is understood to extend further West out of seismic coverage. Figure 4 shows a Google map of the area of interest, overlain by an existing seismic and Gravity map of the basement. Seismic data is available from points A to B. The Section between points B-C is covered by gravity & magnetic data only, not seismic. The basement outcrop

is mapped on the western side of the graben. Due to the limited seismic coverage on the western side of the graben, there is a gap in our understanding of the geological features in that area. The service provider is expected to leverage all available data to proactively model and predict horizons and faults in areas not covered by seismic data. This approach will significantly enhance geological understanding of the entire graben. Biostratigraphic analysis data is available from the Keedelai-1 well in the Jonglei subbasin. A 3D geological model, including main horizons and fault interpretations, is available over the area covered with seismic lines.

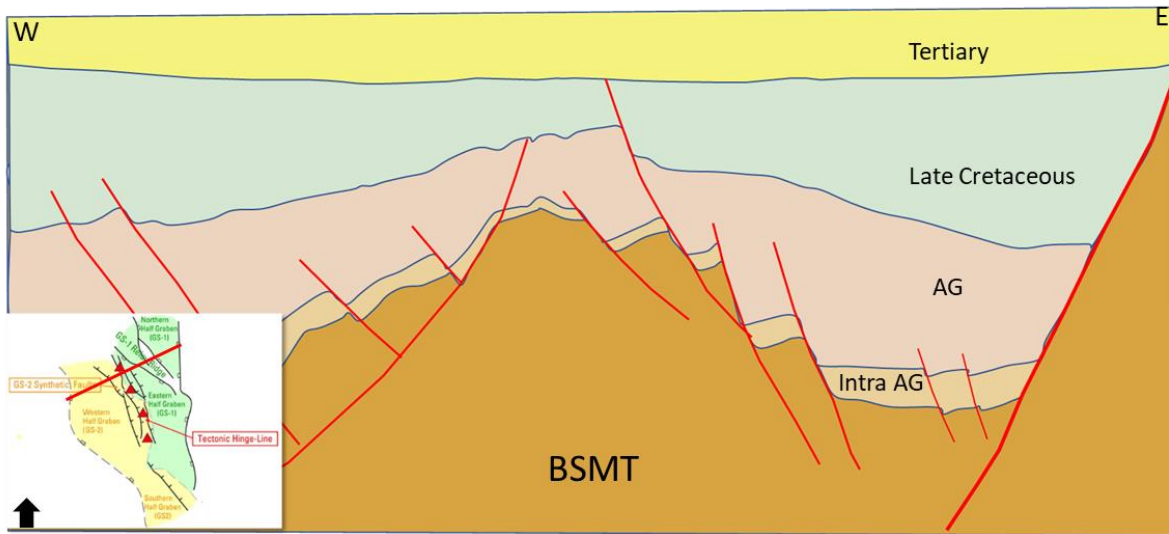


Figure 5 Schematic cross section of Jonglei Subbasin representing the Northern sector of the basin

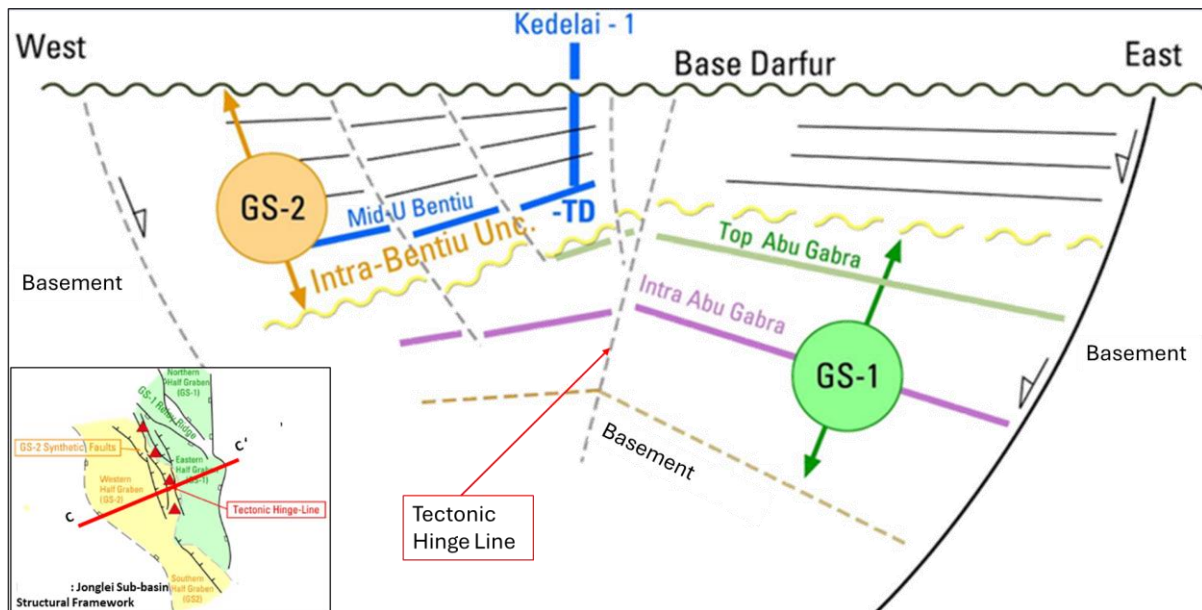


Figure 6: Schematic cross section of Jonglei sub basin representing the central part. (GS: Growth Sequence)

The basement morphology varies across the subbasin. In the Northern sector of the basin, seismic and GM interpretation indicate a basement high between the basement lows, as shown in a schematic in Figure 5. Towards the centre of the sub-basin, the basement high disappears, and distinct rotated fault blocks are interpreted as dipping in a westerly direction. The rotated fault blocks on the west side of the graben seem to be separated by a hinge zone from the east unrotated zone. Figure 6 demonstrates the conceptual geological model, highlighting the tectonic features observed in the center of the sub-basin. As several

models may be generated, the service provider is requested to test multiple scenarios and propose the most geologically plausible model.

## 15.2 TECHNICAL WORK DESCRIPTION

As indicated in the typical chronostratigraphic of Muglad, fig 2, the models should include but not be limited to the following horizons: Basement, Abu Gabra, Bentiu, Baraka and Amal.

The study will be divided into three main phases. Phase 1 will focus on data integration and validation of seismic interpretations and cross-section interpretation QC and validation. Phase 2 will focus on 2D kinematic sequential restoration. Phase 3 will focus on updating the 3D model based on the results of 2D models and validating the integrity of traps based on fault seal analysis. As part of the SOW, the tenderer will transfer knowledge and skills to SFF's technical staff via workshops and Demo exercises during the project.

**Phase I:** data integration and validations of seismic and cross-section interpretations

- a. The tenderer will use available tools and data to predict fault geometry and horizon interpretations where data is sparse or unavailable.
- b. Model faults behaviour at depth and assess its relationship with the structural traps, rate and amount of accommodation space created and expected sediment thickness.
- c. Quantify the length, area and thickness variations of stratigraphic horizons in 2D
- d. Calculate sedimentation rates per selected stratigraphic unit (AbuGabra, Bentiu, Darfur Group and Tertiary Units)
- e. Analyse and calculate the across-fault displacement.
- f. Validate interpretations and propose geologically plausible interpretations
- g. Identify and interpret Stratigraphic features that might be visible in restored sections

**Phase II:** 2D Sequential Restoration on a minimum of three sections but not limited to.

- h. The tenderer will conduct a 2D kinematic sequential restoration on selected seismic lines that adequately represent the geology of the Jonglei sub-basin.
- i. Predict the rate of subsidence
- j. Estimate source rock preservation of AbuGabra sequence
- k. Estimate sealing capacity of horizons above Bentiu and possible overpressure.
- l. Predicts fault-related deformation for a given fault shape and offset

**Phase III:** 3D Model updates and Fault Seal Analysis

- m. Update 3D structural model with outputs from 2D restoration models
- n. Asses the possible strike-slip movement/ transfer zone component in the 3D model
- o. Evaluate throw distribution, across fault juxtaposition, present and Paleo-Fault seal analysis
- p. Conduct fault seal uncertainty models

## 16 DELIVERABLES

### Bi-Weekly

The service provider will prepare and deliver regular presentations documenting findings at each project phase. Regular workshops will be scheduled and conducted on Microsoft Teams to discuss the findings and project progress.

### Final Report

The final deliverables will include a comprehensive **REPORT** documenting all aspects of the study as discussed in the scope of work, including interpreted seismic sections, analyses, assumptions, models etc.

Sections and models must be presented in a file format compatible with Petrel.

## 17 MILESTONES / PAYMENT SCHEDULE

## APPENDIX (III): SAFETY ARRANGEMENTS AND PROCEDURAL COMPLIANCE WITH THE OCCUPATIONAL HEALTH AND SAFETY ACT (ACT 85 OF 1993) AND APPLICABLE REGULATIONS

### 1. General

- 1.1 The Contractor and SFF (hereinafter referred to as “the Client”) are individual employers, each in its own right, with their respective duties and obligations set out in the Occupational Health and Safety Act, Act 85 of 1993 (the Act) and applicable Regulations.
- 1.2 The Contractor accepts, in terms of the General Conditions of Contract and in terms of the Act, his obligations as an employer in respect of all persons in his employ, other persons on the premises or the Site or place of work or on the work to be executed by him, and under his control. He shall, before commencement with the execution of the contract work, comply with the provisions set out in the Act, and shall implement and maintain a Health and Safety Plan as described in the Construction Regulations, 2003 and as approved by SFF, on the Site and place of work for the duration of the Contract.
- 1.3 The Contractor accepts his obligation to complying fully with the Act and applicable Regulations notwithstanding the omission of some of the provisions of the Act and the Regulations from this document.
- 1.4 SFF accepts, in terms of the Act, its obligations as an employer of its own employees working on or associated with the site or place of work, and the Contractor and Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall at all times, co-operate in respect of the health and safety management of the site, and shall agree on the practical arrangements and procedures to be implemented and maintained during execution of the Works.
- 1.5 In the event of any discrepancies between any legislation and this specification, the applicable legislation will take precedence.

### 2. Definitions

- 2.1 In this Specification any word or expression to which a meaning has been assigned in the Construction Regulations, shall have the meaning so assigned to it, unless the context otherwise indicates: -
- 2.2 “**competent person**” in relation to construction work, means any person having the knowledge, training and experience specific to the work or task being performed:  
Provided that where appropriate qualifications and training are registered as per the South African Qualifications Authority Act, 1995 these qualifications and training shall be deemed to be the required qualifications and training;
- 2.4 “**contractor**” means principal contractor and “**subcontractor**” means contractor as defined by the Construction Regulations, 2003.
- 2.5 “**fall protection plan**” means a documented plan, of all risks relating to working from an elevated position, considering the nature of work undertaken, and setting out the procedures and methods applied to eliminate the risk;
- 2.6 “**health and safety file**” means a file or other record in permanent form, containing the information required to be kept on site in accordance with the Act and applicable Regulations;

- 2.7 **“Health and Safety Plan”** means a documented plan which addresses the hazards identified and include safe work procedures to mitigate, reduce or control the hazards identified;
- 2.8 **“Risk Assessment”** means a programme to determine any risk associated with any hazard at a construction site, in order to identify the steps needed to be taken to remove, reduce or control such hazard;
- 2.9 **“the Act”** means the Occupational Health and Safety Act No. 85 of 1993.
3. The Contractor shall, in accordance with the Act and applicable Regulations, make all the necessary appointments of competent persons in writing on a form similar to Annexure 2 of this Specification and deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager. Copies should also be retained on the health and safety file.
- 3.1 Subcontractors shall also make the above written appointments and the Contractor shall deliver copies thereof to the Procurement Manager / SHEQ Manager / Technical Manager.
- 3.2 In the case of a self-employed Contractor or any subcontractor who has the appropriate competencies and supervises the work himself, the appointment of a construction supervisor in terms of regulation 6.1 of the Construction Regulations, 2003 will not be necessary. The Contractor shall in such a case execute and sign a declaration, as in Annexure 3, by which he personally undertakes the duties and obligations of the "Chief Executive Officer" in terms of section 16(1) of the Act.
- 3.3 The Contractor shall, before commencing any work, obtain from the Procurement Manager / SHEQ Manager / Technical Manager an access certificate as in Annexure 4 executed and signed by him, permitting and limiting access to the designated site or place of work by the Contractor and any subcontractors under his control.
- 3.4 Procedural compliance with Act and Regulations, as above, shall also apply to any subcontractors as employers in their own right. The Contractor shall furnish the Procurement Manager / SHEQ Manager / Technical Manager with full particulars of such subcontractors and shall ensure that they comply with the Act and Regulations and safety requirements and procedures.

#### 4. **Special Permits**

Where special permits are required before work may be carried out such as for hot work, isolation permits, work permits and occupations, the Contractor shall apply to the Procurement Manager / SHEQ Manager / Technical Manager or the relevant authority for such permits to be issued. The Contractor shall strictly comply with the conditions and requirements pertaining to the issue of such permits.

#### 5. **Health and Safety Programme**

- 5.1 The Tenderer shall, with his tender, submit a Health and Safety Programme setting out the practical arrangements and procedures to be implemented by him to ensure compliance by him with the Act and Regulations and particularly in respect of: -
- (i) The provision, as far as is reasonably practical, of a working environment that is safe and without risk to the health of his employees and subcontractors in terms of section 8 of the Act;

- (ii) the execution of the contract work in such a manner as to ensure in terms of section 9 of the Act that persons other than those in the Contractor's employment, who may be directly affected by the contract work are not thereby exposed to hazards to their health and safety;
  - (iv) ensuring, as far as is reasonably practical, in terms of section 37 of the Act that no employee or subcontractor of the Contractor does or omits to do any act which would be an offence for the Contractor to do or omit to do.
- 5.2 The Contractor's Health and Safety Programme shall be based on a risk assessment in respect of the hazards to health and safety of his employees and other persons under his control that are associated with or directly affected by the Contractor's activities in performing the contract work and shall establish precautionary measures as are reasonable and practical in protecting the safety and health of such employees and persons.
- 5.3 The Contractor shall cause a risk assessment contemplated in clause 5.2 above to be performed by a competent person, appointed in writing, before commencement of any **Construction Work** and reviewed during construction. The Risk Assessments shall form part of the Health and Safety programme to be applied on the site and shall include at least the following:
- The identification of the risks and hazards that persons may be exposed to;
  - the analysis and evaluation of the hazards identified;
  - a documented Health and Safety Plan, including safe work procedures to mitigate, reduce or control the risks identified;
  - a monitoring and review plan.
- 5.4 The Health and Safety Plan shall include full particulars in respect of: -
- The safety management structure to be instituted on site or place of work and the names of the Contractor's health and safety representatives and members of safety committees where applicable;
  - the safe working methods and procedures to be implemented to ensure the work is performed in compliance with the Act and Regulations;
  - the safety equipment, devices and clothing to be made available by the Contractor to his employees;
  - the site access control measures pertaining to health and safety to be implemented;
  - The introduction of control measures for ensuring that the Safety Plan is maintained and monitored for the duration of the Contract.
- 5.5 The Health and Safety programme shall be subject to the Procurement Manager / SHEQ Manager / Technical Manager's approval and he may, in consultation with the Contractor, order that additional and/or supplementary practical arrangements and procedures be implemented and maintained by the Contractor or that different working methods or safety equipment be used or safety clothes be issued which, in the Procurement Manager / SHEQ Manager / Technical Manager's opinion, are necessary to ensure full compliance by the Contractor with his obligations as an employer in terms

of the Act and Regulations. The Procurement Manager / SHEQ Manager / Technical Manager or his deputy shall be allowed to attend meetings of the Contractor's safety committee as an observer.

- 5.6 The Contractor shall take reasonable steps to ensure that each subcontractor's Health and Safety Plan is implemented and maintained on the construction site: Provided that the steps taken shall include periodic audits at intervals mutually agreed to between the them, but at least once every month.
- 5.7 The Contractor shall stop any subcontractor from executing any construction work, which is not in accordance with the Contractor's, and/or subcontractor's Health and Safety Plan for the site or which poses a threat to the health and safety of persons.
- 5.8 The Contractor shall ensure that a copy of the Health and Safety Plan is available on site for inspection by an inspector, Procurement Manager / SHEQ Manager / Technical Manager, agent, subcontractor, employee, registered employee organization, health and safety representative or any member of the health and safety committee.
- 5.9 The Contractor shall consult with the health and safety committee or, if no health and safety committee exists, with a representative group of employees, on the development, monitoring and review of the Risk Assessment.
- 5.10 The Contractor shall ensure that all employees under his control are informed, instructed and trained by a competent person regarding any hazard and the related work procedures before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.11 The Contractor shall ensure that all subcontractors are informed regarding any hazard as stipulated in the Risk Assessment before any work commences, and thereafter at such times as may be determined in the Risk Assessment.
- 5.12 The Contractor shall ensure that all visitors to a construction site undergoes health and safety induction pertaining to the hazards prevalent on the site and shall be provided with the necessary personal protective equipment.

## **6. Fall Protection Plan**

- 6.1 In the event of the risk and hazard identification, as required in terms of clause 5.3 of this Specification, revealing risks relating to working from an elevated position the contractor shall cause the designation of a competent person, responsible for the preparation of a fall protection plan;
- 6.2 The Contractor shall implement, maintain and monitor the fall protection plan for the duration of Contract. The Contractor shall also take such steps to ensure the continued adherence to the fall protection plan.
- 6.3 The fall protection plan shall include: -
  - A Risk Assessment of all work carried out from an elevated position;
  - The procedures and methods to address all the identified risks per location;

- The evaluation of the employees' physical and psychological fitness necessary to work at elevated positions;
- The training of employees working from elevated positions; and
- The procedure addressing the inspection, testing and maintenance of all fall protection equipment.

## 7. Hazards and Potential Hazardous Situations

The Contractor and the Procurement Manager / SHEQ Manager / Technical Manager shall immediately notify one another of any hazardous or potentially hazardous situations which may arise during performance of the Contract by the Contractor or any subcontractor and, in particular, of such hazards as may be caused by the design, execution and/or location and any other aspect pertaining to the contract work.

## 8. Health and Safety File

- 8.1 The Contractor shall ensure that a health and safety file is opened and kept on site and shall include all documentation required as per the Act and applicable regulations, and made available to an inspector, the Procurement Manager / SHEQ Manager / Technical Manager, or subcontractor upon request.
- 8.2 The Contractor shall ensure that a copy of the both his Health and Safety Plan as well as any subcontractor's Health and Safety Plan is available on request to an employee, inspector, contractor or the Procurement Manager / SHEQ Manager / Technical Manager.
- 8.3 The Contractor shall hand over a consolidated health and safety file to the Procurement Manager / SHEQ Manager / Technical Manager upon completion of the **Works** and shall in addition to documentation mentioned in the Act and applicable Regulations include a record of all drawings, designs, materials used and other similar information concerning the completed structure.

### HSE philosophy

Inherent safety and protection of the environment is a prerequisite from the beginning of the design process. The HSE philosophy must be included in the design premise document, and should include considerations on waste reduction, minimisation of fugitive emissions, ground water pollution prevention, minimisation of manning levels for hazardous processes, hazardous materials handling, early detection systems and specific measures to reduce risks to ALARP levels.

### Hazard identification study

A systematic evaluation of all hazards shall be performed in the hazard study. The hazard study is the basis for the area classification drawings and may alter the location of for example buildings, process units on the plot plan or may lead to additional preventive measures (firewalls, other material types etc) being required.
