1. INTRODUCTION AND PURPOSE

Food safety and prevention of communicable diseases are KPI's of Municipal Health Services (MHS). The storage, production and serving of food and foodstuffs always involve a risk due to the possibility of bacteriological and chemical contamination. An annual sampling program for food and water is followed for all seven regions of Municipal Health Services in the City of Tshwane.

In addition to the sampling program, the certification of premises in terms of the City of Tshwane Health Bylaws for Childcare Services and Homes for the elderly as well as the need for calculation of area for the certification of the private learning institutions requires the department to provide Environmental Health Practitioners with the correct tools of trade to effectively render an efficient service to the residents of the city

2. BACKGROUND

SAMPLING

Proactive food sampling by MHS assists in monitoring the safety and standard of food for sale to and subsequent consumption by the public and thus help to prevent the spread of food borne disease as part of a strategy for improving the quality of life of our community. Food sampling therefore, forms an integral part of law enforcement in City of Tshwane and can provide useful information to help effective enforcement of the Foodstuffs, Cosmetics and Disinfectants Act, Act 54 of 1972.

The same principle applies to water sampling, where early detection and investigation of water contamination forms an integral part of effective disease surveillance and the implementation of control measures. Some sampling is undertaken on a reactive basis in order to determine the causative agents of food or water related incidents.

The objectives of the sampling program of the Municipal Health Services Section in the City of Tshwane is to:

- prevent any food borne diseases
- ensure safe and healthy food supply
- ensure safe and healthy production of food
- preventing waterborne diseases
- monitoring of water for potable use
- monitoring of rivers and streams
- preventing communicable disease, such as Vibrio Cholera
- analysis of cases of notifiable medical conditions such as food poisoning and related incidences

CERTIFICATION OF PREMISES-MEASURING WHEELS

According to section 24 of the Constitution of the Republic of South Africa as amended, everyone has the right to an environment that is not harmful to their health and well-being. Chapter seven of the Constitution also states clearly as one of the objects of the Local Government: “to promote a safe and healthy environment”.

.In order to achieve same, the health department must ensure that adequate space is provided at premises that are used for the care and education of residents and that certification of these premises is conducted in a manner that ensures such safety. Therefore the procurement of digital measuring wheels will help in assuring that this responsibility is fully discharged with.

This quotation will benefit the City of Tshwane in ensuring a safe and healthy environment through adequate provision of spaces that are used for the care of children, the elderly and for educating learners and students.

- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- (l) **“non-firm prices”** means all prices other than “firm” prices;
- (m) **“person”** includes a juristic person;
- (n) **“QSE”** means a Qualifying Small Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- (s) **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration

P_{min} = Comparative price of lowest acceptable bid

5. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 A bidder who qualifies as an EME in terms of the B-BBEE Act must submit a sworn affidavit confirming Annual Total Revenue and Level of Black Ownership.
- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating

issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
