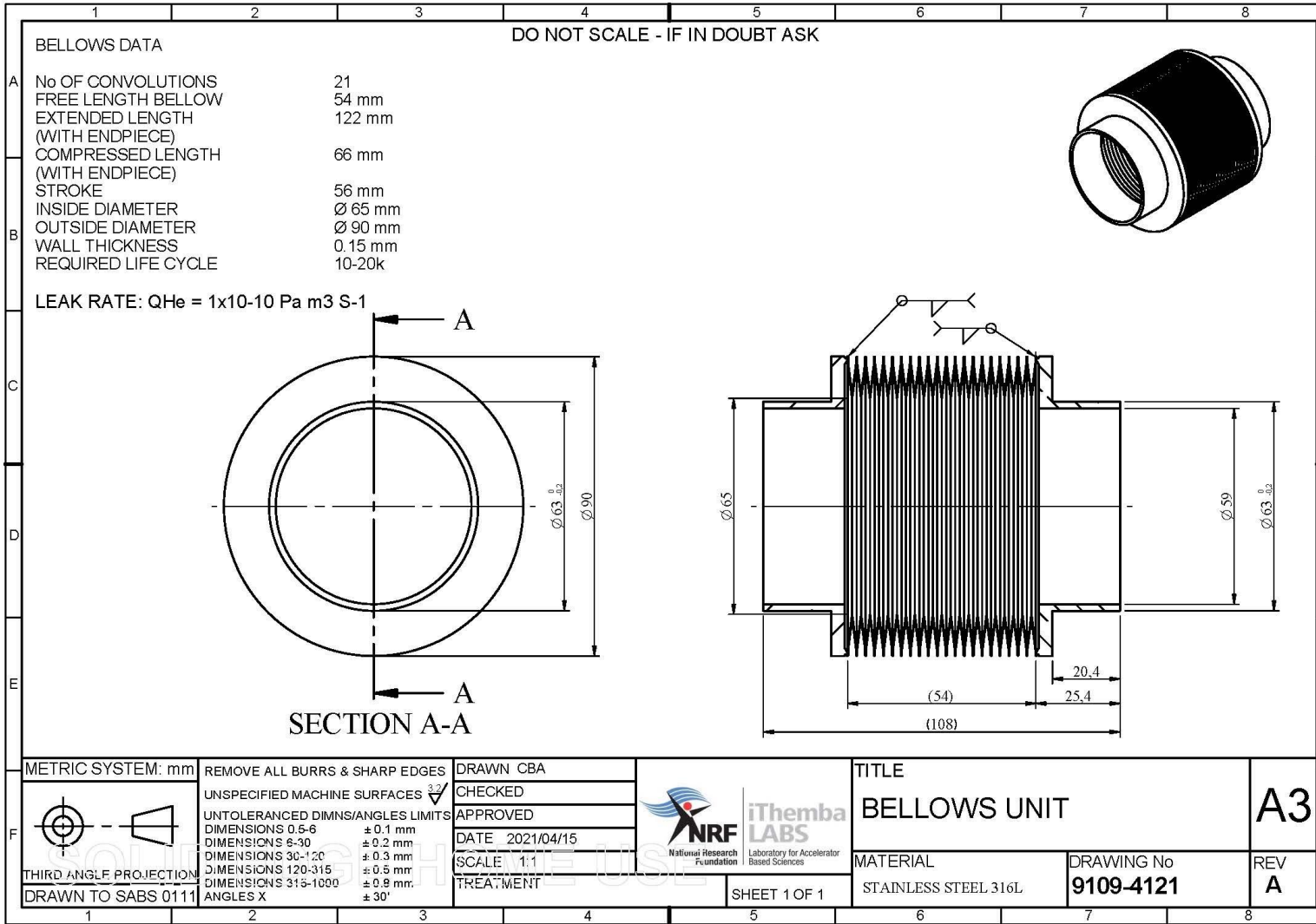




Figure 1: Typical image of Metal Bellows Assemblies

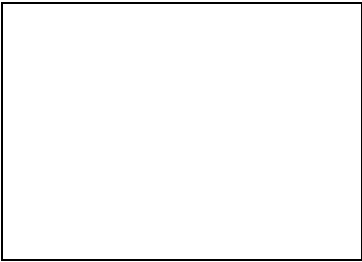
