C1.1 Employer's Objectives

The objective of the Employer is to appoint services of a suitably qualified and registered Structural Engineer to conduct a comprehensive conditional assessment of the building, including the flooring at the Johannesburg Water Head Office, located at the Turbine Hall Building. The precinct has two building that is Turbine Hall and Turbine Square both buildings have three Storeys each. Size of both buildings is 24 326 m².

C1.2 Description of services

Standard professional services as per the Guideline Scope of Services rendered by persons registered in the relevant Built Environment Councils – Engineering Council of South Africa for Engineers Professions (ECSA).

C1.3 Extent of the Services

1.3.1 Scope of Works

The Johannesburg Water Head Office, located at the Turbine Hall building, has been experiencing excessive structural vibrations which has raised safety concerns to the occupants. In order to ensure safety, structural integrity, and compliance with applicable building standards, Johannesburg Water requires a qualified Structural Engineer to conduct a comprehensive conditional assessment of the building.

The appointed Structural Engineer will be required to:

- Undertake a detailed structural conditional assessment of the entire Turbine Hall building.
- Provide an opinion regarding the integrity of the building.
- Assess and evaluate the building's structural integrity, with specific attention to the reported excessive floor vibrations.
- Conduct assessment to all flooring systems and supporting structures.
- Identify any risks, defects, weaknesses, or areas of concern that may compromise the safety and functionality of the building.
- Provide recommendations on remedial works to reinstate the overall structural integrity of the building.
- Provide cost estimate for the proposed remedial works.
- Provide an opinion as to whether the building is currently unsafe to be used in its present condition,
- Compile and submit a detailed technical report with findings and recommendations to the Executives of Johannesburg Water.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
