1. PURPOSE

The Kwazulu-Natal Growth Fund Agency (KZNGFA) invites quotations from suitably qualified service providers for support and maintenance of the KZNGFA web portal for a period of 12 months.

2. BACKGROUND

Kwazulu-Natal Growth Fund Agency (KZNGFA) is an Agency, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KZNGFA is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KZNGFA, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KZNGFA Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KZNGFA.

The KZNGFA wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED

3.1 Background

KZNGFA has developed a public-facing web portal designed to facilitate the submission of funding applications online. The system is currently on staging undergoing a parallel run and is scheduled to transition to full online operations in January 2025. However, there is presently no support and maintenance contract in place to ensure the system's continued functionality and effectiveness once it goes live. The technology stack at which the system is built is as follows:

- Backend: ASP.NET Core
- Database: Microsoft SQL Server
- Frontend Framework: AngularJS
- Email Broadcast & Communication Platform with unlimited emails and One-Time Pins

3.2 Provision of the dedicated web server

The service provider is expected provision and maintain a dedicated web server where the system will be hosted. The server must meet the following minimum requirements:

- Processor (CPU): Quad-core processor, e.g. Intel Xeon E3 or AMD Ryzen 5.
- Memory (RAM): 64 GB for high traffic.
- Storage: 1TB SSD for faster read/write speeds
- Bandwidth: 1 Gbps connection for high traffic handling.
- Traffic: unlimited
- Hardware: RAID, Hotswap SSD & PSU, Dual Power Supply

3.3 Data Migration

The service provider is expected to migrate the system data, source code and databases from the staging server to the live dedicated server as envisaged in Section 3.2 above

- Plan and prepare data migration
- Perform full data back-up before migration and test the restore process
- Develop a rollback plan in case of failure
- Perform data cleansing to correct any data inconsistencies and duplications
- Plan and schedule downtime where necessary
- Export data from staging server and import data into the live server
- Test and validate data to ensure functionality

- Implement a rollback plan in case of critical issues during or after migration

3.4 Support and maintenance for 12 months

3.4.1. Web portal support and maintenance

- Regularly assess portal performance (e.g. page load times, responsiveness).
- Identify and fix bugs or glitches in the portal.
- Apply software patches and updates
- Regular vulnerability scans and penetration testing.
- Update and patch application vulnerabilities
- Implement a Web Application Firewall (WAF) to protect against any cyber threats.
- Schedule regular backups of application code, databases and user data.
- Ensure restore procedures are tested for reliability in disaster recovery.
- Optimise code and database queries to handle growing user traffic.
- Plan and implement scaling strategies
- Provide helpdesk support for end-users (e.g. issue tracking and resolution).
- Document and address common user issues (FAQs, ticketing systems).

3.4.2. Dedicated web server support and maintenance

- Monitor uptime, CPU usage, memory, disk space and network traffic.
- Update the operating system and server software
- Patch security vulnerabilities promptly.
- Configure firewalls and intrusion detection/prevention systems
- Regularly update and renew SSL/TLS certificates for secure HTTPS communication.
- Conduct server hardening (e.g. disable unused ports and services, implement SSH key authentication).
- Implement server-side backups (e.g. weekly full backups, daily incremental backups).
- Test server recovery processes to minimise downtime during failures.
- Monitor server hardware (e.g. disk health, temperature, power supply).
- Replace or upgrade failing components proactively.
- Configure load balancers for high-traffic scenarios.
- Optimise server configurations (e.g. adjust thread and memory limits).

3.4.3. Communication and Reporting

- Provide monthly and quarterly performance reports (e.g. uptime, traffic, security incidents).
- Regularly update stakeholders on new features, updates or issues.

4. CONTRACT DURATION

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$\begin{array}{ccc} \mathbf{80/20} & \mathbf{or} & \mathbf{90/10} \\ \mathbf{Ps} = \mathbf{80} \left(\mathbf{1} - \frac{\mathbf{Pt} - \mathbf{Pmin}}{\mathbf{Pmin}} \right) & \mathbf{or} & \mathbf{Ps} = \mathbf{90} \left(\mathbf{1} - \frac{\mathbf{Pt} - \mathbf{Pmin}}{\mathbf{Pmin}} \right) \end{array}$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

$$\begin{array}{ccc} \mathbf{80/20} & \mathbf{or} & \mathbf{90/10} \\ \mathbf{Ps} = \mathbf{80} \left(\mathbf{1} + \frac{\mathbf{Pt} - \mathbf{Pmax}}{\mathbf{Pmax}} \right) & \mathbf{or} & \mathbf{Ps} = \mathbf{90} \left(\mathbf{1} + \frac{\mathbf{Pt} - \mathbf{Pmax}}{\mathbf{Pmax}} \right) \end{array}$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

Table 1: Specific goals for the tender and points claimed are indicated per the table below.

(Note to organs of state: Where either the 90/10 or 80/20 preference point system is applicable, corresponding points must also be indicated as such.)

Note to tenderers: The tenderer must indicate how they claim points for each preference point system.)

 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
