Further note, it is prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database to be registered, registration can be done online via www.csd.gov.za **Further that Local Content and Production will form part of the evaluation and therefore all potential bidders who fail to meet the minimum threshold for local content will not be considered for award.**
