1 PURPOSE

- 1.1. The Department of Transport would like to invite bid proposals to render technical services for a project to develop the criteria for registering a scheme with a Certification Body responsible for certifying persons (management system auditors/inspectors) against the following South African National Standards – SANS 55000 & SANS 1393 and the services are estimated for a period of 24 months. The project involves building capacity through skills transfer sessions to Departmental staff and conducting provincial workshops to key stakeholders.
- 1.2. This objective of this project is:
- 1.2.1. to create an awareness and understanding the need / importance of implementing:
- Asset Management Systems (SANS 55000) by the Roads Authorities in line with the TMH22 COTO Technical Manual
 - Construction Management System (SANS 1393) by the suppliers within the Road Construction & Maintenance Industry as envisaged in Government Gazette Number 39101.
- 1.2.2. to develop and improve inspection, monitoring, evaluation and reporting capacity/knowledge/skills within the Roads Branch, and Roads Authorities in general, through a structured skill transfer process for officials to develop an awareness and on understanding the application / implementation of the above-mentioned South African National Standards.

Note

- i) A prospective service provider must provide proof that a team with the relevant professional and diverse skills has been assembled for this project (refer Section 3.2.3) and a Bidder should demonstrate that members of this project team have been accordingly assigned to cover all tasks (*i.e. project team has appropriate experience and the resources are allocated to execute all tasks to be undertaken*).
- ii) Bids should preferably be in the form of a Consortium or Joint Venture that is representative of black ownership, women ownership, youth ownership and people with disabilities ownership.
- iii) All prospective Bidders are required to familiarise themselves with the various applicable legislation, policies, Standards and technical manuals, etc. These are to be read with the terms of reference, as it will help a prospective Bidder to understand and prepare the Bid Proposal.
- iv) Due to consequential circumstances of the Covid-19 pandemic, the bidder needs to factor all the necessary regulations and health and safety requirements in their Bid Proposal.

2 BACKGROUND

- 2.1 The road network forms the backbone of development in any economy. In South Africa however, the planning and development methodologies of the previous dispensation have deprived a large portion of the population of this country of basic transport infrastructure, leading to a lack of access and mobility and making transport unaffordable for them. It is thus important for transformation in the road infrastructure not to focus purely on technocratic road needs. Instead, it should be broad and comprehensive in assessing the demands placed on our road network (i.e. economic, social and environmental demands), which if addressed will contribute to the realization of key national policy priority areas that seek to redress the imbalances of the past and support economic growth.
- 2.2 The S'hamba Sonke Programme (SSP) is an initiative of the National Department of Transport to develop and maintain South Africa's secondary road network while at the same time placing the rural economy on a labour absorptive growth path. Some of the key focus areas are:
- The maintenance of critical rural arterial routes;
 - Cost-efficient use of labour absorptive methodologies in roadworks;
 - **Implementation of an Asset Management Systems as a tool to support investment decisions for road infrastructure;**
 - Improving Access to Schools and Clinics;
 - Delivering a Safe Road environment; and
 - **Contractor development and localization.**
- 2.3 The SABS adopted the Asset Management System (ISO55000), which was developed by the International Organization for Standardisation (ISO) and published it as SANS 55000.
- 2.4 This National Standard (SANS 55000) supports compliance to requirements of the Government Immovable Asset Management Act (GIAMA - Act 17 of 2007), which is applicable to a range of Government Infrastructure Departments / organizations, such as Road Authorities, Public Works, Health, Educations, etc. In essence, SANS 55000 is a standard covering management of physical assets owned by Government. The standard was split into two parts:

- 2.5.1 Part 1 - Specification for the optimized management of physical infrastructure assets; and
- 2.5.2 Part 2 - Guidelines for the application.

- 2.5 The Technical Methods for Highways (TMH) consists of a series of publication, used to either prescribe or to provide guidelines on various aspects relating to highway engineering. The documents are primarily aimed at ensuring uniformity throughout South Africa.

- 2.6 The TMH22 manual provides a template, guidance and methodologies on the manner in which road infrastructure assets should be managed. It establishes a uniform and integrated system on which the asset conditions are collected and reported on, to ensure an equitable funding distribution, so that the maintenance and rehabilitation of the road infrastructure is ensured.

- 2.7 TMH 22 manual covers the following aspects: -
 - 2.7.1 The benefit to the roads authority relating to asset management;
 - 2.7.2 A brief description of the policies and requirements of the Road Authority in terms of current legislation;
 - 2.7.3 The various levels of asset management and the minimum levels required;
 - 2.7.4 Processes and methodologies for higher levels or more advanced asset management;
 - 2.7.5 Guidance for the implementation of the Road Asset Management System;
 - 2.7.6 Guidance for the development of inventory data and asset valuations;
 - 2.7.7 Requirements for the collection of usage and condition data and time intervals thereof; and
 - 2.7.8 Methodologies for the reporting on the condition of the assets;

- 2.8 Methodologies for the determination of the maintenance and rehabilitation requirements of the road network; and Identification for the ongoing improvement of the road authorities' Asset Management System.

- 2.9 In summary, TMH22 manual provides the background and the template for Road Authorities to implement and sustain efficient Asset Management Systems to ensure the road network performs at the required minimum level of service.

2.10 The SANS 1393 (Construction Management Systems):

2.10.1 was specifically developed for the construction industry in its broadest terms, and this uniquely South African Standard can be implemented by all companies within the construction industry including upstream value chain providers with a pragmatic and explicit focus on the effective and efficient use of construction resources;

2.10.2 sets performance measures against time, cost, quality, site management and the management of health and safety;

2.10.3 scheme is aimed at supporting contractor performance improvement as well as risk management in the construction industry; and

2.10.4 establishes minimum acceptable standards that are necessary for running a contracting company and for supervising building and construction works. It will lay the foundation for clients to better assess the capabilities and performance of contractors in a uniform and consistent manner.

2.11 As part of the implementation process of these standards, it is necessary for the Department to provide leadership, direction and support to the roads industry and other stakeholders that can adopt these standards into their business operations and implement these national standards in a uniform way.

2.12 Standards can be used by organisations as a key risk instrument to improve compliance, efficiency, address safety and meet customer requirements.

2.13 Of particular importance is to note that:

2.13.1 The ISO standard 'ISO 55000 Asset Management' was published in January 2014.

2.13.2 This new standard provides a fresh focus upon the purpose and application of asset management within organisations.

2.13.3 The significant interest in the standard shown by asset owners, regulators and certification bodies reflects a universal business desire to improve the value returned to organisations, through the effective management of physical assets.

2.13.4 To realise that benefit, organizations (Road Authorities) require knowledgeable people capable of applying an asset management certification process who, at the same time, can use that process to provide the value that business desires.

2.14 The long-term purposes include:

2.14.1 To establish the minimum knowledge and comprehension of asset management to perform duties as an assessor for ISO 550001 and the GFMAM.

2.14.2 To provide guidance for organizations providing training in preparing for ISO55001 adoption and evaluation.

2.14.3 To provide the basis for certification of ISO 55001 assessor/auditor personnel

2.14.4 To support the introduction of ISO55000, and ensure that organisations derive benefit from the use of these standards.

2.15 SUMMARY OF THE MANDATE OF THE DEPARTMENT OF TRANSPORT FUNCTIONS (SPECIFICALLY THE BRANCH: ROAD TRANSPORT) WITH REGARDS TO PROJECT PLANNING, IMPLEMENTATION, MONITORING, EVALUATION, AND REPORTING

2.15.1 The Department of Transport develops, provides and is responsible for:

2.15.1.1 Policy, advice, programs, legislation and regulation across a wide range of areas, including infrastructure planning and coordination, transport safety, land, air, maritime transport security (including shipping) and major projects facilitation;

2.15.1.2 Country wide monitoring, evaluation and reporting for the roads sector;

2.15.1.3 Norms, guidelines and standards and/or;

2.15.1.4 Provision of information systems.

2.15.2 There are responsibilities assigned to the Department emanating from the South African Constitution outlining how the National Sphere of Government should support Provinces and Municipalities e.g.:

2.15.2.1 Section 154 (1) "the national government must support and strengthen the capacity of municipalities to manage their own affairs"; and

2.15.2.2 Section 155(7) "Executive Authority to see to the effective performance by municipalities of their functions".

2.15.3 There are responsibilities for National Governments emanating from the provisions in the Divisional of Revenue Act (DORA), which imposes legal responsibilities onto Transferring Officers and National Sector Departments.

TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER FOR TECHNICAL RELATED SERVICES, WITH REGARDS, SANS1393 and SANS55000.

- 2.15.4 The Department is the Transferring Officer of the Provincial Road Maintenance Grant (PRMG).
- 2.15.5 Conditions of the Municipal Infrastructure Grant (MIG) requires the Department of Transport to *"support municipalities with planning and implementation of municipal roads and monitor municipalities' performance and compliance with conditions applicable to this sector" and "each national sector department will be expected to fulfil a monitoring role on the relevant sector outputs in collaboration with provinces and districts municipalities"*.
- 2.15.6 The grant conditions of the Urban Settlement Development Grant (USDG) and the Human Settlements Development Grant (HSDG) require the Department of Transport to provide support to the Human Settlements Department to "Facilitate strategic and spatial planning support related to human settlements development".
- 2.15.7 The Road Transport Branch as a Programme, exists to develop and manage an integrated road infrastructure network, regulate road transport to ensure safer roads and provide oversight, monitor, evaluate and report on the implementation of road projects by authorities.
- 2.15.8 Implementation of road construction and maintenance projects takes place through SANRAL, provinces & municipalities. National Government (Treasury) provides the funding, except in the case of SANRAL that has powers to also raise additional funds or enter into Concession Agreements in terms of the founding legislation of SANRAL and in the case of Provinces/Municipalities that can also set aside budgets from its own revenue.
- 2.15.9 In summary, one of the key responsibilities of the Road Transport Branch involves reviewing, monitoring and evaluation of monthly data, including validations and submission of monthly, quarterly and annual reports. Projects are inspected based on risk profiling and on need basis. Flagship projects are required to be profiled and further evaluated to determine their impacts and outcomes.

- 2.15.10 The Department has to continually assess the impact / outcome of road programmes / projects being implemented (*country-wide*) in order to demonstrate best practices, showcase job creation and the development of Small, Micro, and Medium-sized Enterprises (SMME) and Cooperatives.
- 2.15.11 Within the Roads Branch, the Chief-Directorate: Road Infrastructure and Industry Development has among its core activities the responsibility for planning or developing, implementing & supporting industry development and transformation programmes for the Road Construction & Maintenance Industry.
- 2.15.12 The Road Construction Industry is a key vehicle for Development and Transformation requires to be exploited to realise the following objectives:
- 2.15.12.1 Increasing emerging sector participation;
 - 2.15.12.2 Meeting socio-economic objectives;
 - 2.15.12.3 Balancing delivery empowerment;
 - 2.15.12.4 Sustained growth of contractors; and
 - 2.15.12.5 Transforming the industry to maximize participation of Women, Youth and Black Owned Businesses.
- 2.15.13 One the is a desires of the Maximising Job Creation through Labour Intensive Road Construction and Maintenance Methods in line with the SSP is to achieve / support transformation and industry development objectives by considering the following:
- 2.15.13.1 That the level of Maximising Job Creation for a specific project becomes a design parameter where the designer carefully considers the socio-economic environment, the engineering parameters and the associated maintenance strategy for the project. In addition, the relation between construction time, specified quality and construction cost need to be evaluated;
 - 2.15.13.2 The need for providing employment opportunities and distribution of income through injecting some project funds into the local economy in the form of wages to local poor and unemployed people;

TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER FOR TECHNICAL RELATED SERVICES, WITH REGARDS, SANS1393 and SANS55000.

- 2.15.13.3 The need to implement the “Contractor Household Programme” i.e. use of local labour for road construction and maintenance projects from poor communities as a method to address poverty and unemployment;
- 2.15.13.4 The need to support Small Micro Medium Entrepreneur (SMME) and Cooperate development as was approved by the Cabinet in 2016;
- 2.15.13.5 The need for providing training or skills development to locally employed workers;
- 2.15.13.6 The need for the development of labor-intensive capacity in the construction industry;
- 2.15.13.7 The need for ensuring the projects are designed and packaged to promote the participation of small to medium sized contractors;
- 2.15.13.8 The need to consider the Scope of Work (stage and extent) in conjunction with the socio-economic environment where the project is being carried out will be the main drivers determining the labor-intensive of the project; and
- 2.15.13.9 The need for promoting use of local material and alternative labour-based technologies.

3 SCOPE OF WORK

The following services are required:

- 3.1 Development of the criteria for auditor competency requirements and schemes for SANS1393 and the SANS 55000 in accordance with ISO 19011, ISO 17021 and ISO 17024 (SANAS and IAF regulations / requirements) for registration of these schemes with a Management Systems Certification Body that is accredited by SANAS or a similar recognised Organisation.
- 3.2 Capacitating a team from the Roads Branch - putting at least (18) staff through an integrated skill transfer programme to cover:
 - a. Awareness and understanding the following Legislation - the National Road Traffic Act, the Government Immovable Asset Management Systems Act, the Occupational Health and Safety Act, the National Environmental Management Act; Construction Industry Development Board Act,
 - b. Conformity Assessments;

TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER FOR TECHNICAL RELATED SERVICES, WITH REGARDS, SANS1393 and SANS55000.

- c. Standards Writing;
 - d. Introduction, awareness and understanding of the Quality, Health, Environmental, Safety, Construction Management and Asset Management System Standards.
 - e. Management System Auditing (Lead Auditor Training) for SANS 1393 and SANS 55000 in accordance with ISO 19011, ISO 17021 and ISO 17024 (SANAS and IAF regulations) and Writing Technical Audit Reports; and
 - f. the TMH22 COTO Manual and the GFMAM Competency Specification for an ISO 55001 Asset Management System Auditor/Assessor Manual; and
 - g. a capacitation programme for at least 5 members of the team to be put through to programme to develop competency as SANAS approved Technical Assessors.
- 3.3 Conduct provincial workshops for the Road Authorities on SANS 55000 and SANS 1393 and on the SANS 1393 specifically targeting the CIDB Grade 4s and above.
- 3.4 Note (i) the Service Provider must provide details of the capacity building program and on how skills transfer will be incorporated throughout the phases of the project. It envisaged that some key individuals identified may be allowed to spend some time in the offices of the Service Provider and/or on projects to obtain some practical experience. The timing and duration will be agreed between parties during the finalisation of the Inception Report.
- 3.5 Note (ii) the Service Provider must provide consider the Health and Safety requirements / regulations, with regards, the Covid 19 Pandemic when it comes to conducting the skills transfer sessions and workshops. A blended approach will be acceptable i.e. have physical and virtual sessions.
- 3.6 Note (iii) The Service Provider must procure and supply the necessary standards / training material to be used by the staff for the skills transfer programme.
- 3.7 The service provider is expected, but not limited to:
- 3.7.1 Conduct a basic review of the existing / applicable local and/or international best practices in place for the criteria for certifying inspectors/auditors and training requirements to capacitate auditors for auditing companies against SA National Standards - SANS 1393, SANS 55000 and other relevant standards or similar.

- 3.7.2 Engaging with SANAS and Certification Bodies wherein the Certification Schemes can be registered.
- 3.7.3 Developing the Certification Schemes that shall be tabled for registration at the identified and/or interested / appropriate Accreditation Body and Certification Body.
- 3.8 The project requires stakeholder consultation and liaison with industry experts, SABS, SANAS, the Construction Industry Development Board (CIDB), National Regulator for Compulsory Specifications (NRCS) and the relevant Certification Bodies. The stakeholder interaction programme forms a critical component of the project.
- 3.9 It is required that at the end of the project a Closeout Report is submitted with a detailed audit trail outlining the processes and procedures followed for the entire project with recommendations. The key project deliverables to be covered in the Closeout Report as well as the annexures to the main report should include the following:
 - 3.9.1 Summary of Literature review; and
 - 3.9.2 Stakeholder consultation and liaison report as an annexure to the main report with an analysis and feedback on how the comments were dealt with. The objective of the stakeholder consultation and liaison memorandum is to:
 - a. Ensure stakeholder participation and support for the project;
 - b. Provide feedback regarding the unfolding of the stakeholder consultation and liaison process;
 - c. Identify any setbacks that might have been encountered during the consultation process;
 - d. Put forth recommendations for overcoming the delays that might have been encountered;
 - 3.9.3 An Annexure to the main report (project closeout report) shall include the minutes, agenda and attendance registers and the Workshop material / presentations at the provincial workshops.
- 3.10 In addition to the above, there are other works (throughout the project) will include the following amount others:
 - 3.10.1 Power Point presentations and ongoing discussions with the Project Team.

- 3.10.2 Preparation of draft documents and circulation for comments, inputs for reviewing and updating purposes.
- 3.10.3 Recording and keeping minutes for all meetings held and copies of all correspondence received during the entire process from stakeholders in a document titled “comments register”.
- 3.10.4 Development, preparation and distribution of an electronic version – both in MS Word or other as well as a PDF format to the DOT.
- 3.10.5 Preparation of workshop material to be used during capacitation / information sessions for the Departmental staff and with the relevant stakeholder’s e.g. Provincial officials, industry, etc.
- 3.10.6 Facilitation and Presentation at provincial workshops for relevant stakeholders.
- 3.10.7 Note, whenever reports are sent to or due by the DoT, two bound hard copies shall be required at all times as well as electronic copy (PDF version).

- 4.2 Upon signature of the Contract the DDG: Road Transport shall introduce his team at an Inception Meeting with the successful Service Provider. This date is regarded as the official date of commencement of the contract. The Service Provider must immediately begin with assessing the team and the existing method of work operations to get an understanding of the internal needs. The first key deliverable within 14 days of accepting and signing the Contract is for the Service Provider to provide the Department with the Project Inception Report, which shall include:

- 4.2.1 that there is alignment between the Departmental Project Team and the Consulting Team's understanding in terms of the overall project objectives, scope of work, the deliverables and the timeframes;
- 4.2.2 the finalisation of the project activity schedule (*this shall include a detailed project plan, the key project milestones and the budget (expenditure) forecast*);
- 4.2.3 the finalisation of the skills transfer programme to DOT staff (i.e. agreement of the capacity building program and on how skills transfer will be incorporated throughout the phases of the project)
- 4.3 The next key deliverable is the report on the criteria for developing and registering the Schemes:
 - 4.3.1 The process involves literature review, consultations, development of draft schemes, review and analysis of the draft schemes before submission for registration of the Schemes with the Certification Body;
 - 4.3.2 There must be a report must be accompanied by proof of submission for registration of the schemes with the Certification Body.
- 4.4 Another key deliverable is a report about the skills transfer sessions, with evidence of the skills transfer sessions;
- 4.5 Another deliverable is the workshop material and a report with evidence of all the provincial workshops conducted.
- 4.6 The service provider is required to compile a report on comments and inputs received and analyse the information and inputs from all the industry stakeholders during stakeholder interaction. It is envisaged that consultation with the relevant road authorities should be through members of the Roads Coordination Body, which sits quarterly. It is likely that a special sitting of the body would be required to align with the timing of this project.
- 4.7 The final deliverable is a Project Closure Report at the end of the project. The service provider will be expected to prepare and submit the Project Closure Report with a detailed audit trail outlining the processes and procedures followed for the entire project, including all supporting annexures / sub-reports.
- 4.8 It is against this backdrop, that development of a criteria for registering a scheme with a certification body for certifying inspectors against South African National

Standards, SANS 55000 and SANS 1393 respectively, building capacity and conducting provincial workshops on SANS1393 and SANS 55000 is needed.

4.9 Based on the above, the Service Providers have to demonstrate that Individual Team members have experience or expert knowledge in:

4.9.1 SABS Standards

4.9.2 Standards writing and conformity assessments;

4.9.3 Legal Knowledge to be able to present (conduct skills transfer) on the relevant acts as cited in Section 3.2.3

4.9.4 Road Asset Management Manual (THM22);

4.9.5 Construction Industry;

4.9.6 Stakeholder workshops;

4.9.7 Developing Training manuals for Management Systems & Technical Assessors and Technical Assessors Training / skills transfer sessions.

4.9.8 Management System Auditor training;

4.9.9 Management System Auditing and Certification, and

4.9.10 Technical Asser Training

4.9.11 Technical Asset Training

4.10 Persons suitable for this project should the following skills or qualifications:

4.10.1 Civil Engineering;

4.10.2 Legal;

4.10.3 Lead Auditor;

4.10.4 Technical Assessor;

4.10.5 Training / Lecturing (preferably registered as an ETDP)

4.11 Therefore, the following documents should be submitted by Prospective Bidders:

4.11.1 a covering letter to confirm their understanding of the project and their offering with the relevant supporting details (profile and experience) of the Consortium or Joint Venture team.

4.11.2 reference letters from Clients stating the Project Description, Project Value, the duration and confirmation the project was successfully completed

4.11.3 the CV for every team member and indicate which specific area work and experience in the provision of the area of expertise in years for the position where the person will be placed for the project; and

- 4.12 As far as senior managerial staff are concerned, their CVs should only be provided if they are going to be actively and consistently physically involved in the Bid.

5 MANDATORY REQUIREMENTS

Bidders must comply with the requirements and submit all required document(s) indicated hereunder with the bid documents at the closing date and time of bid. This phase is not scored and bidders who fail to comply with all the mandatory criteria will be disqualified.

- 5.1 Bidders are required to be registered on the Central Supplier Database and the Department of Transport shall verify the bidder's tax compliance status through the Central Supplier Database.
- 5.2 Where Consortia / Joint Ventures / Sub-contractors are involved; each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database. It is therefore a condition of this Bid that the tax matters of the bidder be in order at any point in time from the closing date of the Bid.
- 5.3 This Bid will only be awarded to a bidder(s) whose tax status on Central Supplier Database is compliant. Compliance should remain valid for the duration of the contract.

6 EVALUATION CRITERIA

- 6.1 Bidders are invited and, in fact, encouraged to attend a briefing session to be held virtually, where they can ask for clarification on the evaluation criteria and other aspects of the Bid. As this briefing session will be done virtually, it will not be compulsory. The link will be advertised during the bid advert.
- 6.2 Only bidders who have complied with mandatory requirements will be evaluated for functionality.
- 6.3 Bidders must submit supportive documentation for all functional requirements as indicated hereunder as part of their bid documents.

- 6.4 The Bid Evaluation Committee (BEC) responsible for scoring the respective bids will evaluate and score all bids based on their submissions and the information provided.
- 6.5 The value scored for each criterion will be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for each criterion. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- 6.6 Functionality will be evaluated based on the supporting documentation supplied by the bidders in accordance with the functionality criteria and values below.
- 6.7 Bidders are requested to ensure they become familiar with Table 1 and 2 below. Sufficient supporting information should be provided in your Bid Proposal. Bidders are especially requested to propose details on capacity building on how skills transfer will be incorporated throughout the phases of the project.
- 6.8 The evaluation of the functionality will be evaluated individually by Members of Bid Evaluation Committee in accordance with the below functionality criteria and values. The applicable values that will be utilized when scoring each criteria ranges from:

6.8 The Bids that fail to achieve a minimum of 70 points out of 100 points for functionality will be disqualified. This means that such bids will not be evaluated on the Preference Points System stage.

6.9 Second Stage – Evaluation in terms of 80/20 Preference Points System

Only bids that achieve the minimum qualifying score for functionality will be evaluated further in accordance with the 80/20 preference points system.

6.9.1 Detailed Pricing:

Service Providers must complete the required SBD Pricing documents and ensure that Prices are:

- Firm and inclusive of all costs, including disbursements;
- inclusive of VAT, if applicable;
- Correctly calculated and identical to the financial proposal;
- Pricing should be detailed, with proper cost breakdown, in line with milestones.
- The Department uses a two-envelope system.

NO PRICES MUST REFLECT IN THE TECHNICAL PROPOSAL.

6.9.2 Fees:

Domestic hotel accommodation may not exceed the maximum allowable rates referred to in the domestic accommodation rate grid set out in National Treasury Cost Containment Directives. (incl dinner, breakfast and parking), air travel must be restricted to economy class and claims per kilometre may not exceed the rates approved by the Automobile Association of South Africa.

6.9.3 Rates:

According to the 23 October 2013 Cabinet Resolution as defined in the National Treasury Instruction 01 of 2013/14: Cost Containment Measures sub-paragraph 4.2; the Consultants (or Service Provider) will only be remunerated on the following rates regime:

- a. The "Guidelines for fees" issued by the South African Institute of Chartered Accountants (SAICA);
- b. The "Guide on Hourly Fee Rates for Consultants", by the Department of Public Service and Administration (DPSA); or
- c. Based on the body regulating the profession of the Consultant.

6.9.4 Payments

6.4.9.1 There is provision to make monthly payments or payments will be processed as agreed upon in the approved Inception Report.

6.4.9.2 However, payments can only be made for actual services rendered and not "planned services".

6.4.9.3 Therefore, during the finalisation of the Inception Report at the beginning of the project, both Parties will need to agree on the monthly deliverables and payment schedule; and the successful service provider shall be expected to indicate the planned monthly staffing resources based on the activity schedule and project cash flows.

6.10 Calculating of points for B-BBEE status level of contribution

6.10.1 Points will be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 6.11 Bidders are required to complete the preference claim form (SBD 6.1), and submit their original and valid B-BBEE status level verification certificate or a certified copy thereof or a sworn affidavit at the closing date and time of the bid in order to claim the B-BBEE status level point. The points scored by a bidder in respect of the level of B-BBEE contribution will be added to the points scored for price.
- 6.12 Only bidders who have completed and signed the declaration part of the preference claim form and who have submitted a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS), or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or a sworn affidavit confirming annual turnover and level of black ownership in case of an EME and QSE together with the bid will be considered for preference points. A trust, consortium or joint venture (including unincorporated consortia and joint ventures) must submit a consolidated B-BBEE Status Level Verification Certificate for every separate member.
- 6.13 Failure on the part of the bidder to comply with paragraphs 6.11 and 6.12 above will be deemed that preference points for B-BBEE status level of contribution are not claimed and will therefore be allocated a zero (0).
- 6.14 The Department of Transport may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regard to preference.
- 6.15 The points scored will be rounded off to the nearest two (2) decimals.

- 6.16 In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest number of preference points for B-BBEE.
- 6.17 However, when functionality is part of the evaluation process and two or more bidders have scored equal points including equal preference points for B-BBEE, the contract will be awarded to the bidder scoring the highest for functionality.
- 6.18 Should two or more bids be equal in all respects; the award shall be decided by the drawing of lots.
- 6.19 A contract may, on reasonable and justifiable grounds, be awarded to a Bid that did not score the highest number of points.

7 RULES OF BIDDING

7.1 Format and Submission of Bids

- 7.1.1 Bid submission requirements must be completed in sections and appendices provided in the bid document.
- 7.1.2 **Bids must be submitted in two (2) envelopes, one (1) with the technical proposal and the other pricing. Supporting documents required for compliance including a Valid Tax Clearance Certificate and all the SDB documents except for SBD 3.1 and 3.3 must be submitted together with the technical proposal.**
- 7.1.3 Bidders must submit their bids on the stipulated closing date and time. Late bids will not be considered. All late bids must be collected within seven (7) days failing which the DOT will discard of such late proposals.
- 7.1.4 Format of submission of proposals:
- (a) Envelopes must be clearly marked with Company name, DOT BID Number and whether it is the technical or financial response (envelope 1 and 2);
 - (b) Proposals must be submitted as one (1) original and four protected soft copies. Soft copies must be exact copies of the original document, and should be labelled properly.

- 7.1.5 In order to evaluate and adjudicate bids effectively, it is imperative that bidders submit responsive bids. To ensure a bid will be regarded as responsive it is essential to comply with all conditions pertaining to mandatory requirements.
- 7.1.6 Each bidder must attach all applicable documents in support of its bid in accordance with the requirements set out in this bid as well as any other relevant materials, photographs and/or attachments.
- 7.1.7 Each bid, once submitted, constitutes a binding and irrevocable offer to provide the Services on the terms set out in the bid, which offer cannot be amended after its date of submission.
- 7.1.8 Department of Transport (DOT) reserves the right to accept or consider any Bid in full or in part or any responses or submissions in relation thereto.
- 7.1.9 The DOT reserves the right to appoint more than one bidder whose bid most successfully conforms to the Criteria and the Requirements in accordance with the terms and conditions described in the TOR.
- 7.1.10 The DOT reserves the right to request any additional information that it may require or deem necessary. All such requests shall be in writing.
- 7.1.11 After careful consideration and thorough examination of the proposals, DOT shall select the successful Bidder whose proposal most closely satisfies the criteria and the requirements. The lowest price (management fee where applicable) offered will not necessarily be a decisive factor in choosing between Proposals.
- 7.1.12 The Department shall publish the results of the outcome of a tender process, including the details of the Successful Bidder in the same media that was used to advertise the bid.

8. INFORMATION SESSION

- 8.1 A virtual briefing session will be held with the Department as detailed in the advertisement. Although not compulsory, prospective Bidders are advised to attend the briefing session since this session provides bidders with an opportunity to clarify aspects of the process as set out in this document and to address any substantive

- 8.2 Prospective Bidders should take note of Clause (1) Note (iii) and the Annexures A – C, provided as information to assist in preparing the Bid.

9 SUB-CONTRACTING, PARTNERSHIP/CONSORTIUM/JOINT VENTURE AND COMPANY REQUIREMENTS

- 9.1 All these details have to be provided upfront. Please provide all the mandatory documents and certificates for each of the JV Partners.
- 9.2 The successful bidder must obtain prior DOT approval about to sub-contract, and/or amend the sub-contracting arrangements.
- 9.3 A proposal submitted by a company, close corporation or other legal person must be accompanied by a resolution or agreement of the directors or members and be signed by a duly authorized person.
- 9.4 A proposal submitted by a partnership must be accompanied by a written partnership agreement.
- 9.5 A proposal submitted by a consortium or joint venture of two or more parties must be accompanied by a signed memorandum of understanding between the parties to such consortium indicating:
- 9.5.1 the conditions under which the consortium will function;
- 9.5.2 its period of duration;
- 9.5.3 the persons authorized to represent it;
- 9.5.4 the participation of the several parties forming the consortium;
- 9.5.5 the benefits that will accrue to each party;
- 9.5.6 any other information necessary to permit a full appraisal of its functioning.

10 SECURITY AND CONFIDENTIALITY OF INFORMATION

- 10.1 No material or information derived from the provision of the services under the Contract may be used for any purposes other than those of the Department, except where authorised in writing to do so. All information will be held strictly confidential. The successful Service Provider may be required to sign a Confidentiality Agreement with the Department.

11 TERMS AND CONDITIONS

- 11.1 The Department reserves the right to amend, modify or withdraw this Terms of Reference (TOR) document or amend, modify or terminate any of the procedures or requirements set out herein at any time and from time to time, without prior notice except where required by law, and without liability to compensate or reimburse any Service Provider.
- 11.2 Neither the Department, nor any of its respective officers, or employees may make any representation or warranty, expressed or implied in this TOR document, and nothing contained herein is, or shall be relied upon as, a promise or representation, whether as to the past or the future.
- 11.3 The costs of preparing proposals and of negotiating the Contract will not be reimbursed.
- 11.4 The Department also reserves the right to call interviews with short-listed Service Providers before final selection, and to negotiate price with the Preferred Service Providers.
- 11.5 Firms may not contact the Department on any matter pertaining to their bid from the time when bids are submitted to the time the Contract is awarded. Any effort by a Service Provider to influence bid evaluation, bid comparisons or award decisions in any manner, may result in rejection of the bid concerned.
- 11.6 Bid submission requirements must be completed in sections and appendices provided in the bid document.

11.7 Further Requirements

11.7.1 The individuals proposed for professional work on the project shall remain on the project unless the Department grants prior permission to change the team composition. Such permission will not be withheld unreasonably.

11.7.2 No material or information derived from the provision of the services under the Contract may be used for any purposes other than those of the Department, except where authorised in writing to do so. All information will be held strictly confidential. The successful service provider may be required to sign a Confidentiality Agreement with the Department.

11.7.3 Copyright of all documents and electronic aids and software programs prepared or developed in terms of the appointment, shall vest in the Department.

11.7.4 Any Briefing Notes which may be issued by the Department to the successful service providers should be considered as part of this ToR.

11.7.5 In the event that negotiations between the Department and the successful service providers fail with regard to the conclusion of a Contract, the Department reserves its right not to appoint the successful service providers without incurring any liability to compensate or reimburse the successful service providers.

11.7.6 The Department of Transport reserves the right to cancel the Contract forthwith and to terminate the service of the successful Service Provider(s) with thirty (30) days' notice, and to do so if the successful Service Providers becomes unable for any reason whatsoever to implement any of the terms of the Contract due to causes within his/her control, or delay without proper cause. In such an event, the successful Service Provider(s) shall, when called to do so, hand over to the Department all documents and papers which are related to the project.

11.7.7 The Department will also have the right to:

11.7.7.1 Discontinue the services of the successful Service Provider(s) at any stage during the project without any obligation to allow the successful service providers to execute the remainder of the project, and to:

- 11.7.8 Should the Contract be cancelled in terms of paragraph 4.8.7 above, the quantum of remuneration due to the successful service providers for services rendered prior to the date of the termination of the Agreement shall be determined between the Department and the successful Service Provider(s).
- 11.7.9 A proposal submitted by a company, close corporation or other legal person must be accompanied by a resolution or agreement of the directors or members and be signed by a duly authorized person.
- 11.7.10 A proposal submitted by a partnership must be accompanied by a written partnership agreement.
- 11.7.11 A proposal submitted by a Consortium or Joint Venture of two or more parties must be accompanied by a signed memorandum of understanding between the parties to such Consortium or Joint venture indicating:
- 11.7.11.1 the conditions under which the Consortium or Joint Venture will function;
 - 11.7.11.2 its period of duration;
 - 11.7.11.3 the persons authorized to represent it;
 - 11.7.11.4 the participation of the several parties forming the Consortium or Joint venture;
 - 11.7.11.5 the benefits that will accrue to each party;
 - 11.7.11.6 any other information necessary to permit a full appraisal of its functioning.
- 11.7.12 The successful Service Provider(s) may be required to enter into a Service Level Agreement (SLA) prior to appointment.
- 11.7.13 The Department is not bound to accept any of the proposals submitted and reserves the right to call for best and final offers from short-listed service providers before final selection.
- 11.7.14 Firms may ask for clarification on this ToR or any of its Annexures up to close of business forty-eight (48) hours before the deadline for the submission of bids.

11.10 Prospective Bidders must at all times comply with the Department's Supply Chain rules and processes with regard to all projects and payments.

12 PAYMENT

12.1 Invoicing:

The Contractor's Project Manager shall, at the end of each deliverable, submit a consolidated invoice, certified as correct by the Contractor's Project Manager, showing the actual work performed, hours worked, and manpower inputs for the task and associated costs accompanied by all supporting documents.

12.2 Payment Information

12.2.1 An invoice only becomes due and payable:

- (a) When the Project Manager signs-off on the specific deliverable and submits the invoice for payment; and
- (b) When the invoice is correct with regards to calculations, information contained, banking details and supporting documents.

12.2.2 It is important to ensure that invoices are correctly submitted and reference the project name, DOT number and Order Number.

12.2.3 Non-compliance will delay the payment process.

12.3 Penalties

12.3.1 Poor performance will result in penalties that include withholding of a minimum 30% of the total invoice of each affected phase / milestone until it is fixed before the final product is submitted. In the case where the performance has not been improved to the satisfaction of the Department and the final product is handed over, the original amount held back will not be paid over to the Service Provider under any circumstances. On the other hand, an improved quality and/or performance, at the satisfaction of the Department, will require the outstanding part of the held back invoice to be paid to the Service Provider in full but with no additional interest.

12.3.2 The project milestones/phases are expected to be adhered to. Any deviation must be approved by the Department prior to any commencement of the changes. Failure to do so will result in a 5% non-payment of that particular and/or affected phase(s).

12.3.3 Notwithstanding item 12.6.2 above, failure to meet the deadline as stipulated in this TOR will result in 30% of the total outstanding payments for the project as whole not being paid over to the Service Provider if the poor performance is attributed to the Service Provider unless there is undisputed evidence that the fault lies with the Department."

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the

RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

obligations of the supplier covered under the contract.

- 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or

analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.

- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;

- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take

such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

- 16. Payment**
- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.
- 17. Prices**
- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
- 18. Contract amendments**
- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
- 19. Assignment**
- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- 20. Subcontracts**
- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
- 21. Delays in the supplier's performance**
- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the

supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any

person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which

may be due to him

25. Force Majeure

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.

27.5 Notwithstanding any reference to mediation and/or court proceedings herein,

(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and

(b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;

(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
- 29. Governing language** 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
- 30. Applicable law** 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
- 31. Notices** 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
- 32. Taxes and duties** 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
- 33. National Industrial Participation Programme (NIP)** 33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
- 34. Prohibition of Restrictive practices** 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
