The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this quotation may not materialize.

Formal quotations will be evaluated in terms of **80/20** Preference Point System as approved by council in terms of the interim arrangements.

Bidders must ensure that all the necessary compliance documentation is submitted with the bid at the closing date of the tender. Bidders must comply with the Formal Quotation conditions as stipulated in the bid document, if a bidder does not comply the bid will be regarded as non – responsive.
