APPOINTMENT OF A SERVICE PROVIDER FOR THE RENTAL OF A 55-TON MOBILE CRANE (WET HIRE)

Siyathemba Local Municipality hereby invites suitably qualified and experienced service providers to submit written quotations for the provision of a 55-Ton Mobile Crane on a Wet Hire basis for the lowering, support, and re-erection of three (3) municipal high mast lighting structures located in Prieska and Marydale to facilitate maintenance and repair works..

Scope of Services

The successful bidder shall provide:

- A certified 55-Ton Mobile Crane with a minimum boom reach of 40 metres.
- A qualified and certified Crane Operator.
- A qualified and competent Rigger/Banksman.
- All fuel, lubricants, maintenance, transport and operational costs.
- All certified lifting tackle and rigging equipment.
- Mobilisation and demobilisation to and from site.

All statutory permits and compliance requirements necessary for the execution of the works.

Pricing Requirements

Bidders must submit rates based on the following:

1	Daily Wet Hire Operational Rate (Excluding VAT)
2	Daily Standing / Idling Rate (Excluding VAT)

Only quotations submitted on a daily rate basis will be considered.

Mandatory Returnable Documents

The following documents must accompany the quotation:

- Valid Lifting Machinery Inspector (LMI) Load Test Certificate for the proposed crane (not older than 12 months).
- Certified copies of the Crane Operator's License, PrDP and Medical Fitness Certificate.

Special Conditions

- No mobilisation of the crane shall be permitted until the Contractor has verified and confirmed that all required replacement components for the high mast structures are available and secured on site.
- Daily rates shall only be applicable for actual operational days approved by the Municipality.
- The Municipality reserves the right to refuse payment for downtime resulting from mechanical breakdowns, operator absenteeism, lack of permits, or any contractor-related delays.

EVALUATION CRITERIA

Proposals will be evaluated in accordance with the Preferential Procurement Policy Framework Act (Act No. 5 of 2000) and the Municipality's SCM Policy on the basis of the 80/20 preference point system.

Functionality, experience, accreditation and compliance will form part of the evaluation criteria.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
