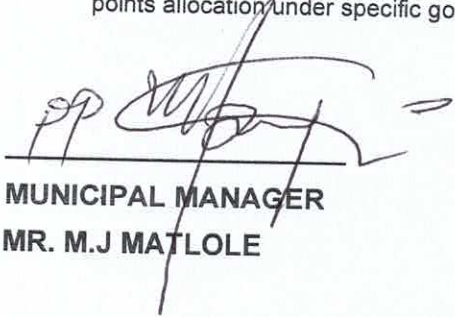
SPECIAL CONDITIONS OF A TENDER
