Formal tenders sealed and individually clearly marked “with the tender number and description of choice as detailed above” must be placed in the Municipal tender box, **26 Church Street, OUTDSHOORN** no later than **12h00** on **FRIDAY, 02 SEPTEMBER 2022** and will be opened in public immediately thereafter in the **Supply Chain Management Office, 26 Church Street, OUTDSHOORN** or any alternative place in Oudtshoorn Municipal Offices.

A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of **120** days after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R337 including VAT** for hard copies directly printed by the Municipality and **free of charge when provided on pdf via e-mail**. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and / or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Only locally produced or locally manufactured goods with a minimum threshold for local production and content will be considered:

***Escalation effective from 1st of July 2023 – the bidder will be allowed to escalated prices on an annual basis with an average CPIX over the past year but not exceeding 8%.**

Formal Tenders TD-31/08/2022 and TD-32/08/2022 will be evaluated and adjudicated in terms of **80/20** Preference Point System prescribed by the Oudtshoorn Municipality's Supply Chain Management Policy.
