1. INTRODUCTION AND PURPOSE

The purpose of this specification is to outline the requirements for the supply, delivery, and offloading of high-quality marching band musical instruments for the Tshwane Metro Police Department (TMPD) Ceremonial Unit.

All instruments covered by this technical specification are brand-new, factory-sealed, professional-grade marching instruments suitable for rigorous outdoor ceremonies which must ensure uniformity, durability, and professional performance during official events.

2. PROJECT SCOPE

The successful bidder will be responsible for:

- Supplying all specified marching band instruments.
- Delivering and offloading at a designated TMPD site.
- Providing warranty and servicing as stipulated.

2.1 GENERAL REQUIREMENTS

- Quantity: As per the accompanying Bill of Quantities (BoQ).

- Condition: All instruments must be brand new, factory-sealed, and in perfect working order.
- Quality Standard: Instruments must be of Professional or High / Intermediate / Advanced Student quality suitable for sustained, rigorous use in outdoor marching, ceremonial, and concert environments. Durability and consistent tone quality are paramount.
- Finish: Brass instruments must have a clear lacquer, silver-plated, or gold-lacquer finish as appropriate for the instrument type. Woodwind instruments must be finished as standard for their type (e.g., hard-wearing plastic or wood resin for marching clarinets, lacquered brass for saxophones).
- Percussion instruments must include adjustable straps and harnesses for marching use.
- Warranties: A minimum 12-month standard manufacturer's warranty must be provided against defects in materials and workmanship.

2.2 GENERAL SPECIFICATION

This quotation covers the following types of instruments:

- Brass (trumpets, flutes, cornets, trombones, sousaphones).
- Woodwinds (marching clarinets, saxophones).
- Battery percussion (marching snares, tenors, bass drums, cymbals).
- Front-ensemble (marimbas, vibes, glockenspiels).
- Instrument accessories (stands, harnesses, cases).

2.4 WARRANTY & COMPLIANCE

All instruments MUST include a 12-month Original Equipment Manufacturer (OEM) warranty on manufacturer's defects.

2.5 SERVICING REQUIREMENT

The successful bidder shall be responsible for a once-off full servicing of the supplied equipment 12 months after the date of delivery.

This service must include a full inspection, maintenance of key components (including valve/bearing adjustments, head joints, reeds, drumheads, straps, hardware checks, complete inspection and cleaning kit), and confirmation of continued operational safety and performance.

IMPORTANT: All costs associated with the required service must be included in the original bid pricing.

2.6 DELIVERABLES

- Delivery must occur within 30 working days of receiving an official purchase order.

- Off-loading at designated delivery sites is required.
- No deliveries may be made without a valid purchase order.
- The City reserves the right to reject non-compliant deliveries.

The City of Tshwane reserves the right to extend the validity period beyond the initial term and any subsequent extensions. Any extension must be requested in writing by the Supply Chain Management (SCM) Division prior to the expiry of the current validity period. Extensions will only be considered while bids remain valid.

8. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis to assess the viability of pricing submitted by bidders.

The following provisions shall apply:

- If a bidder's price is deemed unviable, the city will request written confirmation from the bidder regarding their ability to deliver at the quoted price.
- If the bidder confirms they cannot deliver, the bid will be disqualified as non-responsive.
- If the bidder confirms they can deliver, a risk-mitigating contract will be entered into to safeguard against non-performance. Any failure to deliver will be addressed in accordance with the contract, including performance warnings and potential listing on the database of restricted suppliers.

Additionally, the City reserves the right to negotiate a market-related price with the bidder scoring the highest points. If no agreement is reached, the city may negotiate with the next highest scoring bidder, and so on. If a market-related price cannot be agreed upon with any qualifying bidder, the City reserves the right to cancel the quotation.

9. SERVICE LEVEL AGREEMENTS

Should it be considered as a requirement by the City of Tshwane: Group Legal & Secretariat Services Department, a Service Level Agreement will be finalized upon award of this tender. Such Service Level Agreement will be signed between the City of Tshwane and the Successful bidder, if not, the condition of this Tender will serve as the contract between the City of Tshwane and Successful Service Provider.

1. I have read and I understand the contents of this Certificate;
2. I understand that the accompanying bid will be disqualified if this Certificate is found not to be true and complete in every respect;
3. I am authorized by the bidder to sign this Certificate, and to submit the accompanying bid, on behalf of the bidder;
4. Each person whose signature appears on the accompanying bid has been authorized by the bidder to determine the terms of, and to sign, the bid, on behalf of the bidder;
5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
