The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of CONSULTING ENGINEERING SERVICES FOR THE UPGRADING OF NATIONAL ROAD R573 SECTION 2: WORK PACKAGE E FROM KM 13.00 TO KM 24.7. This project is in the province of Mpumalanga and in the Nkangala district municipality and Thembisile Hani local municipality and the approximate programme is for supervision of 36 months, commencing March 2024.

Only tenderers who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date, are eligible to tender.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
