The appointment of a panel of suitable service providers for the supply and delivery of first grade Lucerne and Eragrostis grass to South African National Parks.

The contract will be for a period of three (03) years.

SPECIFICATIONS/SCOPE OF WORK

SANParks aims to appoint a panel of suitable suppliers that have the capability and understanding to provide fodder to SANParks. Bids are sought from reputable reliable suppliers that have experience and capability in the supply and delivering of first grade Lucerne and Eragrostis grass.

DELIVERABLES

- All Lucerne and Eragrostis grass must be of first grade quality, from current year.
- Each load of Lucerne must be accompanied with a Lucerne Quality Index (LQI) issued by a Member of the National Lucerne Trust (NLT) which must confirm the loaded parameters and LQI ranging between 97 – 103. Index.
- All Lucerne and Eragrostis grass rectangular bales must be from the current season.
- All Lucerne and Eragrostis grass must be delivered in square / rectangular form.
- All Lucerne and Eragrostis grass must not be contaminated with weeds or toxic plants or any other species of plants / grasses not ordered.

SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
