8. Any legal person, or their family members, may make an offer or offers in terms of this invitation to bid. In view of potential conflict of interest, in the event that the resulting bid, or part thereof, be awarded to family members of persons employed by an organ of state, it is required that the bidder or his/her authorised representative declare his/her position in relation to the evaluating/adjudicating authority where the bidder is employed by the Institution.
9. The bid of any bidder may be disregarded if that bidder or any of its directors abused the institution's supply chain management system; committed fraud or any other improper conduct in relation to such system; disclosure is found not to be true and complete; or failed to perform on any previous contract.
10. Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). Collusive bidding is a per se prohibition meaning that it cannot be justified under any grounds.
11. Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorises accounting officers and accounting authorities to:

1. BACKGROUND:

The Western Cape Department of Agriculture (WCDoA) produces and hosts on a weekly basis two agricultural related radio programmes which is broadcast on RSG100 – 104fm.

The technical programme broadcasted on **Friday mornings at 05h25 – 06h00** (timeslot is subject to change) comprises of multiple guest speakers/specialists covering a range of topics including current affairs, events, new research etc. This programme is more of a technical nature.

The **Saturday morning** journal programme broadcasted **between 11h45 and 12h00** has a singular focus and topic and between one to three guest speakers/specialists are interviewed. The focus of this programme is broader, to inform the listener of success stories and successful people in agriculture.

Guest speakers and specialists are interviewed from across South Africa and covers the South African agricultural landscape irrespective of the fact that the programmes are produced by the Western Cape Department of Agriculture (WCDoA).

Both shows are pre-recorded and must be distributed by email or We Transfer to RSG in order to be uploaded on the Wednesday before the broadcasts on Friday and Saturday..

All programmes are loaded on [RSG Landbou Archives - Western Cape Department of Agriculture \(elsenburg.com\)](https://www.elsenburg.com) on the Monday following the Friday and Saturday broadcasts. This is done by the department's web custodian.

The department has its **own studio** and recording equipment at its Head Office at Elsenburg, **Stellenbosch** and 75% of studio interviews and phone interviews as well as the uploading of programmes are conducted from the Stellenbosch studio. The remaining 25% of interviews can be conducted throughout the country or via MS Teams or telephonically, depending on the subject matter.

- 3.2.5 Liaise with WCDa HOC and WCDa programmes, farmers (commercial and new), extension officers, researchers and industry leaders on possible topics and events that are current and of interest.
- 3.2.6 Be up to date with current affairs in terms of agriculture and possess research skills to ensure accuracy of information;
- 3.2.7 Attend WCDa events to do interviews as agreed upon with HOC.
- 3.2.8 Write content for social media platforms if required;
- 3.2.9 Set up interviews with specialists on the specific topic.
- 3.2.10 Travel economically and only if really necessary (not more than 8 times per year).
- 3.2.11 Interviews are ideally one on one.
- 3.2.12 Get familiar with the topic in order to ask relevant and intelligent questions.
- 3.2.13 Take pictures of projects which can be used for publicity by WCDa and RSG.
- 3.2.14 Edit programme to fit into time-slot.
- 3.2.15 Send programme to HOC for final sign-off.
- 3.2.16 Mix and prepare content, to be uploaded to RSG (SABC), in final format
- 3.2.17 Present programme.
- 3.2.18 Produce 1 x promotional material per week (audio).
- 3.2.19 Produce 1 x promotional copy of about 300 words per week (written).
- 3.2.20 Collate digital content e.g. photographs and/or short video clips for RSG website.
- 3.2.21 Send short description of planned programmes to HOC first for input and sign off.
- 3.2.22 Load programme and promotion electronically onto SABC's ftp site weekly.
- 3.2.23 Submit content to RSG (Cape Town) if there is a technical problem with uploading of content.
- 3.2.24 Prepare once-off marketing material of programme for announcement by RSG presenters to credit the Western Cape Department of Agriculture ($\pm$ 30 words). Email content of programme and accompanying photographs weekly to distribution list, including departmental web editor for placement on website.
- 3.2.25 Send programme plan and list of guest speakers to WCDa's HOC at least four weeks in advance for input and sign-off.
- 3.2.26 Timeously communicate with the HOC regarding any RSG Landbou related matters that the WCDa would need to be aware of e.g. change in programme schedule or any other possible risk or advantages.

4 MANAGING THE STUDIO

The successful service provider is to manage the state-of-the-art Elsenburg Radio Studio, which includes but is not limited to the equipment and facility. The service provider will keep a close track of the booking of this facility as well as the functionality of the equipment and ensure that any malfunction or damages are reported to the WCDa timeously. The

financial implications of management of the studio should be part of the main financial proposal.

In addition to the management of the studio, should there be a need for additional interviews, this part would be billed on an hourly rate and should be included in the pricing breakdown.

As part of the management of the studio, if there are officials keen to make use of the studio, the service provider must be available to support the individuals. For managing, recording and editing additional interviews, not limited to RSG content, will be billed on an hourly rate as and when the need arises.

5 SKILLS, EXPERIENCE AND QUALIFICATION

- 5.1 An applicable, recognized three-year degree or equivalent journalistic/ media studies qualifications and experience will be advantageous.
- 5.2 Have at least 3 - 5 years' experience as a professional radio presenter on a recognized commercial radio station;

- 5.4 Have excellent presentation and performance skills (to be indicated on CV)
- 5.5 Have a proven broad knowledge of agriculture in general;
- 5.6 Have a proven understanding of role players and stakeholders of agriculture in general;
- 5.7 Have extensive research skills and experience (to be indicated on CV);
- 5.8 Have the ability to work independently without being micro-managed;
- 5.9 Have a very good knowledge of radio technology in terms of mixing, editing and editing software;
- 5.10 Have sufficient experience (3 – 5 years) in the managing of a radio studio including enough technical skill to maintain and service the basic equipment of a radio studio;
- 5.11 Be familiar with social media platforms and able to prepare content for social media platforms when required;
- 5.12 ;
- 5.13 Be prepared to be interviewed prior to appointment;
- 5.14 Accept duty by 1 March 2025;
- 5.15 It will be required of the successful bidder to travel and attend off-site visits to farms and conduct off-site interviews subject to prior approval by the HOC (transport and subsistence costs to be reimbursed separately by the department).
- 5.16 Cell phone costs will be reimbursed at a rate of R350 per month.
- 5.17 Duly registered on the Central Supplier's Database.
- 5.18 Proposed timeline to be submitted for:
 - Monthly meeting with HOC and planning for the month to come.

- Schedule recording for the next month, a month in advance.
- Submit content to SABC/RSG a month in advance.
- Prepare text for advert and share with WCDoA a month before the scheduled slots
- Prepare for ad-hoc requests and keep record of these requests.
- Submit invoice to SCM for the first day of the month.

6 CONDITIONS

- 6.1 A CV outlining above skills, experience and qualifications with contactable references must be included as part of the tender documents.
- 6.2 Three (3) x 90 second voice recordings saved on a USB memory stick in mp3 format, where 1) is reading or presenting copy in AFRIKAANS, 2) is reading or presenting copy in ENGLISH provided by the department and 2) is a recent LIVE recording of the bidder in studio presenting his or her own radio programme. Script to be supplied by the department. The voice recordings will be subject to a panel evaluation. The recordings will also be sent to RSG for their quality assurance and acceptance. Only presenters recommended by the evaluation panel will be subjected to the second stage of evaluation.

7 RESOURCES

- 7.1 The successful bidder shall have full access to the radio studio of the WCDoA and all its equipment including a computer, editing software, mixing table, micro phones, land line, email and (limited) internet facilities (studio is situated in Stellenbosch).
- 7.2 The studio will also be serviced annually or on request if something should break.
- 7.3 The successful bidder will have a very close working relationship with the WCDoA HOC to assist with identifying topics, events, guest speakers and specialists.

8 SERVICE LEVEL AGREEMENT

A service level agreement (SLA) will be drawn up detailing all contractual obligations between WCDoA and the appointed radio presenter. The service level agreement will specify, inter alia, the agreed deliverables and roles and responsibilities with timelines of the various parties.

9 FINANCIAL PROPOSAL

- 9.1 A total price (VAT inclusive) must be submitted to cover the three-year contractual period and for the 156 x 15 minute and 156 x 30 minute programmes.
- 9.2 A breakdown of the costs per programme must also be submitted.

- 9.3 Additional costs will be reimbursed in line with the relevant Departmental Policy: including travel (AA rates equivalent to a 1600 sedan vehicle) (excluding travel to and from the Stellenbosch studio), accommodation and subsistence (not exceeding R800 per night for accommodation and R450 per day for food and drinks) and official cell phone costs can be billed separately on a monthly basis. **THE ADDITIONAL REIMBURSEMENT COSTS DO NOT HAVE TO BE INCLUDED IN THE FINANCIAL PROPOSAL.**

English

This year, 28 September will mark the 18th World Rabies Day. The theme for 2024: "Breaking Rabies Boundaries" highlights that One Health is not for a selected few but for everyone. The second Annual Provincial Veterinary Week will also commence on 28 September and end on 5 October. It includes multiple veterinary-focused events and initiatives.

Rabies Day aims to raise awareness and advocate for rabies elimination globally. It is an event designed to be inclusive, uniting people, organisations and stakeholders across all sectors against rabies.

According to Dr Ilse Trautman, Deputy Director General of Agricultural Research and Regulatory Services (including Veterinary Services) at the Western Cape Department of Agriculture, we can overcome geographic, socio-economic, and educational barriers by breaking boundaries and ensuring widespread vaccination, awareness, and access to medical care. This unified approach is crucial in the fight against rabies, fostering a world where the disease is no longer a threat to humans and animals.

The Western Cape Head of Veterinary Services, Dr Gininda Msiza, says rabies affects the central nervous system.

According to Dr Msiza "Without appropriate medical care, rabies causes brain disease and death. Once symptoms of rabies appear, the disease is nearly always fatal. For this reason, preventing animal bites and receiving prompt medical care is especially important."

The Rabies virus is transmitted through direct contact (such as broken skin or mucous membranes in the eyes, nose, or mouth) with saliva or brain/nervous system tissue from an infected animal. People usually get rabies from the bite of a rabid animal.

Western Cape Minister of Agriculture, Economic Development and Tourism, Dr Ivan Meyer, highlights the value of awareness programmes such as Rabies Day.

Minister Meyers says awareness of rabies disease engages communities and empowers people to save themselves by seeking the care they need. This includes understanding how to prevent rabies in animals, when to suspect rabies and what to do in case of a bite.

Over the last three years, the Western Cape Department of Agriculture has vaccinated over 400,000 cats and dogs in its outreach engagements with communities.

Afrikaans

Die 18de Wêreldhondsdolheidsdag sal hierdie jaar op 28 September gedenk word. Die tema vir 2024: "Breek Hondsdolheidsgrense," beklemtoon dat Een Gesondheid nie net vir 'n uitgesoekte groep is nie, maar vir almal. Die tweede jaarlikse Provinsiale Veeartsenykundige Week sal ook op 28 September begin en op 5 Oktober eindig, met verskeie veeartseny-gefokusde geleenthede en inisiatiewe.

Hondsdolheidsdag poog om bewustheid te verhoog en wêreldwyd vir die uitwissing van hondsdolheid te pleit. Dit is 'n geleentheid wat ontwerp is om inklusief te wees en mense, organisasies en belanghebbendes oor alle sektore heen te verenig in die stryd teen hondsdolheid.

Volgens dr. Ilse Trautman, Adjunk-Direkteur Generaal van Landbounavorsing en Regulerende Dienste (insluitend Veeartsenykundige Dienste) by die Wes-Kaapse Departement van Landbou kan ons geografiese, sosio-ekonomiese en opvoedkundige grense oorkom deur grense te breek en wydverspreide inenting, bewustheid, en toegang tot mediese sorg te verseker. Hierdie verenigde benadering is van kardinale belang in die stryd teen hondsdolheid en bevorder 'n wêreld waar die siekte nie langer 'n bedreiging vir mense en diere is nie.

Die Wes-Kaapse Hoof van Veeartsenykundige Dienste, dr. Gininda Msiza, sê hondsdolheid beïnvloed die sentrale senuweestelsel.

Dr Msiza verduidelik verder dat "Sonder toepaslike mediese sorg veroorsaak hondsdolheid breinsiekte en dood. Sodra simptome van hondsdolheid verskyn, is die siekte byna altyd fataal. Daarom is die voorkoming van dierebyte en die verkryging van vinnige mediese sorg uiters belangrik."

Die hondsdolheidvirus word oorgedra deur direkte kontak (soos gebreekte vel of slymvliese in die oë, neus of mond) met speeksel of brein-/senuweestelselweefsel van 'n besmette dier. Mense kry gewoonlik hondsdolheid deur die byt van 'n hondsdol dier.

Die Wes-Kaapse Minister van Landbou, Ekonomiese Ontwikkeling en Toerisme, dr. Ivan Meyer, beklemtoon die waarde van bewustheidsprogramme soos Hondsdolheidsdag.

Minister Meyer sê dat bewustheid oor hondsdolheid gemeenskappe betrek en mense bemaagtig om hulself te red deur die nodige sorg te soek. Dit sluit in om te verstaan hoe om hondsdolheid by diere te voorkom, wanneer om hondsdolheid te vermoed en wat om te doen in geval van 'n byt.

Oor die afgelope drie jaar het die Wes-Kaapse Departement van Landbou meer as 400 000 katte en honde ingeënt in sy betrokkenheid by gemeenskappe.

GOVERNMENT PROCUREMENT: GENERAL CONDITIONS OF CONTRACT

July 2010

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 “Day” means calendar day.
 - 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order.
 - 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
 - 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of

origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance,

training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

- 1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

- 5.1 The supplier shall not, without the purchaser’s prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier’s performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier’s records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights

arising from use of the goods or any part thereof by the purchaser.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual

- (d) for each appropriate unit of the supplied goods; performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s)

within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in

terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

	(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
29. Governing language	29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law	30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31. Notices	31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
32. Taxes and duties	32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country. 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser. 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
33. National Industrial Participation Programme (NIP)	33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
34 Prohibition of Restrictive practices	In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging). 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
