As a result, bidders are unable to calculate the estimated total for these items. Could you kindly confirm whether the estimated quantities were inadvertently omitted and advise how bidders should complete this section?	The estimated quantities for Items 3, 4, and 5 were inadvertently omitted. Bidders are hereby notified that a replacement page is issued for page 29, indicating the following estimated quantities for items 3, 4 and 5: • Item 3: Biscuit – Romany Creams (Each) – Quantity: 25 • Item 4: Biscuit – Eet-Sum-More (Each) – Quantity: 25 • Item 5: Biscuit – Digestives (Each) – Quantity: 25 All items must be priced per unit, with an estimated quantity of 25 for each of the above-mentioned items.	• Pricing Schedule, Category C: Office Refreshments, Page 29

In terms of the Technical Requirements, Requirement 1 (minimum 3-year industry experience) refers to stationery, office equipment or office refreshments, and Requirement 2 (minimum contract values) lists thresholds for Categories A–D only. Category E: Office Kitchenware is not explicitly listed. Please confirm whether these requirements apply to Category E.	Requirement 1 applies per category tendered and is applicable to all categories. In line with the note in the tender document, bidders must provide evidence in accordance with the category they are bidding for. Therefore, bidders submitting for Category E must provide proof of at least three (3) years' relevant industry experience. For Requirement 2: No minimum contract value has been prescribed for Category E. Therefore, Requirement 2 is not applicable to Category E.	- Specifications, Clause 6 - Evaluation Criteria / Technical Requirements, Page 34 - Schedule 13: Technical Requirements, Page 67
3.	With regards to Annexure 7: Vendor Performance, what is required of bidders in terms of page 91. Please advise on whether we need to complete the form or does the Cape Town Stadium complete it?	Bidders are not required to complete Annexure 7. It has been included in the tender document for information purposes as an example of what the contract performance evaluation will entail once the contract is active.	Annexure 7: Vendor Performance Form; page 91-92.
