1.8 **“B-BBEE status level of contribution”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment Act;

1.9 **“Bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods, work or services.

1.10 **“Comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilised have been taken into consideration

1.11 **“Consortium or joint venture”** means as association of persons for the purpose of combining their expertise, property, capital, efforts, skills and knowledge in an activity for the execution of a contract.

1.12 **“Contract”** means the agreement that results from the acceptance of a bid by an organ of state.

1.13 **“Specific contract participation goals”** means the goals as stipulated in the Preferential Procurement Regulation 2017. In addition to above-mentioned goals, the Regulations [12. (1)] also make provision for organs of state to give particular consideration to procuring locally manufactured products.

1.14 **“Control”** means the possession and exercise of legal authority and power to manage the assets goodwill and daily operations of a business and the active and continuous exercise of appropriate managerial authority and power in determining the policies and directing his operations of the business.

1.15 **“Equity Ownership”** means the percentage ownership and control, exercised by individuals within an enterprise.

SCOPE OF WORKS

The Municipality is looking for a panel of ICT service providers to maintain and repair servers, printers, desktops, switches, storage devices, laptops in Mohokare Local Municipality offices for a period of 3 three (3) years.

Background

Mohokare Local Municipality purchased a fleet of laptops, desktops and printers that are being utilized in all MLM offices. ICT equipment/devices are electronic therefore, it's natural that these devices can fail. It is ICT's Responsibility to make sure that the equipment is serviced and we have a backup plan should the equipment (e.g. Servers and Computers) fail as these have to be up and running 24 hours a day. To mitigate this risk, it is strongly recommended as the best practice to have a second line ICT maintenance support to assist the municipality when maintenance is beyond their internal capacity.

Currently there is no service level agreement in place for periodic maintenance and repairs of ICT Equipment as and when required. MLM business is interrupted due to breakdowns that occurs and the turn-around time to resolve problems takes too long because of the lengthy Supply Chain Management (SCM) processes that have to be followed to acquire the aforementioned services.

Scope of Work

- Repairs on Request
- Supply maintenance kit as and when required
- Quarterly Preventative maintenance for Server room equipment (Server Hardware, UPS, Biometric system etc.)
- Provide loan printers and laptops in critical environment where printers and laptops are broken and Users cannot wait until the devices are returned.
- Produce monthly report of all service rendered.
- All equipment must be procured and repaired through the ICT section as a single point of entry
- Proof must be provided from the manufacture that all ICT equipment that are replacing the damaged ones are new and not refurbished equipment
- Maintenance must include all ICT hardware repairs, Servers, Computers, printers, HP plotter, projectors and network switches.
- Maintenance must include Server room protection equipment: UPS. Access Control, Air Conditioner

4. MODE OF BID
