1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.2 **To be completed by the organ of state**

The applicable preference point system for this tender is the 80/20 preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

Iziko Museums of South Africa (Iziko) invites service providers to submit proposals for Paper Conservation services at Iziko South African National Gallery.

BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

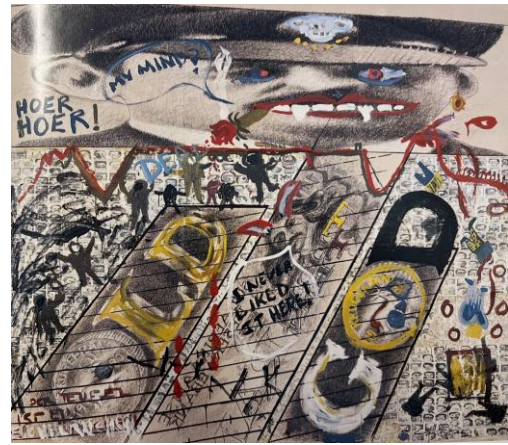
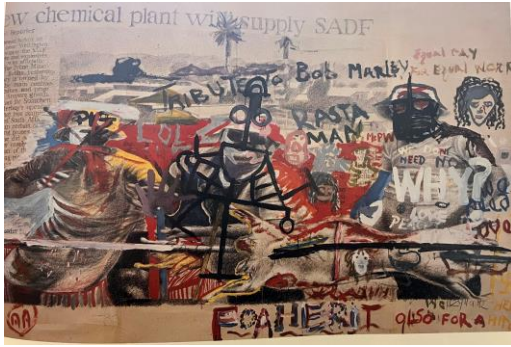
1. Scope of Services

Iziko South African National Gallery (ISANG) will be hosting “*I Never Liked it Here*”: *Revisiting Manfred Zylla’s Interaction Series* from 23 September 2024 to January 2025. This exhibition will shed new light on Manfred Zylla's influential *Inter-Action* drawing series which was a powerful artistic response to the institutionalised racism and human rights abuses of the apartheid regime in South Africa.

Inter-Action was shown at the Community Arts Centre in Cape Town in 1982. What was particularly novel about the exhibition was the fact that Zylla encouraged viewers to interact directly with the works themselves by writing and drawing on them. This resulted in graffiti reminiscent of those found on public walls with phrases like “Remember Mandela” and “Detention won’t silence us” and represented an attempt for a democratisation of fine art as a means of resistance.

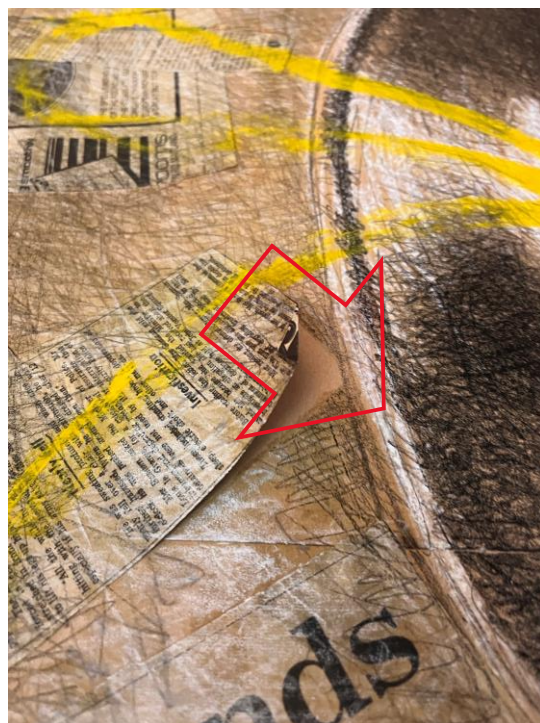
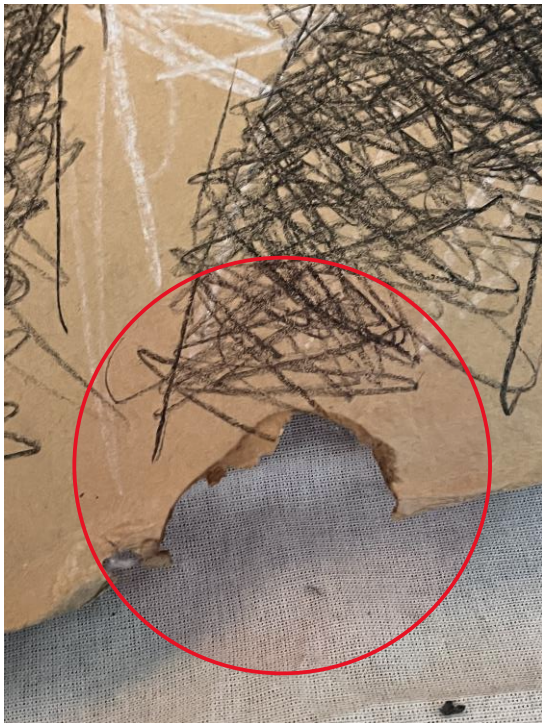
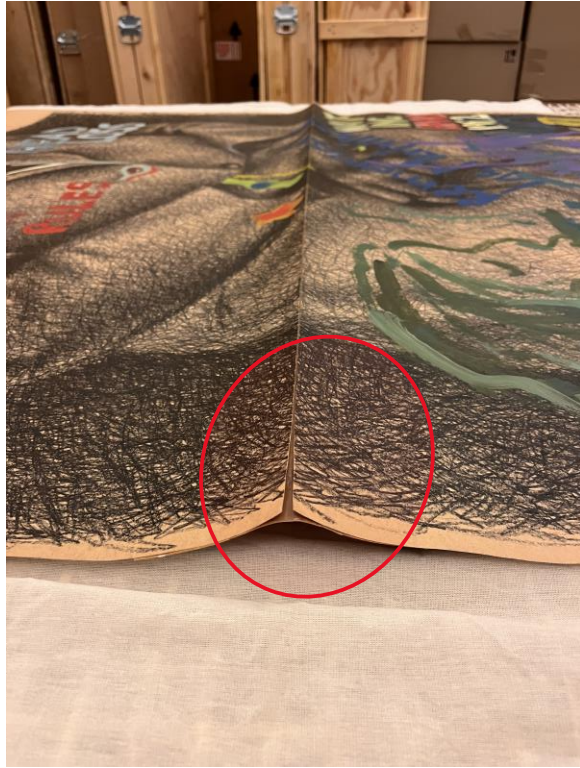
The series, which comprises of **9 large drawings** donated to Iziko South African National Gallery, have been rolled and have not seen the light of the day since the late 1980s. The drawings, with black and white crayon on brown paper, had been assembled by masking tape and are 3 x 2 m (3); 2,30 x 2m (3) and 1.5 x 2m (3).

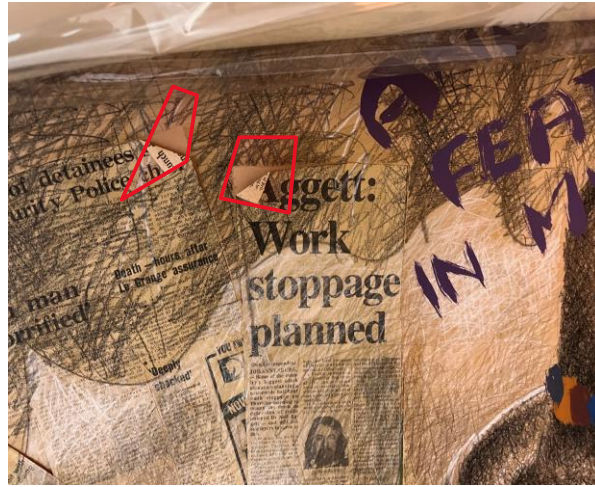
Examples of 4 drawings below:



Notes for requested quotation:

1. ISANG will require the paper conservator to work with Manfred Zylla on-site at the Iziko South African National Gallery between **26 August and 6 September 2024**. It will not be full-time, and times will be negotiated between Manfred, ISANG and the conservator. Therefore, dates may be extended, if necessary, as long as the conservation work is done by **14 September**.
2. The conservation will be done in one of the exhibition spaces open to the public. It is seen as a **live event**, whereby visitors will be able to engage with the artist and conservator. The process will also be filmed and photographed for social media and marketing platforms.
3. The project does not require extensive conservation on the 9 drawings; it is more about repairing or replacing the masking tapes with archival tape to hold the paper together, repairs to tears, glueing down newspaper clippings, the placement of inserts to fill losses, Japanese tissue lining, crease removal and flattening. The artworks need to be in reasonable shape for exhibition display. Please see some close-up examples of repair required on some of the drawings below (but note that all nine drawings need repair):

2. Compliance Documents

3. EVALUATION CRITERIA

Iziko promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

Iziko is committed to achieving Government’s transformation objectives in terms of the Preferential Procurement Policy Framework Act.

- Firstly, the bidder will have to comply with eligibility criteria as per Table 3
- Thereafter assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of **80** points. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Proposals will be evaluated on the 80/20 preference points scoring system: that is, 80% of the points awarded will be based on price, as indicated in the table below; and 20% of the points awarded will be based on specific goals, allocated as indicated in the table below:

Scores will be tabulated to 100 points. Respondents must score **80 points** and over to be assessed on their financial offer and preference score.

Bidders should briefly describe his or her experience. Please note that Iziko reserves the right to contact references as part of the due diligence procedure for RFQs.

The scoring of the tenderer's experience will be as follows:

0	Tenderer has completed less than five or less projects of similar nature
50	Tenderer has completed six to eight projects of similar nature
70	Tenderer has completed more than 8 projects of similar nature.
