1. PURPOSE:

To obtain approval for the procurement of a SOS system for the MC Bellville for an amount of R147 267.95, and to obtain approval to deviate from obtaining three quotations in terms of item 124 of the departmental delegations.

2. EXECUTIVE SUMMARY:

Rape and sexual abuse are an ongoing crisis in our communities. South Africa has one of the highest rates of reported rape in the world. Through sexual offences courts, the court system provides a safe place to victims of crime, while ensuring that the accused is brought to justice. A SOS System will support the victim of abuse by ensuring that the victim is not further traumatized by having to testify in front of the accused.

The office sent out RFQ's to 26 suppliers. Upon the closing date the office had received no quotations. The office then proceeded to extend the closing date. We also contacted all suppliers via telephone in an attempt to ask for assistance with quotations and to ensure that all suppliers did in fact receive our initial RFQ. Regardless of communication and positive offers of assistance made, we unfortunately only ended up with one quotation upon the extended closing date.

3. LEGAL / POLICY ANALYSIS

The Provincial Head is authorized in terms of item 124 of the departmental delegations to approve the deviation from obtaining three quotations.

4. FINANCIAL IMPLICATIONS:

The first RFQ went out on 16 October 2023 to 26 prospective suppliers. On 24 October 2023, the office sent a reminder to all the prospective suppliers to submit quotations, without any success. No quotes were received. On 31 October 2023, a second RFQ was sent out. On 7 November 2023, a reminder was sent out again and all the suppliers were phoned individually. Only one quote was received from **Datacentrix** on 7 November 2023 for the amount of **R147 267.95** (vat inclusive).

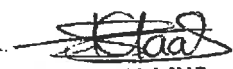

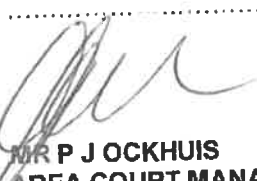

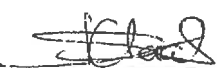
