Ingquza Hill Local Municipality (IHLM) is currently faced with fast-growing grass to all its structures, sport fields and amenities. The Department responsible for grass cutting activities is facing a challenge of a shortage of machines to do these activities. The municipality is having a huge backlog in grass cutting as it has only five machines for each town whereas the season is rainy encouraging fast growth of vegetation.

2. OBJECTIVE

It is against this background that the municipality seeks to provide a safe and attractive environment for its clients and councillors of the IHLM. This can be done through many things, such as grass cutting activities by internal staff or outsourcing of these services when there are unforeseen challenges internally.

3. SCOPE OF PRACTICE

To provide grass cutting activities for twelve (12) Soccer Fields that are utilized by Ingquza Hill Local Football Association League games namely:

- Sigcau Soccer Field (Ward 09), Spezini (Ward 07), Nkululekweni (Ward 06), Spylands (Ward 27), Khonjwayo (Ward 23), Bodweni (Ward 11), Kwa-Gorha (Ward 18), Mfinizweni (Ward 04), Ndaliso (Ward 27), Mcelu (Ward 08), Malizole (Ward 15) and Jikindaba Soccer Field (Ward 26) all with **120 meters L and 90 meters.**
