1. INTRODUCTION AND PURPOSE

The purpose of this QAR is for the appointment of a service provider for the removal, transportation and disposal of oil sludge and used air filters for Tshwane Bus Services(TBS) to ensure efficient and uninterrupted performance of bus maintenance duties.

2. BACKGROUND

TBS buses are mainly maintained internally through the Fleet and Maintenance Section. The execution of general maintenance is performed in facilities and tested on the equipment which are legislated to comply with OHSA regulations. The buildings and equipment need regular repairs, inspections, testing and calibrations in accordance with the OHS Act.

The above services are performed by various service providers with different expertise. Relevant waste management, environmental legislation and protocols needs to be adhered to. TBS has three depots namely C de wet, Pretoria north and Jan Niemand Park with underground oil separator tanks containing sludge that needs to be emptied. The tank bottoms consist of a thick waxy heavy oil sludge mixture which requires suction by the vacuum truck.

3. PROJECT SCOPE

The scope of the work includes.

3.1 Services

3.1.1 The detailed service required for the removal, transportation, and disposal of sludge in TBS is as follows:

- Removal and collection of the sludge
- Removal and collection of used oil and contaminated items.
- Transporting of the waste sludge to a waste treatment area.
- Separator cleaning
- Storm water channel cleaning
- Surface cleaning & Housekeeping of the area of work after completion and the collection of all the sludge
- Issue the Disposal Certificate
- Supply 210(ℓ) clear marked oil contaminated items steel drums with seal lids.

3.1.2 The removal of vehicle used air filters. A used air filter is classified as low-hazardous waste and is subject to special disposal requirements. The toxic substances that accumulate in this vehicle part during its service life can be harmful to the environment.

- Supply clear marked used air filter skip bins. (Length 3.6m,Width 1.4m Height 1.2m)
- Removal of used air filter
- Issue the Disposal Certificate

The appointed service provider shall provide the service expertise, advanced techniques, reliable equipment, and manpower, including preparation and execution of work required by Tshwane Bus Services.

3.2 Transportation Requirements

- All vehicles need to be certified to carry Dangerous Goods by Department of Transport approved providers.
- All drivers of these vehicles must have a valid license with PrDP.
- All drivers must provide proof of Dangerous Goods training attended by an approved Department of Transport training service provider.

3.3 Materials

- The Bidder shall supply all materials and consumables required for the performance of the services as required.
- The bidder is responsible for transportation of material on and off-site.

3.4 Occupational Health & Safety Equipment

The bidder shall ensure that all its personnel engaged in the performance of the services are provided with the minimum safety equipment in good condition to perform the task:

- Safety shoes/boots
- Overall, with long sleeves
- Hard hat
- Rain suit
- Safety gloves
- Hearing protection
- Safety glasses
- Safety harness

The service provider shall supply any additional safety equipment/apparel required for the safe execution of the Services. Note should be taken that non-compliance of wearing proper PPE will lead to suspension of the project.

3.5 Service Warranty

The Contractor warrants and represents that each of its employees, subcontractors, or agents assigned to perform any services under the terms of this agreement shall have the skills, training, and background appropriate with his or her level of performance or responsibility, and comply with National Environmental Management Act (NEMA) (Act 107 of 1998) , of National Water Act(MWA)(Act 36 of 1998) and National Environmental Management :Waste Act (NEM:WA) Act 59 of 2008) , to be able to perform in a competent and professional manner.

3.6 General Specification

- The Service provider shall provide a service, which in the interest of public health, hygiene, and environment, will ensure clean and tidy areas without any spillage of waste on site during removal and transportation.
- The Service provider shall ensure that all statutory laws pertaining to the handling, removal, transportation, and disposal of waste are complied with.
- The Municipality does not guarantee ordering services or any quantities thereof.

4. DELIVERABLES

The successful bidder must mobilize adequate and competent manpower, equipment like pneumatic pumps and vacuum trucks/gully sucker, flexible hoses and other relevant tools and tackles, chemical processes and / or new proven technologies along with personnel protective equipment in the execution of the removal and disposal of the sludge.

The standard repair tasks to be performed should be completed within 5 working days after obtaining the purchase order, except if the environmental conditions are not permissible. Note that a working day consists of 8 hours.

The successful bidder shall carry out work from 07:00 to 15:30 If the bidder needs carry of work after these hours' arrangement must be made with the relevant project manager .If normal working days are affected by the weather and work cannot be completed then the bidder may request the permission to carryout specific work on weekends and public holidays. Written permission may be granted. The CoT will not be responsible for overtime.

A Method statement and risk assessment must be submitted. The method statement shall cover the removal, transportation and disposal of the oil sludge and used air filters. The following will need to be adhered to:

- Section 24 of the National Waste Management Act 59 of 2008
- The applicant must be a registered as waste contractor / transporter.
- Issue the Disposal Certificate
- The Road Traffic Act and regulations for transportation of waste
- Any other regulatory requirement that pertains to the disposal of hazardous waste not covered above.

8. STAGE 3: PREFERENCE POINTS SYSTEM

- Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

9. VALIDITY PERIOD

The validity period for the tender after closure is 90 days. CoT shall have right and power to extent any tender validity period beyond any initial validity period set and subsequent extensions. SCM shall ensure that an extension of validity is requested in writing from all bidders before the validity expiry date. Extension of validity shall be finalised while the quotations/bids are still valid.

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
