## SCOPE OF WORK /SPECIFICATIONS OF SERVICES REQUIRED

### 1. Background

UMngeni-uThukela Water may need emergency Medical Assistance in the Water Plants that are outside town in case of emergencies. Accordingly, uMngeni-uThukela Water will arrange such services through a SERVICE PROVIDER for **36 months** with about 900 employees.

### 2. Description of services required

In this Quotation uMngeni-uThukela Water record as follows:

#### 2.1 SERVICE

2.1 Responding to all medical emergencies that have been initiated by uMngeni-uThukela Water.

2.2 The successful bidder will source other EMS service providers to assist with the emergency in the event that they are unable to assist for whatever reason.

2.3 Where the emergency is covered by WCA, service provider will retrieve the documents from the receiving hospital and claim directly from WCA.

2.4 Where the patient has medical aid in place, and is the nature of the emergency is not covered by WCA, service provider will claim directly from the medical aid.

2.5 Night Shift and Weekends, Employees to call SERVICE PROVIDER to transport an injured employee to the closest appropriate facility – Service provider must make arrangements with health facility if no member of management is able to assist with WCA paperwork during these times, the employee will still be taken to- and seen at health facility (paperwork to be submitted on the following work day).

2.6 Trauma Counselling Services to be made available to uMngeni-uThukela Water employees who qualify for counselling with prior arrangements – At “SERVICE PROVIDER client rates.” All cost to be agreed to prior to appointments.

2.7 Wellness days and all other employers’ social functions to be attended by SERVICE PROVIDER with prior arrangements made.

2.8 Annual evacuation drills to be arranged with adequate notice.

2.9 On site first aiders to be included in all drills that include SERVICE PROVIDER

2.10 Where an ambulance is called out by uMngeni-uThukela Water for a private patient, SERVICE PROVIDER will bill the company reduced rates as follows:

- Basic Life Support Level of Care
- Intermediate Life Support Level of Care
- Advanced Life Support Level of Care
- Trauma counselling rates

Phoning SERVICE PROVIDER for all Emergency Medical Service Requirements

In the case where SERVICE PROVIDER was unable to dispatch its own vehicle and a service provider was utilized, any complaints/queries should be lodged to SERVICE PROVIDER Branch Manager to ensure all service providers are kept to strict standards.

Where no medical aid is in place, SERVICE PROVIDER will claim decreased rates, as discussed above, from uMngeni-uThukela Water directly, uMngeni-uThukela Water will then claim from the employees as needed.

If a patient was transported during a night shift or public holiday and no paperwork could be obtained, it remains the responsibility of uMngeni-uThukela Water to produce the WCA documentation to the receiving Hospital on the following work day.

All drills and/or training requirements and/or company driven staff events need to be discussed with the branch operations manager, minimum of 2 weeks, in advance in order to ensure planning with all stakeholders.

If a trauma counsellor is needed for any employee, contact is to be made with the trauma counsellor or branch operations manager directly in order to request a quote. Trauma counselling can only commence on acceptance of the quote.
