1. PURPOSE

- 1.1. To appoint an accredited Certification Body to conduct the ISO 9001:2015 recertification audit, annual surveillance audits, and awareness training on the new ISO 9001:2026 standard requirements.
- 1.2. This appointment will support the continued maintenance of TIA's ISO 9001:2015 certification and the ongoing improvement of its certified Quality Management System (QMS).

2. BACKGROUND

- 2.1. Since February 2018, The Technology Innovation Agency (TIA) has maintained its ISO 9001:2015 certification, demonstrating its continued commitment to effective quality management.
- 2.2. To retain this certification, TIA must undergo independent external audits conducted by an accredited Certification Body, including re-certification and ongoing surveillance audits.
- 2.3. SGS South Africa is currently appointed as TIA's Certification Body; however, its contract expires on 31 July 2026, and all deliverables under the current contract have been concluded.
- 2.4. TIA must therefore appoint a suitably accredited service provider to ensure continuity of the certification and ongoing compliance with ISO 9001:2015 requirements.
- 2.5. The Business Analysis and Knowledge Management (BAKM) business unit is submitting a request for proposal to appoint a certification body to maintain TIA's ISO 9001:2015 certification for three (3) years.



3. SCOPE OF WORK

The scope of work to be conducted by the appointed certification body includes:

- 3.1. Review assessment and transfer of ISO 9001:2015, if applicable;
- 3.2. Conducting a Re – Certification ISO 9001:2015 Audit; and
- 3.3. Conducting annual ISO 9001:2015 Surveillance Audits.
- 3.4. Provide awareness training on the new ISO 9001:2026 standard requirements for five (5) people to align TIA's current Quality Management System with the updated requirements.

4. PROPRIETARY INFORMATION

TIA considers this Request for Proposal (RFP) and all related information, either written or verbal, which is provided to the Bidder, to be proprietary to TIA. It shall be kept confidential by the Bidder and its officers, employees, agents and representatives.

The Bidder shall not disclose, publish, or advertise this specification or related information in part or to any third party without the prior written consent of TIA. This applies regardless of whether the recipient of this RFP responds with a proposal or not.

5. FUNCTIONAL REQUIREMENTS

Provide all the necessary tools and equipment to effectively maintain TIA's ISO 9001:2015 Certification.

10. GENERAL TERMS AND CONDITIONS

10.1. The Respondent is responsible for all costs incurred in the preparation and submission of the proposal

10.2. Kindly note that TIA is entitled to:

10.2.1. Amend any RFP conditions, validity period, specifications, or extend the closing date and/or time of RFPs before the closing date. All Respondents, to whom the RFP documents have been issued, will be advised in writing of such amendments in good time;

10.2.2. Verify any information contained in a proposal;

10.2.3. Not to appoint any bidder;

10.2.4. Vary, alter, and/or amend the terms of this RFQ, at any time prior to the finalisation of its adjudication hereof;

10.2.5. An omission to disclose material information, a factual inaccuracy, and/or a misrepresentation of fact may result in the disqualification of a proposal, or cancellation of any subsequent contract;

10.2.6. TIA reserves the right not to accept the lowest proposal or any proposal in part or in whole. TIA normally awards the contract to the Bidder who proves to be fully capable of handling the contract and whose Proposal is technically acceptable and/or



financially advantageous to TIA. Appointment as a successful contractor shall be subject to the parties agreeing to mutually acceptable contractual terms and conditions. In the event of the parties failing to reach such agreement within 30 days from the appointment date, TIA shall be entitled to appoint the contractor who was rated second, and so on;

- 10.2.7. TIA also reserves the right to award this RFP as a whole or in part without furnishing reasons;
- 10.2.8. TIA also reserves the right to cancel or withdraw from this RFP as a whole or in part without furnishing reasons and without attracting any liability;
- 10.2.9. The Bidder hereby offers to render all of the services described in the attached documents (if any) to TIA on the terms and conditions and in accordance with the specifications stipulated in this RFP documents (and which shall be taken as part of, and incorporated into, this proposal at the prices inserted therein).
- 10.2.10. This proposal and its acceptance shall be subject to the terms and conditions contained in this RFP document.
- 10.2.11. The Respondent shall prepare for a possible presentation should TIA require such and the Respondent shall be notified thereof no later than 4 (four) days before the actual presentation date.
- 10.2.12. Validity period: 120 days
- 10.2.13. Failure to comply with any of the terms and conditions as set out above will invalidate the Proposal.
- 10.2.14. TIA's decision on proposals received shall be final and binding
- 10.2.15. TIA will disregard any submission if the bidder, or any of its Director:
 - 10.2.15.1. Abused the Supply Chain Management (SCM) system of any Government Department / Institution.



10.2.15.2. Committed proven fraud or any other improper conduct in relation to such system.

10.2.15.3. Failed to perform on any previous contract.

10.2.15.4. Restricted from doing business with the public sector.

10.2.15.5. If a Bidder provided fraudulent references or submitted false documents as evidence for specific goals.

11. MANDATORY REQUIREMENTS

11.1. Service Providers must be registered on the Central Supplier Database (CSD).

11.2. Service Provider must be tax compliant by the time TIA appoints.

12. EVALUATION CRITERIA

In addition to the requirements as stated, all proposals will be evaluated based on evaluation criteria below, and the 80/20 preferential point system. To assess which proposals will best suit the corporate operational requirements of TIA, proposals will be assessed as follows:

- 3.3. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However, communication between partners in a joint venture or consortium² will not be construed as collusive bidding.

In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications, prices, including methods, factors or formulas used to calculate prices, market allocation, the intention or decision to submit or not to submit the bid, bidding with the intention not to win the bid and conditions or delivery particulars of the products or services to which this bid invitation relates.
- 3.5. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 3.6. There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.
- 3.7. I am aware that, in addition and without prejudice to any other remedy provided to

combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1. The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2. **To be completed by the organ of state**

(delete whichever is not applicable for this tender).

- a) The applicable preference point system for this tender is the **90/10** preference point system.
- b) The applicable preference point system for this tender is the **80/20** preference point system.
- c) Either the **90/10 or 80/20 preference point system** will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3. Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and

(b) Specific Goals.

1.5. Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6. The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

(a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

(b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;

(c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

(d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets

through public auctions; and

(e) “the Act” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the audi alteram partem (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
