1. BACKGROUND

The project on Erf 193 Duncanville, Vereeniging is a development of 22 two-bedroom units. construction on site was put onhold in 2018 and the contractor was maintaining the site until Feb 2020. A security company was then appointed that will guard the site until GPF could dispose of the project.

The project information is as below:

- Size of site : 5 812m²
- Number of the units : 22 (two-bedroom units)
- There are 2 blocks : Block A - 8 units
Structure is complete, Interior works were still underway.
Block B - 14 Units
Structure is incomplete.

The property is partially developed, and the status is as below:

Phase One Status

Block A

The construction of Block A structure is completed. The interior works are still outstanding.





Block B

The brick work, plaster and aluminium windows works has been completed. The gable walls have been completed and ready for roofing. The contractor was in a process of installing roof sheeting and windows. They were completing the interior plaster works and the installation of both electrical and plumbing fixtures as well as the lighting on the ground floor. The project is currently on 60% to completion.



CONTRACT DURATION

This contract will be on a month to month basis for a period not exceeding three months.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
