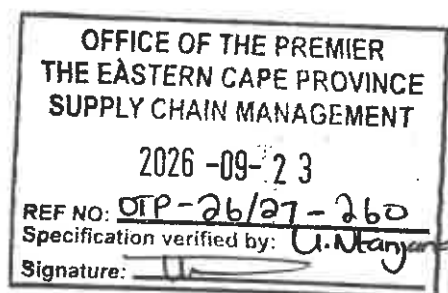

1. BACKGROUND

The Office of the Premier (OTP) seeks to appoint a reputable service provider to provide physical training and exam vouchers for the fulfillment of COBIT 2019 Design Implementation for 25 officials.

2. SCOPE OF WORK

The service provider is expected to deliver the following:

- 2.1. Conduct training / course through classroom learning or on-site contact sessions for 2 days on COBIT 2019 Design Implementation for 25 officials.
- 2.2. Provide theoretical tuition and prepare learners for all the required formative modes of learning.
- 2.3. Facilitation must be pitched in English
- 2.4. Use of blended approaches to learning such as role-plays, assimilation activities and exposure to case studies is mandatory during facilitation.

3. COURSE OUTCOMES

The course will help the candidates to understand:

- 3.1 **Design a governance system:** Master the use of COBIT design factors to tailor a governance system specific to an enterprise's unique risk profile and goals.
- 3.2 **Apply the 7-Phase Lifecycle:** Learn how to effectively manage, implement, and sustain a governance project using COBIT's structured change methodology.
- 3.3 **Assess Capability Levels:** Master the COBIT Performance Management (CPM) model to measure, benchmark, and improve process capability and maturity.

3.4 Align Business and IT: Understand how to map enterprise goals directly to alignment goals and specific governance objectives.

3.5 Optimize IT risk and Resource utilization: Learn to implement controls that mitigate digital risks while ensuring IT investments deliver tangible business value.

4. EXPECTED DELIVERABLES

The successful bidders must provide the following:

- Provide training through classroom learning or on-site contact sessions.
- Provide training and Exam vouchers for COBIT 2019 Implementation
- Issue the department with originals of all certificates of competency at least three (3) months after the completion of the course.
- The COBIT 5 Implementation must be offered in one group.
- Prospective bidders must submit, together with their bids, a completed course outline detailing how the training will be carried out taking into consideration scope of and expected deliverables.

5. FUNCTIONAL RESOURCES

5.1 Provision of Learning Material (Learner Guide)

5.2 Facilitators should have own computers, projectors, flip chart board, and flip chart papers for the training.

5.3 The training should be online.

6. MANDATORY REQUIREMENTS

- a. The service provider must be an ISACA-accredited COBIT Training Organisation (provide proof of accreditation)
- b. The service provider must be QTCO accredited. Proof of such accreditation must be attached
- c. The facilitator must be accredited COBIT trainer and submit proof of accreditation.

PHYSICAL COBIT 2019 IMPLEMENTATION TRAINING AND CERTIFICATION

- d. The service provider must submit proof of accreditation for both the organisation and proposed trainer.
- e. Facilitator must submit CV stating practical COBIT/IT governance and training experience.

PRICE QUOTATION PROCESS (UP TO R 1 MILLION)

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2022

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and

1.2 **To be completed by the organ of state**

- a) The applicable preference point system for this tender is the 80/20 preference point system.
- b) 80/20 preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 **To be completed by the organ of state:**

The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
- 1.7 Bidders who wish to claim points in terms of table 4.2 below need to provide proof for each point claimed as guided below:
- Who had no franchise in national elections before the 1983 and 1993 Constitution – **attach certified copy of identity document (ID) and company registration document / CSD report to show/ substantiate percentage ownership equity.**
 - Who is female- **attach certified copy of identity document (ID) and company registration document / CSD report to show/ substantiate percentage ownership equity.**
 - Who has a disability – **attach doctor's letter confirming the disability**
 - Who is youth - **attach certified copy of identity document (ID) and company registration document / CSD report to show/ substantiate percentage ownership equity.**

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
