Introduction to the NRF

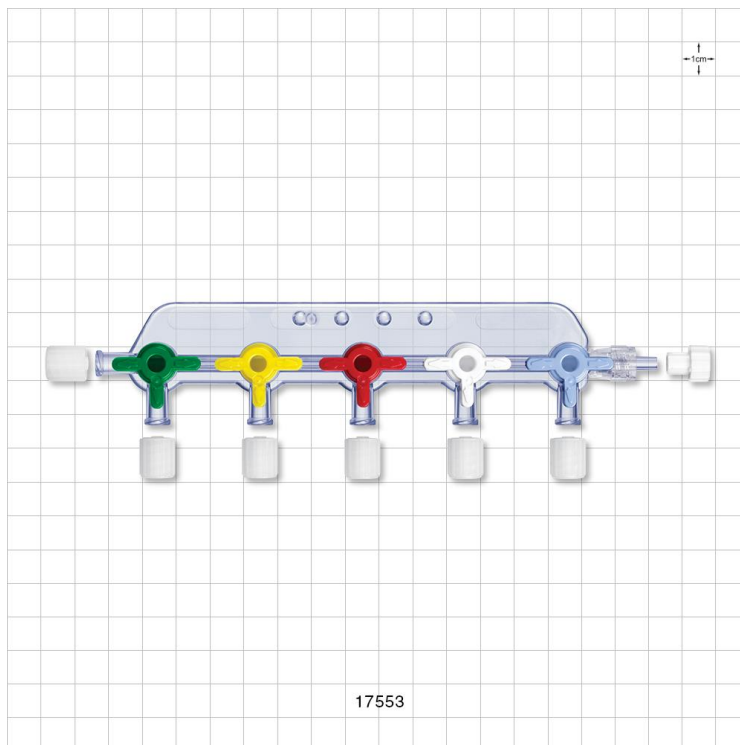
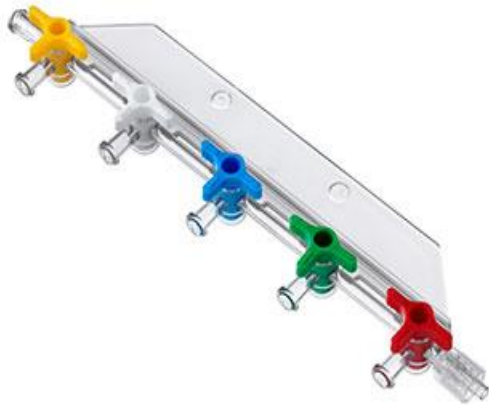

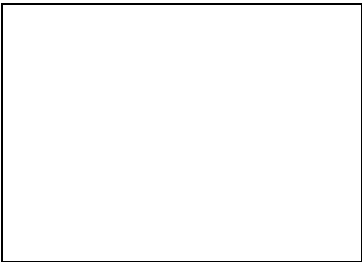
